Greetings Alderman Westmoreland,

I was made aware that there was an issue with a couple Service Requests records that were resolved incorrectly by our staff. Please rest assured that there are indeed quality control checks in place to review these records with the inspectors (especially with our newest staff members still in their training period). This is often done either through daily spot checks or a more thorough weekly review of inspection photos. If an inspection is resolved incorrectly by our staff and the error is clear, these requests would be reactivated by the Forestry Technician and reassigned for inspection. Additional training and coaching sessions always accompany these instances.

As far as using temporary seasonal Manpower staff to assist Forestry Technicians during busiest time of the year, this has been the way the vast majority of Tall Grass inspections have been resolved. It would be nearly impossible to handle the spring/early summer workload of service requests and administrative work in any sort of timely fashion without their vital assistance during the months of April through July (typically into August as well). As the complaints begin to dwindle heading into fall, these temporary staff members are reassigned by Manpower to other positions until the following Spring when they are needed again (often-times they even work in the Tow Lots or other positions with City of Milwaukee until they come back to Forestry). We currently have 5 Manpower staff temporarily assisting our Forestry Technician team.

Our team of Forestry Technicians consists of just 7 staff members that are responsible for a broad spectrum of numerous types of inspections and contractor follow-up. These include the inspecting and citing of hazardous trees throughout the city; inspections of alleys and sidewalks for vegetation encroachments of public right-of-ways; tall grass and weed inspections on private properties; inspecting and confirming contractor maintenance of 4,200+ city-owned properties; inspections and referrals of illegal dumping on city lots; along with all of the follow-up re-inspections of each violation and the contract coordination for code enforcement abatement; and more. Our Manpower staff are primarily responsible with assisting with the workload of the initial inspection for tall grass and weed complaints. A Forestry Technician only would inspect Hazard Tree requests, Encroachment requests, and City Lot contractor follow up while Manpower inspectors resolve as many of the Tall Grass requests as they can.

For additional context, since May 1st of this year, our Forestry Technicians have received 5,885 total Tall Grass and Weeds complaints, 377 Vegetation Encroachment complaints, and 64 Hazardous Tree complaints. We have also inspected all 4,200+ City Lots during 5 City Lot Mowing cycles so far. Without the assistance of our Manpower staff, response times to the each citizen complaint would be considerably much longer, and of course due to the severity and potential danger of the situation the Technicians would still have to prioritize all Hazard Tree complaints first.
