Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/17/22 at 12:32am, Milwaukee Police were dispatched to 4600 S. 27th St, for a subject with a gun complaint. Upon arrival officers observed a subject in pain in the parking lot. Officers spoke with the subject who stated that he was sprayed in the face with pepper spray. Milwaukee Fire Department arrived and treated the subject. Officers spoke with hotel personnel, who stated that the subject was attempting to enter the garage and a vehicle. The subject would not leave the area when told by security and then re attempted to enter the vehicle. The subject was pepper sprayed by on site security to stop his actions. Officers had the subject medical treated and then placed him in to custody.
- 2. On 08/19/22 at 10:25am, Milwaukee Police were dispatched to 4600 S. 27th St, for a trouble with subject complaint. The agent called the police regarding a hotel patron that was causing a disturbance, at the location. The agent stated that the subject made threats to harm staff members and attempted to gain entry to the office. The agent provided video to officers, of the subject's actions. The subject was detained and cited for disorderly conduct, and his stay was terminated at the hotel.
- 3. On 12/15/22 at 12:00pm, Milwaukee Police were dispatched to 4600 S. 27th St, for an injured/sick complaint. Officers spoke with the employee who stated the subject was supposed to check out at 11:00am, but did not. The employee found the subject laying on the floor snoring and could not wake him. Milwaukee Fire Department was on scene and stated that

they administered narcan to the subject. Officers on scene noted that there is only one point of entry and exit into the hotel rooms. The employee was cooperative with the investigation.

- 4. On 03/09/23 at 1:43am, Milwaukee Police were dispatched to 4600 S. 27th St, for a property damage complaint. Officers spoke with the business agent, who stated that past patron was kicking a door at one of the hotel rooms. The subject stated that she wanted items left in the room from her previous stay. The employee checked the room and no items were in the room. Officers advised the subject to leave the location or the subject would be arrested.
- 5. On 05/06/23 at 12:52pm, Milwaukee Police were dispatched to 4600 S. 27th St, for a trouble with subject complaint. Officers spoke with the business agent who stated that a guest refused to leave, and a knife was on the bed. The subject agreed to leave without incident and the knife was not used in a threating, dangerous manner.
- 6. On 05/08/23, Milwaukee Police were dispatched to 4600 S. 27th St, for a welfare check. Officers received information form a third party caller to check the hotel room for a subject. The hotel was cooperative with officers regarding the investigation.
- 7. On 05/14/23, at 11:28am, Milwaukee Police were dispatched to 4600 S. 27th St, for a subject with gun complaint. Officers spoke with the business agent who stated that a guest demanded a refund and implied that he had a gun. Per the business agent the guest got into an altercation with an unknown female. Officers did not locate either subject regarding the assignment. The business was advised, and no police action was taken.
- 8. On 06/27/23, Milwaukee Police were dispatched to 4600 S. 27th St, for a shots fired complaint. Officers spoke with an employee who stated that they were at the rear of the property cleaning out junk. A white vehicle pulled up and a female exited, and yelled stay away from my stuff and discharged one gun shot in the air. The vehicle then went to the front lobby of the business. The possible suspect was in the front the lobby and detained by police. The incident was not caught on video, and some cameras were not functioning properly. The agent mentioned to officers that they are upgrading the camera system. The business was cooperative with the investigation.
- 9. On 08/01/23, Milwaukee Police were dispatched to 4600 S. 27th St, for a welfare check complaint. Officers spoke with employee, who was the caller. The employee stated that a guest seemed confused and was walking in front of the lobby. The guest only spoke Spanish and an interpreter had to be use. The employee stated that Milwaukee Fire Department arrived and he believes that the subject was conveyed for medical treatment. Officers did not observe the current business licenses displayed and contacted the business agent who was cooperative.
- 10. On 08/31/23, at 1:00pm Milwaukee Police conducted a license premise check at 4600 S. 27th St. Officers spoke with the agent via telephone regarding the current license. The agent was advised by officers that there was an aldermanic complaint that hotel licenses was expired and had to be renewed. The agent stated that she was actually at the License Division filing the application as speaking with officers. The agent states that she was made aware of the license issue and would contact officers if she had additional questions. Officers made the agent aware that the business could be cited each day that the business is operating without the proper license. The agent stated that application will be filed with the License Division shortly after getting paper work regarding a shareholder issue. The agent was cooperative with officers.

11. On 10/17/23 at 2:08p.m., Milwaukee Police conducted a License Premise check at 4600 S. 27th St. Investigation revealed the business was open with guests staying on premise, however, they did not hold a Valid Hotel License.

Officers did locate two empty corner cut baggies in the room and there was no evidence of trauma to the body. The agent was cooperative with the investigation.

- 13. On 04/10/24, at 6:27 p.m., an officer was dispatched to a Dead-on-Entry call for service. An employee called for an unresponsive guest found in a room.
- 14. On 10/14/24, at 5:06 p.m., an officer was dispatched to an Overdose complaint. The Milwaukee Mobile Crisis Line called on behalf of the victim who needed mental health services.
- 15. On 03/31/25, at 12:30 a.m., an officer was dispatched to a Theft complaint. A guest stated they forgot their money on the front counter and when they returned it was gone. Security camera footage showed the guest leaving with their money in hand. That guest was removed from the property.
- 16. On 04/06/25, at 5:27 p.m., officers were dispatched to a Welfare call for service. An employee informed two guest they were in violation of motel rules by being in each other's rooms and standing in the hall. The agent pointed out a sign at the check-in area with rules posted.

On Wednesday, April 10, 2024 at, 6:27 PM, I was dispatched to 4600 S. 27th St, located in the City and County of Milwaukee regarding a Dead On Entry Complaint.

Upon arrival, I spoke to Captain Leonard BRANDT with the Milwaukee Fire Department Engine 17, Green Shift, who stated the subject, identified as Kenneth J. KRUEGER (W/M 02/03/1956) was stiff and cold to the touch. BRANDT stated rigor mortis sat in and it appeared that KRUEGER died in his sleep. Cpt. BRANDT gave a pronounce time of 6:14 PM.

I spoke to a staff member of the Suburban Motel identified as Alpa N. PATEL (I/F 01/14/1981) who contacted 911. PATEL stated at approximately 6:10 PM, she knocked on KRUEGER's unit because it was due for a cleaning. PATEL stated she did not hear anyone when she knocked so she entered. PATEL stated when she entered, she observed KRUEGER lying in bed unresponsive. PATEL stated she the last time she observed KRUEGER alive was yesterday, Tuesday, April 9, 2024, prior to 6:00 PM.

According to staff, KRUEGER has resided at the motel since February of 2024.

Veronica ANDERSON of the Medical Examiner's Office was notified and arrived at the scene to conduct her investigation.

The staff on scene was cooperative and provided video footage. The business had its license displayed in the main lobby and office which was up to date.

No narcotics were located, and the death appeared to be of natural causes.

Introduction

Call Details

On Monday, October 14, 2024, I was dispatched at 5:06 pm to 4600 South 27th St. (Suburban Motel Room 1) which is located in the City and County of Milwaukee for an overdose complaint.

Scene Description

Upon arrival, MFD 17 (Blue Shift, LT NEVINS) was already on scene and inside room number one talking to the victim, Joseph E. VENABLE (m/b, DOB 12/04/1956, phone number 231-423-6871), who said that he is homeless. VENABLE was sitting on his motel bed asking why we were all there, to which we responded that the Milwaukee Mobile Crisis' Line had called because VENABLE called them to talk about his issues and feelings of suicide. The Milwaukee Mobile Crisis Line called when VENABLE was on the phone with them and they called 911 for help.

Speaking With VENABLE

The caller was VENABLE, who seemed a little intoxicated. VENABLE did state that he had drank a few Bud

Light beers. VENABLE stated that he had also swallowed about four sleeping pills. When asked why he took the sleeping pills and that combination of alcohol, he stated that he wanted to die. We asked him if he was trying to harm or kill himself and VENABLE stated that he was trying to kill himself. VENABLE was cooperative and stated that he wanted to talk to someone regarding his mental health.

Witness(s)

There were no witnesses present.

Employee Interview

I spoke with Oscar HERNANDEZ, m/w, DOB 01/14/2000, phone 262-398-0468, who is an employee at the hotel. HERNANDEZ didn't know about the incident with VENABLE until MFD arrived since VENABLE called himself. The business was cooperative. I did not observe any security present at the hotel.

There is no video surveillance as the incident occurred inside of the hotel room so I didn't review any video surveillance.

While on scene, I observed the licenses posted and they were up to date.

Per the district community partnership unit this location is not a designated nuisance premise.

Upon our arrival I observed the front lobby being empty and the front desk worker came and greeted me. The front desk worker stated that they just started and was unsure what was going on but called the owner, Alpa PATEL (A/F 01/14/1981 owner of the motel) PATEL was reviewing the camera footage when the caller Amy CABAN (W/F 2/1/1985) came into the front lobby and stated that on March 30, 2025 at 3:40 AM she came to the front desk and asked to rent a room. CABAN stated that she put \$190 in cash on the front desk, forgot it, and left. CABAN stated that she came back around 6:00 PM and the cash was gone, and the worker was unsure what happened to it.

PATEL allowed me to review the camera footage from the front desk area that showed CABAN come in talked to the front desk for a little while placed cash down on the counter and pick up all of the cash before she exited. CABAN did not leave any cash on the counter.

PATEL stated that CABAN was no longer welcome on the property she was removed before I left.

The business had 0 security officers on scene.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Theft I did not observe any violations in the licensed premise.

On Sunday, April 6, 2025, at 5:27 pm, P.O. JOHNSON and I were dispatched to a welfare citizen call at the address of 4600 S 27th St located in the city and county of Milwaukee.

Upon our arrival I observed room 25 and 24 were the subjects who called regarding the situation. Both rooms were relatively clean and there was no argument going on.

I spoke to the callers who stated they were confronted by the manager and workers of the business. The two parties were sitting in room 25, while the resident was cleaning it. The door was open and the other subject in the room, was renting room 24. The workers approached them and told them they were not allowed to be in each other's room. When they asked why, they were told it was part of the rules of the motel. Resident of room 24 went back to his room but was standing outside the door. The workers then told him he wasn't allowed to stand outside his door either.

I spoke to licensed premise agent/owner, Alpa N PATEL (A/F 01-14-1981). PATEL stated that they had a sign posted above the check in desk with the rules. There was a sign posted toward the ceiling, stating rules such as, not be able to go to anyone else's room and no standing outside for too long. I asked PATEL regarding the rules and the legality of them, and that the rules are unethical. PATEL stated that she was told by the alderman they needed to be put in place for her to open the motel. I informed Sgt LAROQUE of the situation.

The business was cooperative with the investigation. The business had 0 security officers on scene.

While on scene, I observed the licenses posted and they were up to date.
