There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with warrants or unpaid fines:**

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Licensing Committee,

I want to share that myself and many neighbors, landowners and business owners, in the area adamantly oppose the issuing of Class A Fermented Malt Beverage License to Tittu Rehmat Store located on 418 E Center Street Milwaukee WI 53212. This business has been a hotbed of illegal activities since the new operator has taken over. We have spoken with them for the past few years in an attempt to rectify the situation. It has gone to no avail. The owners welcome the illegal activity and cater to them for profit. The following areas of concern:

1. Active Drug Dealing occurs in-front, alongside, and behind the store. Dealers meet their customers in the store and walk out to sell to them.
2. The store sells items that are not food or alcohol related but are used as drug paraphernalia items.
3. The store has/had illegal gambling machines in operation (multiple complaints have been filed).
4. The store's customers regularly use the adjacent city parcels to drink in and use drugs in.
5. The store's customers regularly block the alleyway to neighborhood traffic while they are selling, using drugs and alcohol. – the owners have a parking lot that they restrict to employee use and do not allow their customers to park there.
6. Crime has risen because of this establishment with multiple murders occurring in close proximity after they have been buying alcohol from the establishment. There has been numerous incidents of drug using/dealing complaints; fighting, shootings, and indecent exposure of genitalia to minors from the customers of this establishment – police records as back-up.
7. The amount of litter and debris caused by the establishment's customers is a public nuisance and sanitation / public health issue.

The owners' response:

1. Parking: paved parking lot but chains it so no one can use;
2. Drug dealing: puts up cameras but doesn't call it into the police or share the videos;
3. Open intoxicants: sells to customers even though they loiter outside drinking openly – puts up sign no loitering;
4. Debris/Litter – puts neighbors can out front of his store for their use – neighbor garbage can is filled with store customers refuse;
5. Calls from neighbors in regards to complaints: continues to sell drug paraphernalia, illegal gambling machines, and solicit this type of clientele.

There is a well operated liquor store on Center that is less than 1 block away that does not have any of these issues or complaints. They are a positive neighborhood fixture and responsible operators. If the community needs to purchase alcohol this is a viable option from an operator that does not leach off the community and instead takes pride in their business. I told me that they are afraid to say anything because they are threatened and have been beat-up prior. That only tells me that they can not control their business and should not be operators. The Community is pleading with the licensing committee to deny the license due to chronic nuisance property and the harm this business has caused to the neighborhood.

In closing, I am a local businessman and homeowner of this community who is directly impacted, and children have been impacted due to this negligent business. I have had to witness shootings, murders – drunk men showing their genitalia to them, and constant drug trafficking due to this business's poor practices. I also who had a similar operator. Within 30days of me acquiring that nuisance property I shut it down. That is the difference between a responsible local owner and someone who just leaches off the neighborhood with no regards for its wellbeing because they are not from the neighborhood. There is more than enough information to deny this license, please do the right thing and deny the license for the safety of our children and community!

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/12/22 at 2:21pm, Milwaukee Police conducted follow up to a shooting which occurred outside and down the street from the premise located at 418 E. Center Street. A subject was shot after a small altercation by a vehicle that arrived on scene. The day of the shooting, the store was cooperative with police and allowed access to the cameras. The business was not the caller to the shooting.
2. On 10/31/22 at 11:34am, Milwaukee Police were dispatched to 2611 N. Holton Street for a fight compliant which occurred at 418 E. Center Street. Investigation revealed that multiple individuals entered the store and began fighting over money. The employee tried to break up the fight and allowed officers to review surveillance video of the incident.
3. On 11/03/22 at 2:06pm, Milwaukee Police, the Wisconsin Department of Revenue, Milwaukee Neighbor Services, and a Milwaukee Environmental Health Inspector conducted a license premise check at 418 E. Center Street. The reason for the check was because of an earlier investigation (Item #2) which surveillance video captured people playing gambling machines inside the store prior to the fight. The DOR agents instructed an employee to remove the gambling machines and seized tobacco products that did not have invoices. The DNS Inspector conducted a fire inspection and issued the applicant building code violations (no citations found in system). The MEH Inspector discovered food products that were not cooked at the right temperature and order employees to discard the food. The MEH inspector also

discovered animal droppings in the basement and mice droppings on the ground level in the rear storage area. He issued multiple health code violations (no citations found in system).

4. On 01/13/23 at 1:54p.m., Milwaukee Police conducted a License Premise Check at 418 E. Center St. Assisting in this assignment were personnel from Department of Neighborhood Services. The following violations were observed:
  - A deep fryer plugged into an extension cord
  - Both fire exits were blocked with locks, boards or both
  - Rear storage area had a hole in the ceiling with insulation that had mold growing in it, along with the surrounding wood
  - Spray foam in the basement was stuck to fire suppression sprinklers and a non-functioning sump pump
  - Expired baby food
  
5. On 11/15/23 at 12:30p.m., Milwaukee Police conducted a License Premise Check at 418 E. Center St. Assisting in this assignment were Agents from Wisconsin Department of Revenue Alcohol and Tobacco, and personnel from Department of Neighborhood Services. The following violations were observed and addressed on scene:
  - A freezer improperly plugged in and considered a fire hazard
  - Mice droppings in the basement
  - 2 gambling machines, however, they were unplugged
  - No employees had a valid Class D Operator License
  - Expired meat items in the cooler

6. On 07/09/24 at 2:45p.m., Milwaukee Police were dispatched to a Subject with Gun at 418 E. Center St. Investigation revealed a known shoplifter entered the store with their hand in a backpack. Fearing the subject had a weapon, the staff called police. The subject was gone on police arrival. The officers observed video surveillance which depicts the incident as it was told to officers.

The following items pertain to Tittu Rehmat Food, located at 418 E. Center St.

7. On 03/04/25, at 11:55 a.m., officers were dispatched to a Trouble with Subject complaint. The caller stated a female with a minor child was walking in front of the business possibly soliciting. The employee working did not observe the subjects and allowed officers to review security camera footage. The employee stated the female was not allowed in the business. No business violations observed.
  
8. On 04/23/25, at 5:05 p.m., officers were dispatched to a Subject with Weapon complaint. The caller stated there were 4-5 subject throwing items around because they were locked in the business after being caught stealing merchandise. Upon officers' arrival the caller did not want any additional police service due to the subjects apologizing and paying for the items. No business violations observed.

9. On 07/06/25, the applicant was cited for Sale of Cigarette to Minor at 2401 N. 21st St. Arraignment is scheduled for 12/22/25 at 8:30a.m.
10. On 07/17/25, at 12:03 p.m., officers were dispatched to a Theft complaint. A customer accused an employee of taking her payout ticket from a gambling machine and not giving her money owed. The customer became upset and threw items around the business. Officers reviewed security camera footage, which showed the customer at a gambling machine inside of the business. An employee agreed to give the customer \$10.00 and informed them they are not allowed back into the business.
11. On 10/04/25, at 10:58 a.m., An officer conducted a Wisconsin WINS Tobacco Compliance check. The employee working did not confirm the participants age who was a minor and sold a Black and Mild to them. The employee was advised and a citation (0683BRFP45) was issued to the agent. (Citation not in Muni when check was conducted).
12. On 11/09/25, at 8:42 p.m., officers were dispatched to a Reckless Endangering Safety. The caller witnesses an unknown subject armed with a handgun chase a victim into the business. Upon officer's arrival all of the subjects were not on scene. The employees were not fully cooperative with officers during their investigation.
13. On 12/08/25, at 11:42 a.m., an officer conducted Follow-Up regarding the previously reported gambling machines. Two machines were found stored on the rear west wall behind a shelf and unplugged. An owner stated the machine are not being operated and they attempted to have them removed, but are not able reach anyone from the company. The owner was advised to continue attempting to have them removed from the business.

This report is written by P.O Marlon ELLIS, assigned to District 5, Early Power Shift, Squad 5242.

On Wednesday, March 4, 2025, at 11:55 am, I was dispatched with my partner P.O PETTY, to 418 E Center St, Milwaukee, for a Trouble with Subject complaint.

The Dispatched CAD read there was a female wearing a brown jacket, black hoodie, blue jeans pants and tennis shoes who was walking on the 400 Block of E Center St soliciting people for money to buy drugs. This complaint implied the female was walking with an Asian subject that appeared to be a minor and was possibly being trafficked.

Upon my arrival, we spoke to an employee, identified as Ranjit Singh, W/M,12/02/1957. We asked SINGH if he observed a female wearing a brown jacket, black hoodie, blue jeans pants and tennis shoes entering his store or loitering in front of his store with an Asian child.

SINGH stated that he did not observe anyone fitting that description, but we could view his CCTV cameras. P.O PETTY and I, view the CCTV camera that shows outside of the store, and we observed a W/F, wearing a brown jacket, black hoodie, blue jeans pants and tennis shoes. The W/F approached the store from the southside, she then went up to a B/M who was standing in front of the store and handed him something in his hands, however I am unsure of what the transaction was.

The video feed we observed showed the person matching the description of the female in the CAD entering and leaving the area alone. It never displayed an Asian minor.

The B/M then entered the store and came back outside where the W/F was and handed her something

in her hands. The W/F then left heading southbound.

P.O PETTY then showed SINGH the video and he was asked if the B/M had come inside the store to and made any purchases and SINGH replied yes. SINGH stated that the B/M is a regular customer and that he comes inside his store often. P.O PETTY then asked SINGH if recognize the W/F and SINGH replied yes. SINGH stated the female walks up and down the street all day and she is not allowed inside the store. Having this information, it appeared the female could have possibly handed the B/M money, and he could have entered the store to purchase items for her.

There were no other witnesses located during this investigation.

The Occupancy license was posted and is currently up to date. The store staff and manager were polite and cooperative.

Squad 5261 saturated the area but was unable to locate the subjects.

We did not speak to the caller regarding this investigation.

There was no further Police action taken.

### LICENSED PREMISE REPORT

This report is written by P.O. Michael MCKINNEY, assigned to District Five, Early Power shift, Squad 5242.

On Thursday, July 17th, 2025, at 12:03pm, my partner, P.O. Terrence PETTY, and I, while in full duty uniform, equipped with activated AXON body-worn cameras, and driving a marked police vehicle (Squad Car 65525), were dispatched to 418 E Center St for a Theft complaint, in the City and County of Milwaukee.

Upon our arrival, I noticed the B/F Caller standing outside the business next to a black sedan, waiting for us with an angry expression. Meanwhile, customers were entering and exiting the store. I spoke with the B/F Caller, identified as Linda L. HASKINS, the caller,11/28/67, who stated that the business owner had taken her payout receipt with her money on it while she was playing a slot machine inside the business. Haskins claimed that the owner was refusing to return her funds.

I then spoke with the business owner's son, identified as Sukhdeu N.M.I. SINGH (W/M, 09/16/91). SINGH explained that upon his return to work that afternoon, his father was accused of stealing money from a customer, which led to the customer throwing items in the store. SINGH stated that he reviewed the surveillance footage, which showed HASKINS intentionally throwing items without permission. He insisted that he did not know HASKINS and did not want her back on the property. SINGH was cooperative in providing access to the surveillance recording and helped with our investigation.

I reviewed the footage from the camera mounted on the northeast corner of the building's awning, which confirmed that Haskins was throwing items but did not show anyone taking her money. The video

showed her playing a slot machine at the time, and SINGH noted that the last payout for that game was only \$10.00 while Haskins was playing. SINGH stated he had no record of her receiving a payout receipt but was willing to pay her.

Upon my return to issue a contact card to SINGH, I verified that his business license was current and posted. Consequently, we issued HASKINS her \$10.00 and informed HASKINS that SINGH did not want her back at the location.
