The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/19/2021 at 11:18pm officers were dispatched to Culver's, 5501 W. Fond du lac Av. for Subject with Weapon complaint. The business was closed and the officers spoke with a security guard, who stated there was a large group of teenagers engaged in a mutual fight.
2. On 07/17/2021 at 2:08pm officers were dispatched to a Trouble with Subject at Culver's, 5501 W. Fond du lac Av. The officers spoke with the manager, who stated a subject came in the store to get away from a group that was chasing her. The manager was cooperative but stated she did not have access to the cameras, only the general manager had access.
3. On 10/19/2021 at 7:04pm officers were dispatched to a Shots Fired at Culver's, 5501 W. Fond du lac Av. The officers spoke with the security guard, who stated two groups of teenagers got into an argument inside the restaurant. Both parties made phone calls and more people arrived in the parking lot. The security guard then heard shots in the parking lot. The manager was cooperative and provided officers with video of the incident.
4. On 12/18/2021 officers were dispatched to an Armed Robbery at Culver's, 5501 W. Fond du lac Av. The officers spoke with the security guard, who stated he had his gun and money stolen from him while on duty. The manager was cooperative with officers and assisted them in reviewing video of the incident.

5. On 01/02/2022 at 1:16pm officers were dispatched to a Sexual assault complaint. The officers interviewed a female who stated she was an employee at Culver's restaurant at 5501 W. Fond du lac Av. While she was working she stated she was in the cooler looking for items when a manager touched her on her buttocks. The officers spoke with the manager by phone and he denied the incident. The officers attempted to contact the applicant by phone but left a voicemail.

On Tuesday October 19th, 2021, at approximately 7:04pm, Squad 7431 myself along with P.O. Margaret BOYD, did respond to the address of 5501 W. Fond du lac Ave for a Shots Fired complaint. This address is located in the City and County of Milwaukee, WI.

This address is the "**Culvers**" fast food restaurant which is a licensed City of Milwaukee establishment.

## Security Officer

Upon arrival P.O. BOYD spoke with security officer Frank E. SMITH (B/M, 01/31/76). SMITH stated that he was an armed security officer who works for Police Milwaukee Public Safety. SMITH was present during the incident and stated the following:

SMITH stated that there were two male teenagers in the lobby of the establishment who got into an altercation with two other male teenagers. SMITH stated that both parties called more people to the location and shortly after he observed multiple vehicles driving into the parking lot.

SMITH stated that after observing the vehicles drive into the parking lot he heard "a lot" of shots fired in the parking lot of the establishment.

SMITH was cooperative with officers and detective's during the entire investigation.

## Employee (Food Runner)

During the investigation I spoke with a juvenile employee who identified herself verbally as Z.A.E. (B/F, 08/02/05). Z.A.E stated that while transporting food to customers from the kitchen to the parking lot, she made contact with one of the subjects involved in the altercation.

The subject asked to use her phone to make a phone call in which she allowed him to do so.

Z.A.E was cooperative with officers and detectives.

## Manager

During the investigation contact was made with the Store Manager who arrived on-scene after the incident. He was identified verbally as Jazreel D. JONES (B/M, 05/28/87).

JONES was able to utilize the cameras and help us view video surveillance of the incident.

JONES was cooperative with officers and detectives.

## Additional

SMITH, JONES, and Z.E.A were issued a contact card.

During the investigation we located six casings in the parking lot of the location.

While on scene we were informed that there was a walk in shooting victim at St Joseph's Hospital which was related to our assignment. The detective bureau would later arrive at our scene and take over the investigation.

#### Interview of Miranda L. ZANKLE (Victim)

Upon arrival we made contact with **Miranda L. ZANKLE (B/F 10-19-2003)**. ZANKLE stated she had worked at the Culver's restaurant located at 5501 W Fond Du Lac Av, which is located within the City and County of Milwaukee, WI, from the time school started, approximately August 2021, until the end of October 2021. ZANKLE stated during this time she was supervised by **Jezeel D. JONES (B/M 05-28-1987)**. ZANKLE showed us a picture of JONES through the Sex Offender Registry.

ZANKLE stated the incident in question occurred in October between when she turned 18 and 1 week before she quit her job at Culvers at the end of October, which would make the timeframe 10-19-2021 to approximately 10-24-2021. ZANKLE stated while she was employed at Culvers she was working approximately 4-5 shifts a week usually between 4:00 PM to 11:00 PM.

ZANKLE stated at mid-day on the day of this incident at the start of her shift she was restocking ingredients for the rest of her day. ZANKLE stated she was looking for some "cheesecake sauce," in the storage room, which is in the back of the restaurant, but could not find it. ZANKLE stated she asked JONES to assist her in finding some in the storage room but he could not find it either. ZANKLE stated while she was in the storage room with JONES they started talking about Nike Tech jumpsuits. ZANKLE stated she was still looking for the cheesecake sauce while JONES was standing behind her and slightly to her left when JONES told her he would buy her a Nike Tech jumpsuit and at the same time touched her left buttocks with an open palm for approximately 4 seconds. ZANKLE stated she did not give JONES

consent to touch her in this way and his doing so made her feel really uncomfortable. ZANKLE stated she tried to change the subject but felt really embarrassed. ZANKLE stated after this incident when JONES would speak to her she noticed that he would bite his lips, which made ZANKLE feel uncomfortable. ZANKLE stated later the same day when JONES touched her butt he approached her and told her he was sorry and he would give her a raise and promote her to manager, which she had been working to achieve. ZANKLE stated she did not feel comfortable working at Culvers because of JONES' actions and she quit her job at Culvers approximately 1 week later. ZANKLE stated JONES' behavior was the sole reason she quit her job.

ZANKLE stated during the entirety of her employment at Culvers JONES made her feel uncomfortable. ZANKLE stated she noticed JONES would often meet with the young girl employees and managers in a room in the back of the restaurant. ZANKLE stated she was invited to a few of these meetings. ZANKLE stated during these meetings JONES would buy the girls food. ZANKLE stated she never saw any male employees in these meetings. ZANKLE stated JONES and the owner of Culvers set up a WhatsApp, which enabled them to communicate with employees at the Culvers. ZANKLE stated multiple times JONES would SMS text her by her own personal number after work and inform her that she had done a really good job that day and encourage her to keep at it in order for her to be a manager one day. ZANKLE stated she spoke to other male employees at the restaurant, who told her they never got messages like that.

ZANKLE stated on one occasion a female manager, whom she knows only as "G" implied that she was able to stay for a longer shift at Culvers because her "boyfriend," and ZANKLE stated this was referring to JONES, had allowed it. ZANKLE stated this also made her feel uncomfortable as she never considered herself to be in a romantic relationship with JONES.

ZANKLE stated she has heard of JONES having similar inappropriate actions with other female employees but does not know any identifying details. ZANKLE stated she was not going to make a report but a friend showed her that JONES was on the Sex Offenders Registry and ZANKLE was concerned because JONES was working at a place with a lot of contact with young girls and did not want what happened to her, or something worse, to happen to someone else.

ZANKLE stated this incident has negatively affected her because she had to quit her job and has not been able to find a new one.

We provided ZANKLE with a Victim's Resources Form PV-17 and informed her how she could reach us if she had more questions.

## Further Investigation

An NCIC shows JONES is on the Sex Offender Registry but is not longer active.

We attempted to make contact with JONES at his listed residence of, 5374 N 68th St, but were unsuccessful. We did make contact with JONES' mother, verbally identified as **Aminat VAKARE**, who stated JONES only stays at the listed location some of the time. I did observe JONES' listed address was within one block of Kilbourn Public School, 5354 N 68th St.

## Phone Interview of Jezreel D. JONES (Suspect)

JONES stated he had never had any form of sexual misconduct at Culvers nor any complaints.

JONES stated he had never had a relationship with an employee at Culvers and never had any sexual contact with someone at Culvers.

JONES stated he was not at liberty to give any information regarding the WhatsApp account that Culvers uses to keep contact with employees.

During my very short interview with JONES over the phone he became frustrated with my line of questions.

I attempted to make contact with the Culver's owner, Myron SMITH at 414-807-6398 but was unsuccessful. A voicemail was left.
