This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 06/03/23 at 2:19a.m., Milwaukee Police were flagged down by security at 725-729 N Milwaukee for a Trouble with Subject. Investigation revealed a patron was asked to stop slapping butts in the establishment, however, when they continued security proceeded to escort the patron out. The patron accused security of battery, however, the business was cooperative and video surveillance demonstrated security handled the incident according to protocol.
- 2. On 08/20/23 at 1:34a.m., Milwaukee Police were flagged down for a Trouble with Subject at 725-729 N Milwaukee. Investigation revealed a subject was causing a disturbance and asked to leave, however, refused. Security proceeded to escort the subject outside, at which time security and the subject fell to the ground. The subject began kicking security staff and when police attempted to take the subject into custody, the subject punched and bit officers, causing injury. Security was praised for handling the situation well, however, were advised in the future to keep crowds back while police are attempting to effect an arrest.
- 3. On 12/23/23 at 2:15a.m., Milwaukee Police were parked in front of 725-729 N Milwaukee, when they were approached by security, an altercation took place inside and they were beginning to escort people out. Officers were advised a fight broke out inside regarding several groups of people fighting. As security was escorting the separate groups out, the fights continued outside, prompting police intervention. Due to the large number (25-30) of people involved in the fight, officers had to request additional squads. One patron was cited and released at the scene. The

officers requested video surveillance	of the incident,	however, as	of 12/28/23,	had not received
any video.				

- 4. On 02/10/24 at 10:43p.m., Milwaukee Police were stationed at 720 N. Milwaukee, working Code Red, when they heard shots fired. Investigation revealed the victim parked their vehicle in the alley behind 727 N. Milwaukee and entered the business through a rear door. When the victim returned to their vehicle, the suspect approached the victim's vehicle and fired 4 shots at the victim, striking them in the arm. The business was fully cooperative allowing officers to view video surveillance of the incident.
- 5. On 04/19/24, Milwaukee Police conducted a License Premise Check at 725 N. Milwaukee. Assisting in this assignment was an Agent from Wisconsin Department of Revenue Alcohol and Tobacco. Investigation revealed there was no licensed bartender on scene as well as 5 contaminated bottles of alcohol were disposed of. The agent was cited for the violation.



The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 10/22/2024 at 9:10 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.


