



N. Maryland Ave. at E. Linnwood
Ave. (ST211230149) Install traffic
calming traffic circle. (Assess-
able Reconstruction Paving Fund
- \$5,035; Nonassessable Recon-
struction Paving Fund - \$1,500).
The total estimated cost for this
project including the requested
amount is \$15,500. This project is
anticipated to be completed during
the 2024 construction season.

6th Aldermanic District

E. North Ave. - N. Bremen St.
to N. Booth St. (ST211230141)
File Number 230423: Install con-
crete traffic calming speed table.
(Assessable Reconstruction Pav-
ing Fund - \$7,600; Nonassess-
able Reconstruction Paving Fund
-- \$1,000). The total estimated
