File No. 050356 is a resolution authorizing the transfer and expenditure of \$550,000 from the Development Fund for environmental testing, remediation and demolition on brownfield properties in various aldermanic districts. (DCD)

Background

1. The Development Fund uses General Obligation borrowing authority. Traditionally, these funds support economic development “projects too small to warrant or is not appropriate to create a TID” (p. 63, 2004 Plan and Budget Summary).
2. The 2005 Budget provides \$2 million in capital funding for the Development Fund.

Discussion

1. DCD will use Development Fund capital monies to match federal and state brownfield grants awarded to the City and RACM (see table on pg. 2).
2. File 050355 authorizes and directs the appropriate City officials to transfer \$550,000 from the Development Fund Account (a general account) to the Brownfield initiative account (UR03393100) to be used as required matches against federal and state brownfield grant awards.
3. The brownfield appropriations from the 2005 Development Fund are designated for environmental testing, remediation, demolition and other costs (including tax foreclosure) on citywide, downtown and neighborhood brownfield properties, and making use of existing Phase I and Phase II City contracts (list available from the DCD).
4. This initiative was listed as a \$550,000, unfunded “wish list” project in previous DCD spreadsheet reports dated 5/31/2005. Adopting File 050356 authorizes funding for the project, increasing the aggregate Brownfield initiative funding, using Development Fund capital, from \$1,300,000 to \$1,850,000.

Fiscal Impact

1. This resolution allows for transferring \$550,000 of the 2005 \$2 million GO borrowing funds in the Development Fund toward a specific, authorized Brownfield initiative project account UR03393100.
2. Per the following DCD spreadsheet dated 7/12/2005, the Development Fund has \$1,372,947 in available funds and an unfunded priority project “wish list” totaling \$1,802,947, which exceeds available funds by \$430,000.
