Hello Alderman Perez,

Wanted to touch base with you re: Quality Discount LLC's liquor license. You asked me about it some time ago, and I hadn't formed an opinion at that time. After consideration, I'm opposed to it. Also, a number of my neighbors are opposed to it. I canvassed 7th st with another neighbor today, and we gathered 18 signatures in opposition. I may try to gather some more names this weekend from KE tenants.

The petition was initiated by Sam's Liquor -- and I believe a former Alderman (Witkowiak?) is somehow involved. I'm not sure what is going on there. From what I understand, Sam's Liquor is offering to pay for transportation to City Hall for residents who want to testify in opposition to Quality Discount's liquor license application.

The bottom line, though, is this: a number of my neighbors agree that we just don't need another liquor store in the neighborhood. We already have Sam's, there's another liquor store on 6th and Maple, and from what I understand, nearly every restaurant on Mitchell sells beer or liquor of some kind. We also have a number of bars in the area.

We don't need any more weird traffic along the street, or in the lobby of KE caused by intoxicated individuals. I've called 911 and MPD's non-emergency # too many times to count re: intoxicated individuals occupying our lobby at KE or passed out drunk in the parking lots. More liquor sold on the corner means more traffic in the alley -- this I'd like to curb as well.

So, I'm opposed.

In all fairness, however, 5 of the neighbors I spoke to along 7th Street were in favor because they want the competition -- i.e. for Sam's to lower their prices. I disagree with the premise. Quality Discount's prices on non-alcoholic items are already way too expensive -- competition from other grocers etc. hasn't lowered their prices at all. On that matter, I don't see the need for yet another overpriced "general store" either. My husband and I would would vote for a nice pizza parlor or coffee shop rather than another liquor/general store on that corner.

A number of my neighbors (including myself) won't be able to make the hearing on September 27, but we are still very much opposed. One of my neighbors indicated to me that you were in favor of Quality Discount LLC's liquor license. I hope you are not. I hope you will vote against it if given the opportunity.

This report is written by Police Officer Gilbert Gwinn, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/29/2014 an officer received a complaint that Quality Discount, 738 W. Historic Mitchell St was operating without a Class A Malt or food license due to a check not cashing. The applicant was contacted regarding and stated he would look into the matter first thing in the morning. On Tuesday 09/02/2014 the officer conducted follow up and found the applicant's Class A malt and Tobacco was up to date but he needed to renew his food license.
- 2. On 10/04/2014 an officer working with Wisconsin WINS went to Quality Discount, 738 W. Historic Mitchell St to check for compliance with tobacco age restrictions. A subject who is under the age of 18 went into the store and purchased a Black and Mild wine cigar. The clerk Abdelmuti ALI admitted selling the cigar. The applicant was cited for Sale of Cigarettes to Minor/Underage and for not having an employee with a valid operator's license.

Charge 1: Sale of Cigarettes to Minor/Underage

- 3. On 04/30/15 at 4:00 pm, Milwaukee police conducted a license premise check at 738 W Mitchell Street after receiving a complaint that the business was in violation of the submitted "Plan of Operation" report by selling individual fermented malt beverages as well as fermented malt beverages in 40 oz bottles. Upon entry, police spoke with Omar Ali and officers observed that the licenses for the premise were not on display. All was able to provide police the licenses which Ali obtained from a drawer near the cash register. Ali was cautioned that the licenses were required to be prominently posted at all times. Police advised Ali why they were there and officers observed 11 coolers filled with fermented malt beverages for sale, three of which were devoted to four packs of 16 oz beers. Officers observed two "broken" four packs, one of which the missing beer had fallen out and was at the bottom of the cooler, and the other, a four pack of 16 oz Old English 800 with three missing cans. Ali stated this was due to shoplifting. Officers did observe an entire cooler devoted to individual beer sales, the vast majority of which were 20 oz and 30 oz cans consisting of 40 different varieties of cans and bottles of fermented malt beverages. Ali stated he did not believe he was in violation of his plan of operation regarding sales of individual cans of fermented malt beverages because he was not breaking apart packages of beer and selling them individually. All stated that he had to sell the majority of the beers that were in 20 oz and 32 oz bottles or cans because that is the only way they are available but that the sale of these items doesn't conflict with his 2012 plan of operation. Ali stated that he had started carrying the 40 oz bottles last week due to a customer request. Police checked with a clerk from the License Division at City Hall and were informed by Jessica Celella that the agent agreed not to sell 40 oz bottles as part of the initial application and that the restriction still exists on the plan of operation. Ali was advised to stop selling the 40 oz bottles to which Ali stated he would.
- 4. On 05/28/15 at 1:52 pm, Milwaukee police were dispatched to 738 W Historic Mitchell Street for a shooting complaint. Investigation revealed that an argument over the purchase of beer took place between the store owner, Omar Ali and a customer. Ali stated that the customer reached over the counter and at this point, Ali feared for his safety and fired one round from his handgun, which was behind the counter. The victim was struck one time to the left side of his face and was taken to a nearby hospital by friends for medical treatment. Ali was arrested for Recklessly Endangering Safety and later released. As of June 3, 2015, no charges have been located in CCAP. During the investigation, Ali stated that the surveillance system that was installed in the store was not working.
- 5. On 05/29/15 at 6:00 pm, police conducted followed up in regards to the 04/30/15 license premise check with licenses not being properly displayed. A check revealed the licenses were still not posted and the Omar Ali obtained the licenses again from a drawer behind the counter. Ali was advised he would be cited for the violation.



VELAZQUEZ added that he went inside and saw a female with a swollen eye. VELAZQUEZ added that he went to grab the ice to help the victim, and when he returned she was already gone.

VELAZQUEZ was cooperative during the investigation and stated that he will review the video fototage in order to help with the investigation.

On Sunday, 2-21-16, at approximately 2:38am Squad 2464 (PO Richard TOLENTINO and I) Squad 2480 (PO Joshua KOOPMEINERS and PO Adam LUEBBE), Squad 2412 (Sgt. PANNING) and Squad 2310 (Sgt. THORNE) responded to 626 S 5th St (Kana Mojito Club) for a Fight Complaint (CAD# 160522512)

Upon arriving on scene, we did not observe any active fights outside the establishment. I spoke with the security personnel, Rigoberto DELATORE (W/M 8-10-76), regarding the incident. I informed DELATORE we had received a call regarding a fight that occurred at the establishment. DELATORE stated there were no fights that had occurred at the establishment.

After speaking with DELATORE, I along with the other squads on scene entered the establishment. Upon entering the establishment, I observed employees cleaning up for the night. There were no signs that a fight had occurred inside.

I then spoke with the licensee's son, Angel M VELAZQUEZ Jr (W/M 9-23-96), who was working at the establishment regarding the incident. I informed VELAZQUEZ we had received a call for a fight occurring at the establishment and I needed to view his video cameras to determine if in fact a fight had occurred.

VELAZQUEZ Jr then proceeded to take me to where the video camera operating system was located in an attempt to view video footage. VELAZQUEZ Jr attempted to retrieve video but was not able to. VELAZQUEZ Jr then called his father/licensee Angel M VELAZQUEZ (W/M 5-29-69) in attempt to get instructions on how to retrieve the video footage.

This report is written by PO Eliel CONTRERAS assigned to District 2, Late Power Shift.

On Saturday, 2-27-16, Squad 2464 (PO Richard TOLENTINO and I) were instructed by Shift Commander, Sgt SAWYER, to handle a walk in Battery Complaint (CAD# 160583554) at District 2 that occurred at Kana Mojito Club (626 S 5th St.).

At approximately 11:28pm we responded to District 2 to speak with the complainant, Dennis A WOJCIECHOWSKI (W/M 2-26-93) regarding the incident.

Upon arriving on scene, we spoke with WOJCIECHOWSKI regarding the incident. WOJCIECHOWSKI stated he went to Kana Mojito Club (626 S 5th St) to meet up with some friends on 2-27-16 for his birthday. WOJCIECHOWSKI stated he arrived at approximately a little after midnight. While at Kana, WOJCIECHOWSKI stated he had one shot of Jameson Whiskey and two mixed drinks of soda and vodka. WOJCIECHOWSKI stated while separated from his friends, he was standing on the east end of the bar. While standing by himself, WOJCIECHOWSKI stated he was approached by security and was asked to leave. WOJCIECHOWSKI stated he asked security why he had to leave and they did not give him an answer.

WOJCIECHOWSKI then stated four security guards forcefully grabbed him and carried him out of the club. While being carried out, WOJCIECHOWSKI stated one of the security guards sprayed OC (Oleoresin Capsicum) on his face. WOJCIECHOWSKI stated he received injuries due to how the security guards handled him. I asked WOJCIECHOWSKI if he could describe the security guards and he stated he could only remember that one of them was a black male and the other a white male with a beard.

WOJCIECHOWSKI had scratches on his right bicep, bruising on the left side of his body near his rib cage, and scratches near his wrists on both hands.

I asked WOJCIECHOWSKI why he did not call the police or get medical attention for his injuries and he stated he did not know what to do because this had never happened to him before. WOJCIECHOWSKI also stated he did not noticed his injuries until the next day. I asked WOJCIECHOWSKI if he called his friends after the incident occurred and he stated no because he doesn't like asking for help from others.

I asked WOJCIECHOWSKI what he did after the security guards assaulted him and he stated he stayed in his vehicle, which was parked across the street from Kana because he did not know what to do. WOJCIECHOWSKI also stated he slept in his car all night because his car wouldn't start.

I informed WOJCIECHOWSKI if he had been sprayed in the face with OC he would have needed medical attention. WOJCIECHOWSKI stated his face was burning but it wasn't bad until the next day.

I asked WOJCIECHOWSKI why he waited till now to report this and he stated he was not going to do nothing but his mother, Gail MOORE-LIGHTFOOT, who is a clerk for CIB, told him he needed to report it.

During the interview I asked WOJCIECHOWSKI numerous times if he did anything at the bar that would cause security to ask him to leave and he stated no. WOJCIECHOWSKI stated he was by himself minding his own business.

I informed WOJCIECHOWSKI we would respond to Kana and talk to security regarding the incident. I also informed WOJCIECHOWSKI we would look at video footage to confirm his story. After speaking with WOJCIECHOWSKI, I along with PO TOLENTINO responded to Kana Mojito Club to speak with security regarding the incident.

At approximately 12:41am we responded to Kana Night Club. Upon arriving on scene, I spoke with security, Rigoberto DELATORRE (W/M 8-10-76), regarding the incident. I explained to DELATORRE why we where their and he stated he remembered the incident and WOJCIECHOWSKI from the night of the incident because he was working.

DELATORRE stated WOJCIECHOWSKI was asked to leave the establishment because he was observed by a bartender pushing a female in the face with his hand. Upon observing this, the bartender called for security and security approached WOJCIECHOWSKI. DELATORRE then stated when WOJCIECHOWSKI was asked to leave but WOJCIECHOWSKI refused to leave and made his body go limp causing him to fall to the ground. DELATORRE then stated WOJCIECHOWSKI refused to get up from the ground. After refusing to get up from the ground, DELATORRE stated it took five security guards, including himself, to escort WOJCIECHOWSKI because he was kicking his legs and waving his arms uncontrollably. While escorting WOJCIECHOWSKI out, DELATORRE stated he kicked one of the employees in the head by accident. DELATORRE also stated WOJCIECHOWSKI was screaming racial slurs to one of the security guards, who was a black male. WOJCIECHOWSKI stated he could call him a racial slur because he was half black and his mother was a cop at District 1.

DELATORRE stated they were able to escort WOJCIECHOWSKI out of the establishment. DELATORRE then stated WOJCIECHOWSKI attempted to get back into the club and stated he needed to get his coat. DELATORRE stated he informed WOJCIECHOWSKI he could not reenter but if he gave him his ticket stub for his coat he would retrieve it for him.

DELATORRE then stated WOJCIECHOWSKI tried to get passed him and attempted to get in. DELATORRE along with other security guards grabbed him again and escorted him out. While escorting WOJCIECHOWSKI out again, DELATORRE stated WOJCIECHOWSKI was grabbing onto his leg and on to the door to prevent security from taking him out. DELATORRE then stated to get the situation under control, he pulled out his container of OC (Oleoresin Capsicum) and sprayed WOJCIECHOWSKI.

DELATORRE then stated he along with the other security guards carried WOJCIECHOWSKI of the establishment's grounds. DELATORRE then stated he observed WOJCIECHOWSKI walking up and down the sidewalk in front of the establishment. DELATORRE then stated after the bar had closed, WOJCIECHOWSKI entered the establishment after one of the employees left. DELATORRE stated he was able to grab him and told him the bar was closed and could not be inside. DELATORRE stated WOJCIECHOWSKI informed him he was not leaving until he got his coat and watch that he lost while being escorted out. DELATORRE stated he retrieved WOJCIECHOWSKI's coat and told him his watch could not be located. DELATORRE then stated WOJCIECHOWSKI left the premises after getting his coat.

While on scene, I spoke with the bartender, Alberto VALLE (W/M 9-26-90), regarding the incident. VALLE informed me he is the one who observed WOJCIECHOWSKI push the female in the face and observed when WOJCIECHOWSKI fell to the ground on his own. VALLE stated he was able to see when they carried WOJCIECHOWSKI away from the bar but did not see anything after that.

I asked DELATORRE if there was video footage regarding the incident and he stated yes. PO TOLENTINO and I were able to view footage regarding the incident. Upon reviewing the video footage, it was determined the statement WOJCIECHOWSKI proived to us was not accurate or consistent with what the video depicted. The statement DELATORRE and VALLE provided was consistent with what the video depicted.

While on scene, I spoke with Angel VELASQUEZ, who is the licensee's son and asked him if I could return the next day to retrieve the video footage of the incident and he stated yes. I also asked VELASQUEZ if he wanted citations issued to WOJCIECHOWSKI and he stated no.

I informed VELASQUEZ I would be filing a license premise report regarding the incident. While on scene, I did not observe any visible violations. VELASQUEZ was cooperative during our investigation.

On Sunday, 2-28-16 at approximately 7:18pm I, Squad 2464, and Squad 2490 (PO Richard TOLENTINO) responded to KANA Mojito Club to retrieve video regarding WOJCIECHOWSKI's incident.

At approximately 9:31pm, I along with PO TOLENTINO changed locations to District 1 because we were instructed to report our findings to Lt. DURAN due to WOJCIECHOWSKI's mother getting involved in the incident. Upon arriving on scene, we reported our findings to Lt DURAN and provided a copy of the incident.

Re: Notice of Nuisance Premises

Dear Angel M VELAZQUEZ:

This letter is notice to you that the Milwaukee Chief of Police, by the chief's designee, the district commander, has determined that the premises located at 626 S 5th St Milwaukee, WI ("the premises") is a nuisance pursuant to Milwaukee Code of Ordinances ("MCO") § 80-10, Chronic Nuisance Premises. As an individual or entity that is licensed or subject to a license in the operation of a business upon the premises, you are a responsible party for abating the nuisance activities occurring at the premises.

The Milwaukee Police Department has responded to the following described nuisance activities at the premises on the corresponding dates, which qualify the premises as a nuisance:

- 1. On Sunday, May 22nd, 2016, at 2:16 AM, Milwaukee police officers were dispatched to the area of 500 W Pierce St to investigate a "Fight" complaint. Responding officers observed multiple subjects fighting in front of the premises. The investigation revealed that subjects had engaged in a "disagreement" and that police were dispatched. As officers were taking a subject involved in the incident into custody, the subject spit on two officers. This nuisance activity is contrary to MCO 80-10-2-c-1-c.
- 2. On Sunday, July 17th, 2016, at 7:39 PM, Milwaukee police officers were dispatched to Milwaukee Police Department District Six to investigate a "Battery" complaint. The investigation revealed that the victim in this incident had been struck with a beer bottle, by a known subject, inside of the premises at or about 1:00 AM on the same day, causing a laceration that required sutures to close. A subject was taken into custody regarding this incident. This nuisance activity is contrary to MCO 80-10-2-c-1-c.
- 3. On Saturday, October 15th, 2016, at 4:33 AM, Milwaukee police officers were dispatched to St. Luke's Hospital to investigate "Battery" complaint. The investigation revealed that the victim in this incident had been battered by a known subject inside of the premises

causing bruising, swelling, and a facial fracture. The subject was later taken into custody. This nuisance activity is contrary to MCO 80-10-2-c-1-c.

As a consequence, you may be subject to a collections action for the cost of future enforcement for any of the nuisance activities listed in MCO § 80-10-2-c that occur at the premises.

You are directed to respond to my office within 10 days of receipt of this notice with an acceptable, written course of action that you will undertake to abate the nuisance activities occurring at the premises, or file an appeal. You may appeal this nuisance determination to the Administrative Review Appeals Board. Any appeal must be in writing and a processing fee will be charged. Please contact the Office of the City Clerk at (414) 286-2231 for additional information.

If you elect to provide a written course of action, I shall evaluate it to determine if it is a reasonable attempt at abating the nuisance activity.

Prior to responding with a written course of action, it is highly recommended that you obtain records relating to police responses regarding the premises. You may obtain these records from the Computer Aided Dispatch System (CADS) at the Open Records Section of the Milwaukee Police Department (District Three Station, 2333 North 49th Street, Second Floor) between 8:00 AM and 3:45 PM. There is a cost of 25 cents per page for these records.

Once you are able to determine the type of nuisance activity occurring at the premises, please review the following examples of nuisance abatement measures that you may include in your written course of action to abate the nuisance activity. These suggestions are not exclusive, may not apply to the particular premises, and you may propose other nuisance abatement measures that would be appropriate under your particular circumstances.

- Exchange names and telephone numbers with the owners and operators of neighboring premises.
- Participate in a local block watch, neighborhood association, and business association.
- Attend the monthly crime prevention meetings conducted by the local Milwaukee Police District Community Liaison Officer who can be contacted at (414) 935-7228.
- Monitor the property for evidence of drug activity. This may include observation of clear corner cuts of baggies strewn about, excessive quantities of plastic sandwich baggies found in odd places, presence of numerous weight scales or communication devices and drug paraphernalia such as unusual pipes, empty cigar wrappers, burned hollow tubes, etc.
- Install "No Loitering" signs in the front and rear of the exterior of the premises. This signage permits police to cite loitering individuals in the yard and sidewalk area.
- Install "No Trespassing" signs in the front and rear of the exterior of the premises. This signage permits police to cite trespassers in commercial properties.
- Participate in the E-Notify system for email updates regarding the premises.
- Regularly file open records requests for Milwaukee Police Department Computer Aided Dispatch System (CADS) reports regarding the property.

- Institute a standing complaint with the local Milwaukee Police district station that will allow the police department to remove any individuals loitering on the property.
- Draft and serve a no trespassing order against identified nuisance persons and provide the local police district station a copy of the served order.
- Install and maintain a digital security surveillance system.
- Employ security personnel.
- Enroll in Respect 21 or MARTS program (contact CLO for more information)

If you propose a course of action which is rejected by me or fail to timely respond to this request, and a subsequent nuisance activity occurs on or after 13 days after receipt of this notice, you will be subject a collections action for the cost of any police services and enforcement.

Once you have been billed for the costs of police services and enforcement for three or more separate nuisance activities within one year of the date of this notice of nuisance premises, the premises may be designated a chronic nuisance, pursuant to MCO § 80-10-6, and each and every subsequent incident of nuisance activity at the premises may be deemed a separate violation and result in a citation being issued to you for failure to abate the nuisance activity. Each citation would subject you to a forfeiture of not less than \$1,000.00 or more than \$5,000.00. Upon default of payment of a chronic nuisance citation you would be subject to imprisonment in the county jail or house of correction for a period of not less than 40 days or more than 90 days for each violation.
