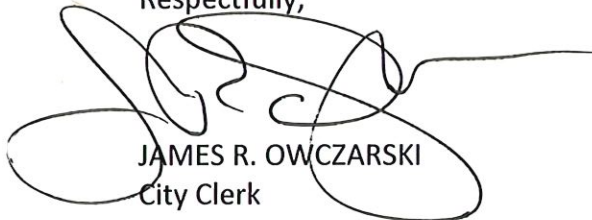
Dear Mr. Hernandez Vazquez:
