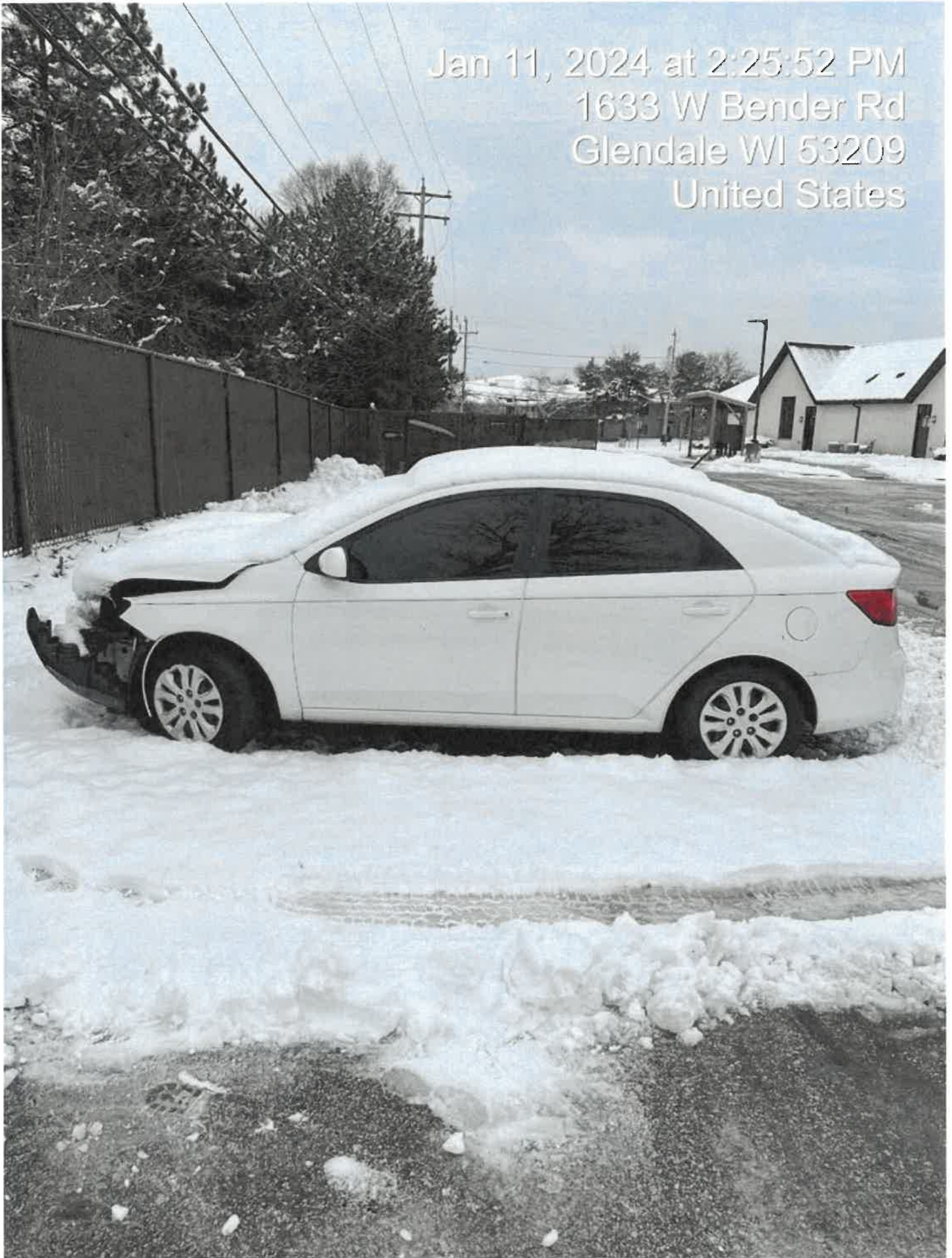

That is why I am writing this letter to defend Jay (Legend Towing) because he has always been a good professional and respectful person at the property.

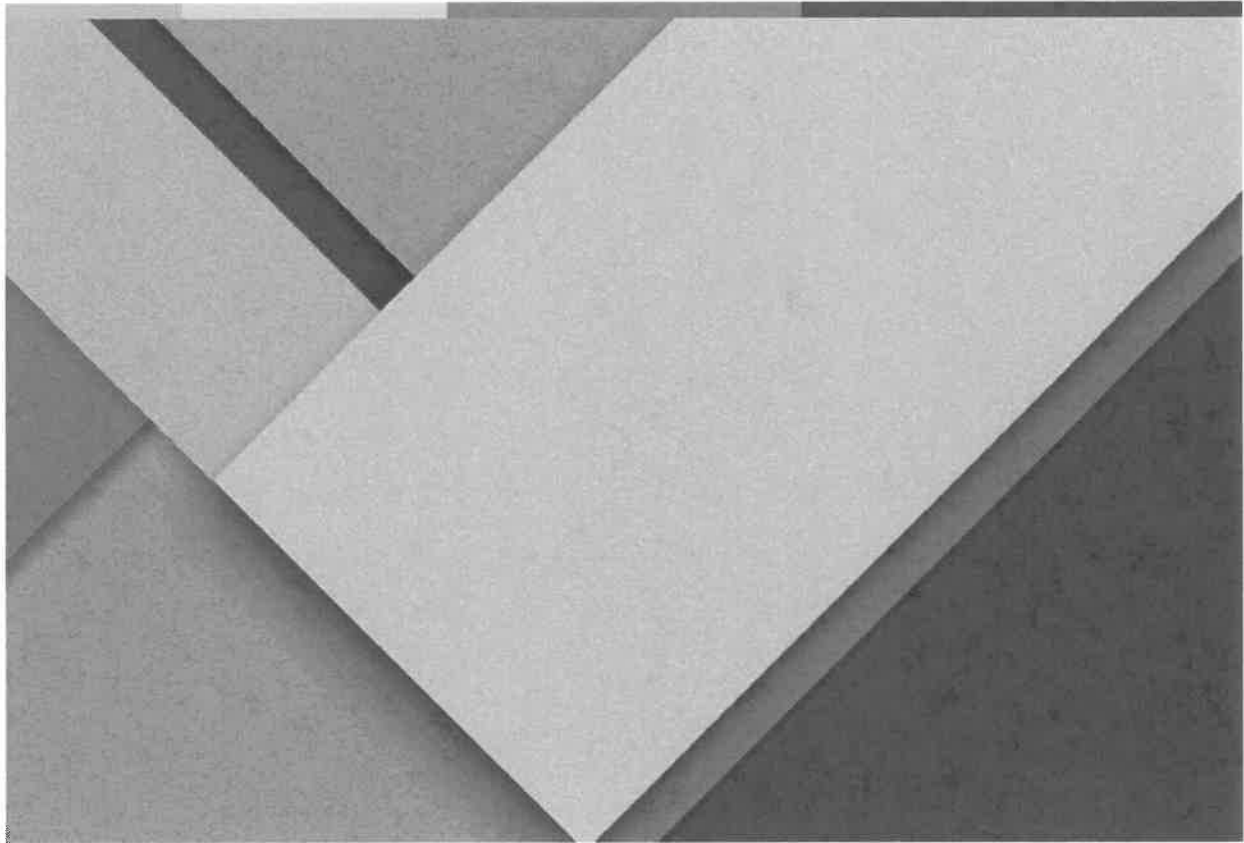

Specifications

Our vehicle fleet includes everything from rollbacks to wreckers to self loading snatchers. Our trucks are all outfitted and equipped with any and all required equipment to complete safe and damage free towing of any vehicle in any condition. We monitor our properties on a 24 hour a day basis with checks being made several times a day. These checks can be done at different times within windows specified by the property owners or on as needed basis to regularly ensure authorized parking is being done on property . In the event a vehicle is found in violation of agreed enforced guidelines 4 photos will be taken of the vehicle, Identifying information on the vehicle will be reported with local authorities of the area in which the tow is taken place to ensure it is properly reported and logged in the system as a towed vehicle. We also keep records of every vehicle towed, pictures/videos taken include geo tracking, dates and time stamps to ensure times locations and conditions of the vehicle are also logged and noted before it is towed in. This information will always be available upon request.

In the event that a vehicle is towed in error, ONLY at Property Owners request we will release vehicles free of charge and (ONLY to listed tenants). We understand that mistakes happen new tenants new vehicles may sometimes not yet be logged or stucked but we do
