

NOTICE OF INJURY
PURSUANT TO SECTION 893.80(1)(A), WISCONSIN STATUTES

PLEASE TAKE NOTICE that Kathleen C. Drabek, by her attorney, Eugene E. Detert, hereby gives notice of the circumstances giving rise to a claim as follows:

1. That on December 18, 1999, at approximately 9 a.m., the claimant, Kathleen C. Drabek, suffered bodily injuries and damages arising out of a slip-and-fall accident occurring in the paved roadway at approximately 3456 South Pennsylvania Avenue, City of Milwaukee, Milwaukee County, Wisconsin, due to a sudden drop in grade of the paved roadway at that location.

2. That, upon information and belief, certain repairs or resurfacing work has been done to the roadway in the 3400 block of South Pennsylvania Avenue; however, the grade of the portion of the roadway used by vehicular traffic has been maintained at a different level than the parking lane where the claimant had legally parked her vehicle on the date and time in question. Further, upon information and belief, the City of Milwaukee has negligently maintained the condition of the roadway at a grade lower than the parking lane without providing warning to individuals such as the claimant who are entering or exiting vehicles, subjecting the claimant and other potential claimants to an unreasonable risk of injury and damages by virtue of the unexpected change in grade in said roadway.

That as a direct and proximate result of the City of Milwaukee's negligence in maintaining the roadway in the 3400 block of South Pennsylvania Avenue, as referred to in paragraph 2 of this notice, the claimant suffered severe bodily injuries requiring medical treatment and she continues to experience pain, suffering, bodily injuries, loss of earnings and other damages which may be permanent in nature.

4. That this notice of circumstances giving rise to a claim for liability against the City of Milwaukee is given pursuant to Section 893.80(1)(A), Wisconsin Statutes.
