This report is written by P.O. Kevin VODICKA assigned to District Two, Day Shift, CPU. On Tuesday, November 25, 2025, at 2:00 pm, Captain Erin MEJIA, Alderman Jose PEREZ, ADA Jesica BALLENGER, P.O. Delian MENDEZ-SANTIAGO, P.O. Carissa SANCHEZ, Safe and Sound NSC Araceli ARAVELO, and I, met with the licensee, Maritza PICA-FUENTES, at District Two regarding her upcoming renewal hearing.

A recap of issues with the license, complaints of the business operating after hours, Dept. of Revenue seizure of property, and the inability to verify if the camera system and DVR were functional was discussed.

The licensee stated that she has spoken to her neighbors about their concerns and asked that they communicate with her if there are issues at the bar. The licensee stated that she will call for police if the neighbors inform her of an issue. The licensee also stated that she has lost the receipts for alcohol purchases but will retain all future invoices and that she has now posted all licenses in plain view. The licensee stated that subjects damaged her exterior cameras and believes that these subjects were not patrons of the bar but rather were people loitering in the area that refused to leave. The licensee also acknowledged that some of the alcohol was purchased from businesses that were not licensed wholesalers. The licensee promised that if the cameras were not functional she would upgrade the system. The licensee stated that her security would monitor the outside of the bar to prevent people from loitering.

The licensee and Ald. PEREZ has a discussion regarding how the licensee has promised to fix issues at the bar prior to every renewal and that the licensee continues to make such promises without correcting the issues.

Upon arrival we located a worker from the bar who identified herself through Wisconsin ID as Maritza Ivette PICA FUENTES (H/F 03-24-1977) employed by Punta Cana stated that as the bar was closing and the customers were leaving she heard a series of gun shots outside near 12th St. PICA FUENTES explained that she did not observe anyone and had called 911 right after hearing the shots fired while inside the business. An initial search of the area was done with no victims or evidence found. All permits/licenses were valid.

The business does have cameras that should have captured the incident but PICA FUENTES and her coworker stated that they were not working.

On Sunday, April 20th, 2026, at approximately 1:43am, Squad 2350 (P.O. V. TORRES and I) was dispatched to 2000 S 13th St in the city and county of Milwaukee, for a Shooting incident.

Upon arrival we observed people in distress and running from the Punta Cana Bar. As we approached closer on foot, I observed another officer giving CPR to an individual that was laying on the ground. Jerry Ivan PICA-FUENTES (W/M 10-19-1989) was telling people to go northbound so they wouldn't get in the way of the officers giving CPR. After the bar was almost empty, I then went in and was able to talk with Maritza Ivette PICA (W/F 03-24-1977) who was owner of the establishment. PICA was very helpful she let us use the establishment to interview the victim's wife and had other people in there that could have been potential people who may have heard something or seen something. PICA let CIB use her video cameras so they could see what led up to the incident. PICA-FUENTES was one of the employees in the establishment and also helped with the individuals that were inside that were affected by the incident that happened by helping keep tensions low.

While on scene I did observe the licenses posted and they were up to date and during the investigation of the incident I did not see any violations in the license premise.
