## **NOTICE OF INJURY AND CLAIM**

To the Officers of the County and City of Milwaukee and the Public Works

Administration

You are hereby notified that pursuant to Wisconsin Statutes Secs., 893.80 and 62.25, Penny Lee Walden of 2200 North Martin Luther King Drive, Apartment B35, Milwaukee, Wisconsin 53212, hereby submits a claim to the City of Milwaukee for great injury and damage to her person she suffered on January 4, 2003 by reason of negligent failure to maintain city sidewalks and lift grates which resulted in her falling on the sidewalk as she walked down the street
