On 2-23-03 a Sunday <sup>(approx. 8:AM)</sup> it was towed  
because of paper over the vin # and no plate?  
The vehicle was open and my phone # was  
in plain sight. I did not deliberately cover  
the vin #!!!

On 2-23-03 approximately 2:30 in the  
afternoon I noticed it was missing. I called  
the police and the girl said I had to wait  
for a squad at home to report it stolen.  
But I could also call to see if it was  
towed. I called the tow yard and they said  
they didn't have it.

Meanwhile through all this my mother  
was in the hospital recovering from surgery  
I didn't know if she would be all right  
or not. Basically I was exhausted and neglected  
to move the truck on Sat nite.

I went back to the hospital Sunday about  
3:30 and stayed to about 9pm. I called the

tow lot once more and they said they didn't have it. When I got home I called the police again and a squad came so I filled a stolen vehicle report. The officer said I could go to police station to file!

On Monday 2-24-03 I called the tow lot again and they said they didn't have my truck.

On Thursday 2-27-03 I was out of town till about 8:30pm when I got the mail I had received a letter from the tow yard saying they had my truck.

On Friday 2-28-03 I went to the tow yard the bill was \$95 tow + 5 days at \$20 day \$100 \$195 to get my vehicle. I paid with my Mastercard and asked the girl where could I contest this. She gave me a slip with city attorneys office. There also was a \$50 ticket on windshield. \$245 total

On Wed. 3-5-03 I went to see if I could contest the tow. The girl said if I had come the day of the tow or the day I had retrieved it that the city attorney could do something about it. Since I didn't I would have to write this letter!

I request a hearing or refund of my money for I feel this wasn't right. I didn't do this on purpose!
