Major Highlights Employment, Administrative & Health



- Advised the Common Council, Mayor's office, and departments regarding response to federal immigration-related grant conditions. Ongoing evaluation of legality of federal efforts to compel cooperation with immigration enforcement efforts and to condition grants on cooperation.
- Successfully defended two federal employment summary judgment decisions appealed to the 7th Cir. Court of Appeals.
- Represented the City and Election Commission in numerous election related challenges, including a voter registration appeal currently pending in the Wisconsin Court of Appeals.

Major Highlights Employment, Administrative & Health



- Assisted in research and rewrite of MCO ch. 98 governing underground conduit occupancy licensing.
- Successfully defended non-renewal of five licensed premises against circuit court challenge – one further successfully defended in appeal to the court of appeals – one pending in the court of appeals.

- Assisted Assessor's Office and BOR in clarification and streamlining of the appeal process.

- Assists all City departments with contract drafting, negotiation and interpretation.
- Half of the ACAs in this section handle purchasing and other, non-real estate contracts for the City they have been asked to draft, review, and negotiate approximately 105 new contracts in the past 12 months.

Special Projects:

- Continue to assist MPD and Comptroller in approving paperwork for payments under the federal grant for the Republican National Convention in 2024 and prepare for the audit of that grant.
- Advise departments on various executive orders from President Trump affecting federal grants and attempting to preserve the City's DEI and environmental initiatives in light of these executive orders and new grant certification language.
- Re-writing of MCO 304-49 in response to changes in state law and a US Supreme Court case that dramatically changes the way the City markets and sells tax-foreclosed properties.




Litigation:

- The City had one notable state court trial in 2025 by successfully convincing a jury to award 50% contributory negligence to a co-defendant where the jury awarded less than half of the plaintiff's demand.
- The CAO had 5 state court trials to the bench on challenges of the City's assessments.
- The CAO successfully defended the City in an motion hearing on attorney's fees in the lawsuit regarding the City's RNC permitting scheme.
- More than a dozen cases against various City entities were dismissed on the City's motion (either motions to dismiss or motions for summary judgment), which is the most efficient way to dispose of cases.
- The CAO is currently defending the City in eight appeals before either the Seventh Circuit Court of Appeals or the Wisconsin Court of Appeals.
- Finally, the CAO successfully settled several litigation matters for millions <u>less</u> than was demanded.

Service Uniformity



Our work is largely dependent upon client requests. We work with every Alderperson which allows us to provide services to all of the districts.

- At the beginning of the year, the Neighborhood Revitalization (NR) Team conducted meetings in each MPD District and invited the local Alderpersons in order to get a broad understanding of problem properties and behaviors across the entire City.
- The NR Team and CAO management have participated in community meetings and trainings in different neighborhoods, with an eye to increasing capacity to do so.
- Our real estate team works with DCD on economic development and other real estate projects throughout the City.

Environmental Impact



Much of our work is paperless and our recent switch to Legal Files, our case and document management system, has aided that effort.

Also the clients we assist such as ECO, Historic Preservation, some DPW divisions, and Water Works are working on environmental policies and we provided legal advise on those policies.
