On Friday, February 28, 2025, at 8:55 PM, I was flagged down by a male employee outside a gas station located at 3308 W Vliet St in City and County of Milwaukee regarding a Trouble with Subject call for service.

Upon arrival, I observed a vehicle with a flat front driver-side tire bearing Wisconsin auto plate AYC-6849. The driver of the vehicle appeared to be in a disagreement with her girlfriend.

I spoke with the male occupant of the vehicle, who mentioned he was waiting on car parts from friend and would be leaving soon. The individual who approached our marked MPD squad car was identified as Ramandeep SINGH (W/M 07-23-99), who verbally provided a phone number of 347-866-3275.

SINGH stated he had no objection to the couple remaining on the premises as long as they calmed down their argument. The business cooperated fully with the investigation. There were no security officers present on site. business representatives that the no property damage but did loud during their altercation.

On Friday, June 13th, 2025 at 2:31pm I, Squad 3190W, responded to an Abduction at the Clark Gas Station located at 3308 W Vliet Street, which was located within the City and County of Milwaukee.

Upon arrival I observed the caller and victim, Jessica L. REED, W/F, 1-18-93, walking on the sidewalk just east of the gas station holding her 4 year old baby, named Lamarii J. WINTERS, H/M, 12-16-20, in her arms. REED was crying and saying that her vehicle, a silver 2009 Pontiac G6, WI AXL1277, had been stolen while she was inside the gas station at 2:30pm. REED did not give anyone consent to enter and drive her vehicle and wished to prosecute.

REED stated that she parked her vehicle on the east side of the gas station and walked into the establishment. REED stated that the suspect, an unknown black male, 17-19yoa, dark complexion, 601-602, skinny build, wearing a white t-shirt, light colored pants and white shoes, walked into the gas station right in front of her. REED stated that while she was inside the store, the suspect walked out and got into her vehicle and drove off northbound on N 33rd street with WINTERS in the back seat on the passenger side. REED stated that she called police right away and was frantically looking around for her son.

REED stated that she started walking around the area to help look for anything to help and observed WINTERS sitting in the middle of the alley located north of the gas station. REED was on her way back to the gas station when I pulled up and observed her holding him in her arms.

REED stated that her vehicle has black tape on the rear lights and stated that the hood does not close all the way. REED further related that there is no front grill on her vehicle.

Gas station surveillance video corroborated incident and assisted with investigation.

The following report copied and submitted by Officer Carlos Felix assigned to the License Investigation Unit, Day Shift.

This report is written by P.O. Isaac ORTIZ, Assigned to District Three, Late Shift.

On 07-30-2025 at approximately 6:41 a.m. P.O. Gregory JOHNSON and I, Squad 3350, (while in full duty uniform and in a marked MPD squad, equipped with Axon Body Camera) were dispatched to a Overdose complaint at the location of 3308 W. Vliet Street, which is in the City and County of Milwaukee.

Upon arrival, Milwaukee Fire Department (Engine 32, led by LT Mike SCHWADE and Med 8) (Blue Shift) started to medically assist the victim later identified as Deundrae M. GOODWIN (b/m 12-24-1979) .

GOODWIN was laying on the ground at the gas station parking lot at the above listed location. GOODWIN appeared breathing but not conscious at the time. Milwaukee Fire Department administered one dose of Narcan (2 mg) and one intravenous to GOODWIN. GOODWIN momentarily gained consciousness and was transported by MED 8 to Aurora Sinai Medical Center for treatment.

GOODWIN was admitted at 7:15 a.m. on 07-30-2025 and assigned to Dr. ENTWISTLE.

I did not observe any drug paraphernalia in the immediate area of GOODWIN.

Interview of Deundrae M. GOODWIN (b/m 12-24-1979)

GOODWIN stated he left his residence (3332 W. Juneau Ave) at approximately 6:10 a.m. and walked to the Citgo gas station located at the above listed location. GOODWIN stated he met a friend later identified as (Thomas M. TESCH (w/m 05-01-1980) of his on the way to the Citgo gas station. GOODWIN stated TESCH accompanied him as he was going to buy him a snack at the gas station. GOODWIN stated the only drug he ingested was a THC vape at approximately 2:00 a.m. on 07-20-2025. GOODWIN stated he did not ingest any other type of drugs. GOODWIN stated he doesn't remember what happened to him prior to him going unconscious at the parking lot of Citgo gas station.

Interview of Thomas M. TESCH (w/m 05-01-1980)

TESCH stated he met GOODWIN at approximately 6:20 a.m. on 07-30-2025 in an alley as he was walking to the Citgo gas station. TESCH stated he went with him and during the walk to the gas station he did not see GOODWIN ingest any type of drugs. TESCH during a conversation they had on the way to the gas station GOODWIN mentioned to him that he smoked marijuana and had been drinking. TESCH stated that he has known GOODWIN as a friend and informed officers that GOODWIN is a cocaine user but did

The hearing before the Licenses Committee will take place on 1/6/2026 at 10:15 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


