MHD just completed a spot check at the location and trucks Parrilla Mixe and El Carboncito were onsite. We confirmed that both of these trucks already received their 2026 routine therefore we did not need to complete any inspections today. The inspector shared that the parking lot was not a concern for trash and only 1 car was parked in the lot at the time.

El Rincon, however, has open orders from their routine 2026 inspection that we are attempting to follow-up on but have not had luck finding them in the field/no contact. They are also in need of a mobile renewal before they can get their truck license released (MHD hold) and are currently operating with a provisional that is good until Aug. We will continue to keep an eye out and await for them to reach out for this necessary inspection.

P.O. Mendez and I responded yesterday to the [redacted] and spoke with the [redacted] who told us about the issues. [redacted] having with food truck patrons parking and using their private parking lot to eat and wait for their food, also leaving their garbage in the lot. We advised [redacted] to reach out to a tow company to contract with, and explained to [redacted] that the company will post signage regarding "unauthorized vehicles will be towed...", and that we will pass that message along to the food trucks along Forest Home Av. One of the [redacted] we spoke with stated that the most uncooperative and confrontational food truck out of the 3 there is "El Rincon Fritanguero", the blue truck out there, which wasn't out there when we stopped by yesterday. We then spoke with the owners of El Carboncito and Parilla Mixe and advised them about the complaints from [redacted] and that [redacted] would be contracting with a tow company soon to tow unauthorized vehicles off their property. We would like to still advise El Rincon Fritanguero about the complaints, when we see them out there. I'll be doing License Premise reports for all food trucks regarding.

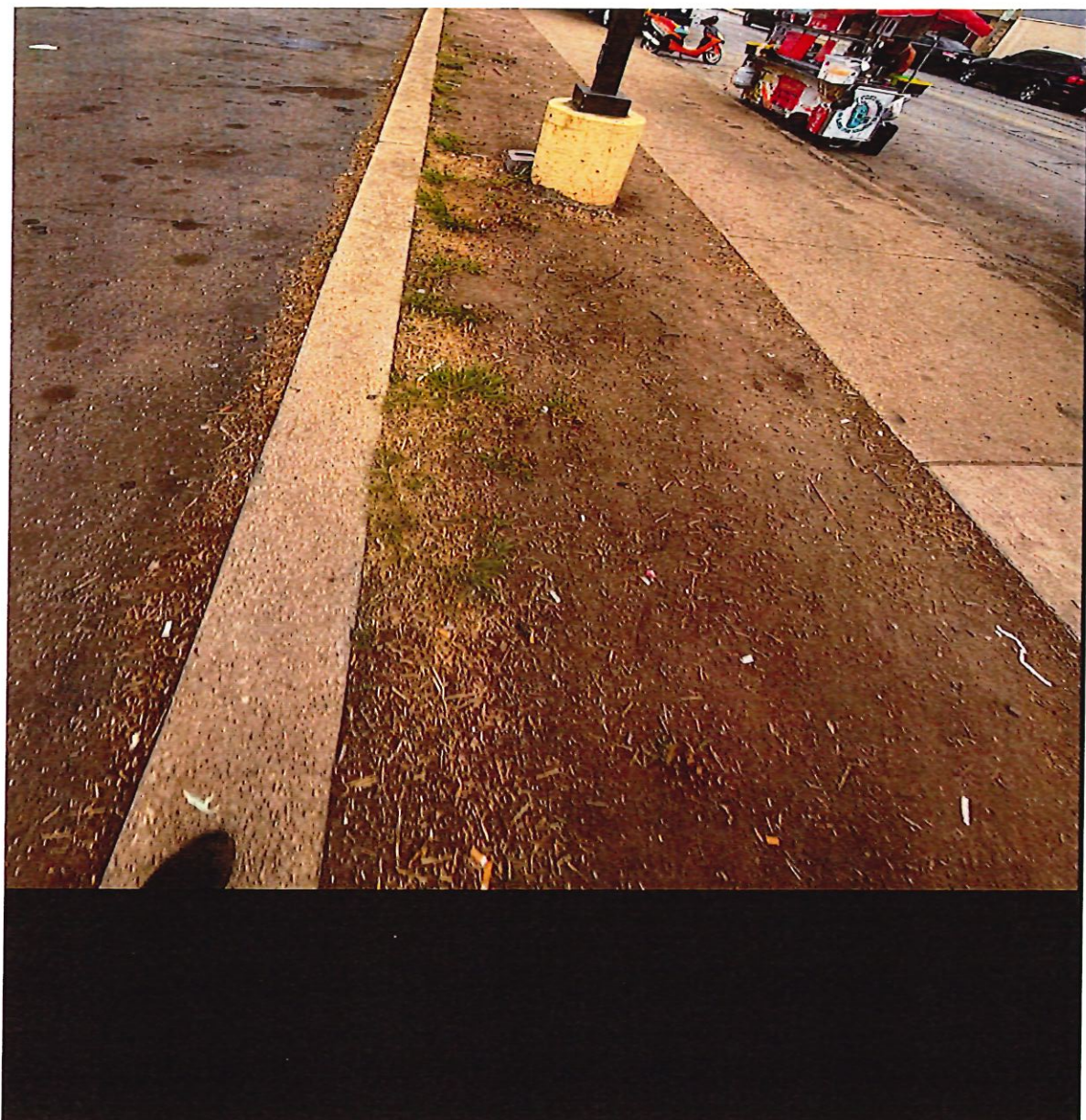

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/07/25, at 9:00 a.m., an officer conducted a CPTED. The establishment was open to business and being operated by the previous owner. Security cameras were functioning. The new agent was advised of a standing complaint form to help deal with problems such as loitering.
2. On 05/28/25, at 11:00 a.m., officers conducted a Licensed Premise check. Upon officers entering the business they were greeted by the manager, who stated the business is still operating as the Brass Key, which is owned by the same person until the licensing change takes place. Officers attempted to contact the owner but were unsuccessful.
3. On 08/14/25, at 11:46 a.m., an officer Conducted A licensed premise check. Signs were posted on the exterior and interior informing patrons no alcohol will be served until further notice. The previous owner was on scene and stated the business was sold on December 2024, and they were attempting to assist the new owner with the renewal of the food and liquor licenses. While on scene the new owner/agent arrived and provided the officer with a valid City of Milwaukee food dealers license.
4. On 08/19/25, at 12:20 p.m., an officer conducted a License Premise check. A sign was posted on the exterior with the new business name. Three handwritten signs informing patrons alcohol is not being served at the location were posted. Employees were cooperative during the investigation.



5. On 08/23/25, at 12:16 p.m., an officer conducted Follow Up per an aldermanic request to confirm the operation of the business. The establishment was confirmed to be open and operating. Several signs were posted informing the public that alcoholic beverages were not being sold until the license was granted. Bottles of alcohol were still on display, and the owner was advised until a license is granted those items should be removed.
6. On 09/16/25, at 2:30 p.m., officers conduct Follow Up regarding restricted food truck parking. A temporary no parking zone was implemented to help curb a street takeover. Three individual companies found to be parked in the zone. They were advised of the restriction and they needed to move. Officers were told by the owners of each business they met with the local alderperson and were informed they could park at the location. Additional information was provided and all three owners complied with the request to move.
7. On 09/19/25, at 11:54 a.m., an officer conducted Follow Up. Signs were still posted advising the public alcoholic beverages are not being served until a license is obtained. The owner stated they did get approved for a liquor license but have not received a physical copy, and will not serve alcohol until they receive their license.

### LICENSED PREMISE REPORT

This report was written by Police Officer Fabian GARCIA assigned to District 6-Days, Community Partnership Unit, Squad 6164.

I was asked by License Investigation Unit to conduct a Crime Prevention Through Enviornmental Design (CPTED) safety and security survey for Maricela A. Jimenez, who is applying for their liquor license through the city of Milwaukee and is planning to be the new agent/owner of the Brass Key located at 4952 W. Forest Home Avenue.

On May 7, 2025, at 9am, I met with JIMENEZ at the Brass Key and conducted the safety assessment. JIMENEZ stated that the location is currently opened and is being operated by the current owner Mr. George D. TSAOUSIS, which i did confirm on the current licenses that were posted. JIMENEZ stated once her licenses are approved that is when ownership will completely change and she will then take over at that time. Also on scene was current manager of Brass Key Barbara A. MUMA.

JIMENEZ stated that there are two exterior cameras, one facing the parking lot and the second facing the north side of the property. The interior does have five cameras, which do face the entrance and exit doors as well as the register. JIMENEZ stated that she does plan on adding additional interior surveillance cameras. JIMENEZ was provided with a District 6 community contact guide. A discussion was had regarding the district 6 standing complainant form. JIMENEZ stated is they do see any issues regarding loitering in the future they will fill out the form and return it to the district station.

JIMENEZ was very cooperative during the safety assessment. There were no additional recommendations

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
