**1. Description of Grant Project/Program (Include Target Locations and Populations):**

This grant seeks to identify and target major drug trafficking and criminal organizations in support of DEA 360 Strategy and Special Operations Division (SOD) project. This multi-agency strategy targets Drug Trafficking Organizations (DTOs) and interrupts the trafficking of narcotics. Nationwide coordination is required for investigators to dismantle criminal enterprises through the creation of comprehensive databases and information sharing. The OCDTEF is also the driving force behind the efforts to target Transitional Organized Crime (TOC), which often times involves large networks of international drug trafficking and criminal activity.

**2. Relationship to City-wide Strategic Goals and Departmental Objectives:**

Overtime funds will solely be used to assist MPD in current and future joint enforcement operations. This project aligns with the department's mission to create partnerships to address quality of life and nuisance related drug activity that impacts public space.
