There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

I would like to file an objection to the license of Jack's Bar (Bistro) located at 4923 W Villard Ave, Milwaukee, WI 53218.

I was shot inside of this place on December 31st 2023!

At this time there is an ongoing investigation. However the establishment remains open while I have no answers and again its an ongoing investigation.

There has been no confirmation that the employees (Security guards, staff) were NOT the shooters.

However it has been confirmed that there was shooting on the inside and outside of Jacks Bistro (where I was inside of) from an altercation between the above mentioned parties.

I was picked up from the establishment and transported by paramedics after suffering 2 gunshot wounds to my lower extremities.

I have not spoken to the owner, manager, staff, gotten a letter of or any sort of apology face to face.. no updates of and no apology... no justice.... no nothing.

I'm just not sure if it's protocol to have someone shot in your business.. wipe their blood up and open again the next day?

Meg left a voicemail message stating there would be an order meeting between the owner, community liaison officers, sergeant, and city attorney to work out a plan and I would be contacted.

Once again, to date, there is no followup; no contact by anyone about the "order" and the noise continues, consistently. I am taxpayer, and constituent of the Villard Avenue District. I deserve better. Can someone please follow up and assist with a resolution?

Jacks Executive Bistro is a nightclub located in the midst of our residential neighborhood. The club provides musical entertainment for their patrons. The problem is the club plays EXCESSIVELY loud music that is disturbing the peace and quiet of the neighborhood. The music is so excessively loud that the sounds of the music, yelling of the dj, and party horn devices permeate the inside of my home resulting in disturbing the peace of my home and neighborhood. I cannot enjoy the comfort of my home, can't sleep, and am physically suffering from stress from the noise nuisance. The noise is CONTINUAL, 7 days a week, usually beginning at 10pm until 2-2:30am resulting in the enjoyment of my home, neighborhood, and peace and quiet of the neighborhood being severely disrupted. I have owned my home for over 30 years, and as a taxpayer I deserve to live in peace.

I have called SEVERAL times to report the noise nuisance to Milw Police nonemergency number, Alderwoman Pratt, emailed community police officers District 7 but had had NO intervention.

Since the security and staff as well as outsiders are under investigation as well as being interviewed and the camera footage is still being reviewed, I am wondering if there are grounds for this establishment to be closed until further notice?

It was confirmed that there were multiple shooters which includes the security/staff of the bar. This brings me great fear and makes me fearful for the lives of others that the establishment is still open.

Not only were they open after they remain open with unanswered questions or any justice served on my behalf. I have gotten no correspondence from the establishments owner or management team which also is a concern.

I am due to the . I am asking for support from my community to not just allow this situation to fly by. The community needs to know what occurred, the business needs to know this is not okay, patrons need to know that place is not safe.

The place is less than a mile away and it just gives chills that this place is still open for business.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 07/13/2013 the applicant was cited for Operating while Intoxicated. He was convicted on 09/11/2013 and his license was revoked for 8 months.
2. On 09/08/2013 the applicant was charged in Milwaukee County with Possession of Marijuana (Forfeiture).

4. On 02/18/23 at 10:25p.m., officers were dispatched to an Overdose at 4923 W. Villard Av. On arrival officers were advised by security the patron suffered from a seizure not an overdose, and they refused medical treatment by the ambulance.
5. On 03/28/23 at 1:42p.m., officers were dispatched to the area of N. 49<sup>th</sup> St., and W. Villard Ave., for a Shots Fired call. Officers observed a group of people assisting what appeared to be an intoxicated patron from the bar located at 4923 W. Villard Av. At no time during the investigation did any one flag officers down or appear in distress. A short time later, a victim of a shooting arrived at a hospital in the same vehicle officers observed earlier. Officers interviewed a gas station clerk from across the street as well as a resident from above the bar, both stated they heard the gun shots. Officers returned to the bar to investigate, however, it was closed.

6. On 05/17/23 at 3:12a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. On arrival the business was closed and no loud music could be heard. The officers contacted the caller who stated the music began at 11p.m., and continued until 1:30a.m. The caller further stated this does not occur daily and they think it depends on the DJ.
7. On 06/21/23 at 1:32a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. The caller stated they were willing to be a complainant and the music had been going on over 2 hours. On arrival the business was closed for and no loud music could be heard.
8. On 07/02/23 at 12:52a.m., Milwaukee Police were dispatched to a Shots Fired at 4923 W. Villard Ave. On arrival officers made contact with citizens outside who stated they did not hear any shots fired, but there had been fireworks in the area.
9. On 08/12/23 at 12:43a.m., Milwaukee Police were dispatched to a Noise Nuisance at 4923 W. Villard Ave. On arrival it was determined the music was loud, due to the door being held open while allowing patrons in. The security guard was advised to keep the door closed to avoid the disturbance. The security guard agreed. The officer was not able to make contact with the caller.
10. On 08/17/23 at 4:26a.m., Milwaukee Police were dispatched to a Noise Nuisance at 4923 W. Villard Ave. Due to higher priorities calls for service the officers were not dispatched until after bar close. The officers contacted the caller who stated they no longer needed the police.
11. On 10/12/23 at 5:42a.m., Milwaukee Police were dispatched to a Noise Nuisance at 4923 W. Villard Ave. On arrival there was no loud music and the business was closed.
12. On 10/15/23 at 5:17a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. On arrival there was no loud music and the business was closed. The caller advised the officer the music had dissipated.
13. On 10/20/23 at 2:19a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. On arrival officers observed the business was closed and did not hear any loud music. The caller stated this was an ongoing issue and was willing to be a complainant, however, the officer was unable to make contact with them.



14. On 10/27/23 at 12:58a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. On arrival officers did not hear any music or noise that would constitute the necessity to approach the business.
15. On 10/28/23 at 12:21a.m., Milwaukee Police were dispatched to a Subject with Gun at 4923 W. Villard Ave. Officers interviewed the agent who was on scene that stated patrons who were about to fight inside the establishment and were escorted out. The agent assisted the officer in checking the interior of the bar to make sure no one was hurt.
16. On 11/08/2023, at 5:16a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. Due to higher priority calls for service, the officers arrived over 4 hours later and the business was closed.
17. On 11/10/23 at 12:13a.m., Milwaukee Police were dispatched to a Subject with Gun at 4923 W. Villard Ave. Officers were advised prior to arrival the caller stated a subject came to the bar with a rifle and threatened to shoot a named security guard. On arrival officers observed no one in distress and investigation revealed there was no security guard by the name provided employed at the business.
18. On 11/21/23 at 10:29p.m., Milwaukee Police were dispatched to a Trouble with Subject at 4923 W. Villard Ave. On arrival officers observed the business functioning normal. The anonymous caller stated they did not see anything and the call was placed two hours prior to officer's arrival.
19. On 12/01/23 at 11:25p.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. Investigation revealed that when the business door was open, the music did appear to be excessively loud which could cause a disturbance to neighbors. Officers advised an employee of the violation, to which they agreed to turn the music down. The caller stated this occurs frequently and has affected them to the point they have considered moving.
20. On 12/13/23 at 2:15a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. No loud music was observed on officer's arrival and the business was closed.
21. On 11/30/23 at 11:52., Milwaukee Police were dispatched to a Subject with Gun at 4923 W. Villard Ave. Officers interviewed the agent who was on scene. The agent stated two groups of patrons began to argue in the bar and were kicked out. One of the groups waited for the other group at the gas station and began to argue in the median with the other group. The agent further stated they were told a female had been knocked over by a vehicle and a parked vehicle was struck by a vehicle the subjects were in. The agent attempted to show officers video surveillance of the incident but was unable to retrieve the incident on the camera.
22. On 12/16/23 at 4:51a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. The original call came in at 2:09a.m. On arrival the business was closed, however, officers noted during routine patrol that night they had driven in the area and did not hear music coming from the bar itself, but possible patrons playing loud music from vehicles as they were coming and going.
23. On 12/31/23 at 1:09a.m., Milwaukee Police were dispatched to a Shooting at 4923 W. Villard Ave. On arrival officers did locate a victim shot to both legs, lying behind the bar. Investigation revealed the shooting occurred in the parking lot and the suspect was a security guard who did not remain on scene. The agent confirmed the suspect was an employee, however, denied knowing their name. The agent did allow officers to view video surveillance which depicted a

security guard discharge their weapon. The video depicts all the security guards to be armed, however, when officers arrived on scene, none were armed and some were uncooperative.

24. On 12/31/23, Milwaukee Police drafted a Nuisance Premise for 4923 W. Villard Ave. The officer noted that during the past year the business has had two critical incidents that involved shootings. The notice was signed by the District Captain and sent out via certified mail on January 1, 2024.
25. On 01/06/24 at 1:18a.m., Milwaukee Police were dispatched to a Shot Spotter at 4923 W. Villard Ave. Officers located two unspent casings on the Eastbound sidewalk in front of the location and one in the eastbound parking lane on W. Villard Ave. Officers observed multiple armed security guards and attempted to interview one, who refused stating they had to escort a patron to their car. Due to previous knowledge of the security system, officers knew video of the incident would not have been captured.
26. On 01/06/24 at 1:18a.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. Due to a Shot Spotter call for service at a different location, officers did not respond until 5:07a.m., at which time the business was closed.
27. On 01/24/24 at 10:26p.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. On arrival officers did not hear loud music, however, contacted the caller who stated they could feel the vibration, but not the music.
28. On 01/30/24 at 10:31p.m., Milwaukee Police conducted a License Premise Check at 4923 W. Villard Ave. Officers observed the crowd to be small and 3 security guards on scene. The agent was on scene and the noise complaints were discussed. The agent stated they have asked security staff to get people to move out of the parking lot after close to keep the music down.
29. On 02/08/24 at 11:26p.m., Milwaukee Police were dispatched to a Noise Complaint at 4923 W. Villard Ave. There was no loud music coming from the location and officers were unable to contact the caller.
30. On 02/15/24, the applicant was charged with Operate Firearm While Intoxicated; Criminal Damage to Property (Domestic Abuse) and Disorderly Conduct ( Use of a Dangerous Weapon) in Milwaukee County Circuit Court.

Upon my/our arrival I observed a B/F to be shot in both of her legs and lying behind the bar, I also observed people running out of the bar. There were approximately 15 other squads who either came to the scene or assisted in the investigation.

I spoke to licensed premise owner, Anthony T. WILKS (M/B, DOB 07/10/1987). WILKS stated that the individual was not shot at his business but instead ran into his business after being shot. The business was both cooperative uncooperative with the investigation. There were approximately 5-6 security guards working that night at Jack's Executive Bistro, when the shooting occurred I reviewed footage from the shooting and observed the security guards to be armed. When officers arrived on scene some security guards were not armed and were uncooperative with police officers on scene. I then observed on security footage from the business a security guard discharging his firearm towards the side of the business. That security guard that discharged his firearm did NOT remain on scene. WILKS who owns the business stated that he did not know who the security guard was either but that he did work for the bar. WILKS was cooperative with allowing officers to review security footage regarding the incident, WILKS allowed myself to immediately review the video footage.

I reviewed video surveillance footage. The footage showed and observed a security officers discharging his firearm at approximately 1:11am The video was recovered by squad 1928.

Investigation revealed the victim was shot while standing in the bar's parking lot.

According to some witness, patrons of the bar was asked to not block the walkway inside the bar. One of the patrons, soon to be the suspect, was not happy about this request and made some threats, although the threats were vague and didn't include shooting up the bar. However, witnesses believed the suspect meant that he was going to get a gun.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.


