On Tuesday March 10, 2020 at approximately 11:09PM, my partner, PO Charles Scaife, and I responded to 4750 N Hopkins St in the City and Count of Milwaukee, regarding a possibly overdoes inside the tavern (Gold Diggers).

Upon arrival I observed Paratech parked on N. Hopkins Street with a patient in the rear. I spoke to the paramedic who stated that The Milwaukee Fire Department (MFD) responded to a subject who was unconscious inside the tavern and when they arrived they administered narcan to the subject who then awoke. The patient, who was later identified as Brian H. Clayton (B/M, 08/10/90) and works at the tavern as the door guard/tip handler.

When I spoke to Clayton he stated he had arrived to work at about 630pm-700pm. Clayton stated that before work he had smoked marijuana which he believed was less than a gram. Clayton stated when he arrived at work he began to setup the hookah, music, and money. Clayton stated he did smoke hookah while at work. Clayton stated he did not take any other drug today besides smoking the marijuana before work. Clayton stated he does have a lot of health issues and he does not take medication for that. Clayton stated he started to not feel well so he moved from the bar stool to the couch. Clayton stated he felt his heart slow down and that he passed out. Clayton stated the next thing he remembers is being woken up by MFD. Clayton again stated that he did not take anything else today. I asked Clayton if he takes any un-prescribed pills and he stated that on Monday morning at about 300am or 400am he took a rollie. Clayton stated he hasn't taken anything since then.

I then spoke to the bartender, Lakita D. Lewis (B/F, 10/17/74) who stated she arrived to work at approximately 700PM and Clayton was already at work. Lewis stated that when she saw him she thought he looked off. Lewis stated that Clayton seemed withdrawn. Lewis stated that she did not see Clayton do anything but just smoke hookah. Lewis did not have anything else regarding this incident.

I spoke to the owner, Michael Lyons (B/M, 04/27/78) who was not at the tavern at the time of the incident. I asked to view the security footage of when Clayton arrived at the tavern and Lyons showed me. While watching the footage I did not observe Clayton doing anything suspicious. Lyons stated that at about 10:15pm Clayton texted him stated that he did not feel good. Lyons stated he did not text anything else. Lyons did not have anything else regarding this incident. Lyons was extremely cooperative with the investigation.

- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
