This office is in receipt your claim in the amount of \$2,015.64, relating to your subrogation interest and the interest of your insured arising from a May 8, 2001 accident allegedly involving your insured and a City dump truck at 5400 West Hampton Avenue.

Our investigation reveals that the Fleet Services Division Report completed as a result of this accident notes that the City dump truck and your insureds' dump truck were travelling in the same direction in traffic lanes which were next to each other. The City vehicle was passing your insured. As this happened, your insured crossed over the lane marking and sideswiped the City vehicle. The primary liability for this accident rest with your insured. As such, the City cannot accept liability for the loss. Accordingly, we are denying your claim.
