Claim for Damages Due to Street Repairs at 5262 N 38th St, Milwaukee 53209

Dear Claims Department,

I am writing to formally submit a claim for damages resulting from street repair work conducted in front of my property located at 5262 N 38th St, Milwaukee. As a direct consequence of the repairs performed by the City of Milwaukee or its contractors, my property sustained significant damage, leading to a sewer backflow in the basement. This incident caused extensive property loss and financial hardship, for which I seek compensation.

#### **Details of the Incident**

- The City of Milwaukee conducted street repair work in front of my property at the end of December 2024.
- As a result of this work, my property experienced a sewer backflow, leading to flooding in the basement and damaging equipment as well as my tenant's personal belongings.
- The city subsequently sent a third-party contractor to investigate and verify the damage in mid-January 2025.
- The water heater was rendered inoperable.
- We had to hire a licensed plumber to inspect the sewer line, who determined that the damage was likely caused by the city's construction activities.

- Heavy-duty pumps were required to remove the sewage from the basement multiple times.
- The furnace sustained damage and required repairs.

## **Tenant Complaints**

- Persistent foul odors spreading throughout the house due to the sewer water.
- The need to boil water daily for warmth and hygiene due to lack of proper heating.
- Rising water levels in the basement due to freezing hoses preventing proper pumping.
- Health and safety concerns stemming from fecal-contaminated water being circulated through the home's ventilation system.

### **Expenses Incurred**

Contractor invoice for the expenses is attached, and a payment was made directly for the tenant's lodging.

I have attached a detailed list of expenses incurred as a direct result of this incident, including:

- Replacement cost of the water heater
- Plumbing inspection fees
- Rental cost of heavy-duty pumps
- Cost of cleaning and sanitation
- Furnace repair costs
- Any additional repair or restoration costs necessary to restore the property to its original condition
- Providing temporary lodging to the tenant

Total claim is: \$6950 (contractor invoice) and \$713.95 (tenant lodging) = \$7663.95

This claim does not include any damages suffered by my tenants or their personal belongings. The claim strictly pertains to the costs incurred by me as the property owner.

I respectfully request reimbursement for these costs, as the damage was a direct result of city-conducted repairs. Please review my claim and provide guidance on the next steps in the reimbursement process. If additional documentation is required, please let me know as soon as possible.
