## STATEMENT OF TAX LEVY

TO: Mr. Ronald D. Leonhardt, Clerk of the City of Milwaukee - Waukesha County, County of Waukesha, State of Wisconsin.

- I, Mae D. Killebrew, hereby certify as follows:
- 1. I am the duly elected, qualified and acting Secretary of the Milwaukee Area Technical College District Board of the State of Wisconsin.
- 2. The Milwaukee Area Technical College District Board, at the District Board meeting held on the 22nd day of October 2002, approved an operating tax levy of \$79,725,200. The District Board has also levied a direct annual, irrepealable tax levy in the amount of \$26,952,400 to pay principal and interest on promissory notes issued by the District. Accordingly, the total tax levied by the District Board is \$106,677,600.
- 3. Such total tax levy has been apportioned to the respective municipalities located in the District in proportion to the full value of all taxable property in the District, as certified to the District by the Wisconsin Department of Revenue. The proportionate amount of such total tax levy for the current year to be spread upon the tax rolls for collection in the City of Milwaukee Waukesha County is \$43,080. In accordance with the applicable statutes of the State of Wisconsin, you are hereby required to spread such amount upon the tax rolls of the City of Milwaukee Waukesha County for collection and, when such taxes are collected, to pay such amounts to the Milwaukee Area Technical College District Board.
