





FUTURE FISCAL CLIFF COMPELS MCTS TO PAUSE CONNECT 2 BRT


The 2025 – 2029 County Comptroller forecast shows financial gaps in transit service as soon as 2025, growing into an annual shortfall exceeding \$15M by 2028, the year CONNECT 2 is set to launch

Pausing CN2 at the current 30% phase will free up potentially \$15M in *one-time temporary funds* that will prevent cuts to transit service through most of 2027

The 0.04% sales tax increase implemented in 2024 prevented major cuts. It did not provide for service to be expanded

Milwaukee County and State leadership, with the support of MCTS and community advocates, must secure a long-term solution that addresses ongoing funding shortfalls as well as cost of additional bus rapid transit service




Figure 2 – Comptroller Forecast Before CN2 + 27 Applied





Figure 3 – Comptroller Forecast with MCTS's CN2 + 27 Applied

NEXT STEPS – PAUSE CONNECT 2 AND RESOLVE FISCAL CLIFF



Transit faces growing annual shortfalls 2025-2029, exceeding \$15M by 2028, the year CONNECT 2 is scheduled to launch

Pausing CONNECT 2 now preserves core MCTS service into 2027

Permanent Funding Solutions are Needed to:

- Maintain current service / prevent cuts
- Restart CONNECT 2 BRT from 30% Phase
- Explore / Study additional corridors for BRT
