NOTICE OF PUBLIC HEARING

DEAR PROPERTY OWNER:

The City Plan Commission has scheduled a public hearing to receive comments on Common Council File No. 250414, the proposed annexation of territory (commonly known as expansion of the boundary) to Business Improvement District ("BID") No. 20 (East North Avenue), which proposed territory is to generally include the area extending north from the current boundary between Bartlett Ave. and Oakland Ave. to Thomas Ave.; the area extending east from the current boundary to Frederick Ave. south of Greenwich Ave.; the area extending northeast from the current boundary between North Ave. to the south, Terrace Ave. to the southeast, and Prospect Ave. to the northwest, up to and including the properties at 2409 N. Terrace Ave., 2320 N. Lake Dr., 2315 N. Lake Dr., and 2462 N. Prospect Ave.; the area extending southeast from the current boundary bounded by North Ave. to the north, Summit Ave. to the southeast, and Ivanhoe Pl. to the southwest; the area extending south from the current boundary up to and including the properties at 2124 N. Prospect Ave. and 2071 N. Summit Ave.; the area extending southwest from the current boundary to Windsor Pl. southeast of Oakland Ave. and southeast to Prospect Ave.; the area extending from the current boundary south to include the properties along the south side of North Ave. east to Newhall St., and the individual properties at 1915 E. North Ave., 1820 E. North Ave., and 2443 N. Murray Ave., in the 3rd Aldermanic District. Please refer to the included map for specific details.

The proposed annexation of territory was initiated by BID No. 20 East North Avenue team who submitted a petition to the City of Milwaukee requesting that the City expand BID No. 20, per Section 66.1109 of Wisconsin State Statutes.

Interested parties will be offered an opportunity to express their views on the proposal prior to consideration by the City Plan Commission. Your attendance and comments at this hearing are invited so that a complete examination of all aspects of the proposal can be made.
