SWORN CHARGES BY CHIEF OF POLICE FOR REVOCATION OF LICENSE

Pursuant to Wis. Stat. § 125.12 (2)(ag)2, and §§ 90-12-1-F, I Milwaukee Code of Ordinances, Acting Chief of Police Edward Flynn, by Captain Patrick Mitchell, Commander of Police District Seven, being first duly sworn and upon his oath, respectfully charges the following based upon review of official Milwaukee Police Department investigative reports and communication with police and city officials.

1. That Winston Brown ("Licensee") is the holder of a Class "B" Tavern license for the premises known as Jamaica Inn, located at 3040 West Atkinson Avenue, Milwaukee, Wisconsin.
2. That according to Milwaukee Police Incident Report 082510020, on 9/6/08 at approximately 11:30 pm, the Milwaukee Police Department responded to a report of shots fired near the licensed premises.
3. That subsequent investigation revealed that a shooting occurred between a bartender of the licensed premises, Aszett Williams, AKA "Willie," and a regular patron of the bar, Paul Gayle, AKA "Pablo." Mr. Williams had been working and Mr. Gayle had been visiting the bar. When Mr. Gayle left, Mr. Williams armed himself with a firearm and went outside where he encountered Mr. Gayle who was also armed. While both suffered gun shot wounds, Mr. Williams died of his injuries, and Mr. Gayle survived his.
4. That the Licensee was present at the licensed premises during this incident and was interviewed initially by Officer Federer. While speaking to the Licensee, the officer observed him to turn around and speak to Deandra Pirtle at a volume to low for him to hear what was said.
5. That Officer Federer then spoke to Ms. Pirtle who told the officer that she was inside the bar and heard five to six shots fired while inside the bathroom.
6. That a short time later, Ms. Pirtle approached Officer Federer outside the presence of the Licensee and told him that when the Licensee spoke to her, he told her, "Don't say anything." She said she knew the shooter as "Pablo" and that he had entered the bar prior to the shooting with two men. She said she did not tell the officer this earlier because she was scared when the Licensee told her not say anything.

7. That Ms. Pirtle then spoke to Detective Sarenac and stated that she observed Mr. Williams go to the back of the bar, step behind a curtain to a storage area behind the bar and come out a few seconds later tucking a handgun into his waistline. She could only see the butt of the gun, but there was no mistake that he had a gun in his front waistband. About five minutes later Mr. Gayle and his friend went outside. About five minutes after that, Mr. Williams went outside as well. Shortly after that time, she heard gunshots.
8. That Detective Applegate spoke to the Licensee at the licensed premises on the scene. The Licensee stated that Ripton McKen went outside after the shots and returned and gave him Mr. Williams' cell phone. He later said Mr. McKen brought the gun into the bar. When confronted on this discrepancy, the Licensee said he misspoke, that Mr. McKen only brought the cell phone in. The Licensee stated he never saw Mr. Williams' arm himself.
9. That Detective Applegate reported that other witnesses say they saw Mr. Williams arm himself and that the Licensee was present at that time. When confronted with this, the Licensee said repeatedly, "I saw nothing. I heard nothing."
10. That the next morning, Detective Applegate spoke to the Licensee again who then identified "Pablo" as the second person involved in the shooting and admitted he heard the gunshots. He stated that he saw Mr. Williams follow Mr. Gayle and his friend out, then come back in and watched TV for a short time, and then go outside again. At that time the Licensee heard the gunshots.
11. That Detective Casper spoke to Matthew Spielvogel at the scene. According to Mr. Spielvogel he had never been to Jamaica Inn, nor did he know anyone involved. He stated he was driving by and witnessed the shooting. He drove off and came back and saw a cell phone by a body on the ground—the body of Mr. Williams. He took the cell phone and gave it to the first officer that he could, Officer Emenuelson
12. That on 9/7/08 at approximately 2:57 pm, Detective Petropoulos spoke to Ripton McKen, who at first indicated that he was not familiar with the people involved in the shooting. He stated he had heard some gunshots and then went outside and saw a man lying on the ground. After awhile, Mr. McKen acknowledged that he had not been accurate. He then stated after he heard the gunshots, he went outside and saw "Willie" was shot and lying on his back. A few inches away from Mr. Williams' hand, he observed a black revolver lying on the sidewalk. He picked up the gun, brought it into the bar and gave it to the bartender, "Raggedy" (Samuel Reid), and told him to call 911. He then left the scene. He stated he did not know if it was a "bar gun" or not, but gave it to the bartender so it did not "fall into the wrong hands." He indicated that he did not believe that the Licensee saw him hand over the gun.
13. That on 9/8/08 at approximately 7:05 am, Detective Casper spoke to Ripton McKen. This time, Mr. McKen stated that he had located a black .38 snub nose revolver and a cell phone next to the body of Mr. Williams. He stated he took both inside so that nothing

would happen to them and asked the Licensee to call 911. He did not call 911 from the cell phone because it was dead. He then gave the cell phone and revolver to the bartender, Samuel Reid, who placed them in a small room off the bar. He then left the scene. During the interview Mr. McKen identified a photo of a revolver recovered from the licensed premises and identified it as the revolver he found next to Mr. Williams' body.

14. That during a search of the licensed premises on the night of incident, Officer Brooks located a black .38 revolver on a shelf at the top of the basement stairs, six feet from the end of the bar, covered by a white T-shirt.

That the above-described conduct by the Licensee on the licensed premises amounts to the purposeful frustration of a homicide investigation in connection to the licensed premises. That the Licensee kept or maintained a disorderly or riotous, indecent or improper house contrary to Wisconsin statute. That the premises was operated in such a manner that it constituted a public nuisance, that the conduct on the licensed premises had a substantial adverse effect upon the health and safety on the immediate neighborhood, and that the continued operation of the licensed premises is not in the best interests and good order of the city as set forth in the Milwaukee Code of Ordinances. Therefore, the Chief of Police, by his designee, respectfully requests that the Class "B" Tavern License of Winston Brown for the premises known as Jamaica Inn, located at 3040 West Atkinson Avenue, Milwaukee, Wisconsin, be immediately revoked in the best interests and good order of the city.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 01/17/96 Officers conducted a check of the Jamaican Inn located at 3040 W. Atkinson Av. Upon entering the tavern Officers saw a patron drinking from a pint bottle of gin. On the scene was the bartender Leo Reid, and the Manager Carolyn Ward. Both were convicted in Municipal Court (Consumption from Bottle on Class 'B')
2. On 01/30/96 at 12:35AM Officers conducted a check of the Jamaican Inn located at 3040 W. Atkinson Av. Upon entering the tavern Officers found a 17 year old in possession of two 40oz bottles of beer. The bartender Leo Reid stated he did not sell the beer to him. The applicant was not on the scene and cited. The bartender was convicted in Municipal Court (Presence of Underage.)

Upon entering the tavern Officers found the licensee Winston Brown behind the bar. It was found that the subject who purchased this alcohol was 17 years old. The 17 year old was not able to identify the person who sold these items to him. The applicant was cited.

She stated that she bought a "go" cup of Canadian Mist from a Female bartender later identified as Carolyn Ward. The applicant was not on the scene. All cases dismissed in Municipal Court

6. On Friday, 08/17/96 at about 11:35PM Officers observed a subject enter the Jamica Inn located at 3040 W. Atkinson Av. About 5 minutes later this subject exited the tavern with a 45oz bottle of Colt 45 malt liquor, which he stated he purchased from a Female bartender. Upon entering the tavern the bartender (Theresa Smith) denied selling any beer to go after 9:00PM. The applicant licensee was not on the scene, and upon contacting him; he accused the Officer of fabricating the entire incident. The case against the bartender was dismissed. The applicant was also cited.

9. On 04/02/99 at 10:30PM an underage Police Aide entered the Jamaican Inn located at 3040 W. Atkinson Av. under the direction of Police Officers. The Police Aide purchased two bottles of beer from the Licensee (Winston Brown). The 19 year old Police Aide was not asked for identification.

10. On 12/11/2003 at 11:43pm, Milwaukee Police went to the Jamaica Inn, 3040 W Atkinson Ave. The main front entrance and exit was locked. After knocking at the locked door several times the officers were allowed inside by a patron. Ann Roberts-James was the manager of her brother's tavern. She stated she didn't know the door was locked. She was convicted in Municipal Court. The applicant was not on the scene or cited.
11. On 12/16/2003 at 10:50pm, Milwaukee Police observed a youthful appearing male exit the Jamaica Inn, 3040 W Atkinson Ave. The male was holding a half pint of Cognac Hennessy. He was 17 years old. He stated he asked an unknown adult male, in the tavern, to purchase the liquor for him. The unknown male could not be located. The manager, Ann M Roberts-James, stated that she had not seen the 17 yr old and that if she did, she would have put him out herself. The applicant was warned. Incident Report Filed.
12. On 3/31/2004 at 10:28pm, an underage Milwaukee Police Aide entered the Jamaica Inn, 3040 W Atkinson Ave. at the direction of Milwaukee Police Officers. The aide was able to obtain a ½ pint of Hennessy liquor from the applicant

13. On 5/5/2004 at 9:20pm an underage Milwaukee Police Aide entered the Jamaica Inn, 3040 W Atkinson Avenue at the direction of Milwaukee Police Officers. The aide was able to purchase a glass of gin with orange juice from the bartender, Ann M James-Roberts. Ms Roberts-James was cited, however the city attorney's office did not prosecute. Incident Report Filed. (Disposition added 05/17/2005)
14. On 06/03/04, at about 1:43 a.m., a patron was fatally shot shortly after leaving the premises. There was no incident on the premises prior to the shooting and no information is indicated connecting the operation of the premises to the shooting. Incident Report Filed

15. On 08/02/2004 at 9:11 PM officers made a lawful inspection of the licensed premises at 3040 W Atkinson Av. Officers discovered a jukebox in the tavern that did not have an Amusement Machine tag. The applicant, who was not in the scene was cited.

16. On 11/12/2004 at 10:45 PM an underage police-aide, under the direction of police officers purchased a bottle of rum and a bottle of vodka from Ann JAMES-ROBERTS. The applicant, who was not on the scene, was not cited. Ms JAMES-ROBERTS was convicted in Municipal Court.

17. On 10/22/07 at 12:50am, Milwaukee Police investigated an Armed Robbery and Recklessly Endangering Safety that occurred at the Jamaica Inn, 3040 W. Atkinson Ave. Detectives interviewed the victim who stated he had entered the bar and purchased some alcohol. As he exited the bar, the victim was approached by a male subject who stated "I got that bag", which the victim knew to mean he had marijuana. The victim walked over to where the subject was standing, and instead of showing him the marijuana the subject pulled out a pistol. The subject robbed the victim of jewelry and money. The victim stated his friends that he came with, now drove their vehicle closer to see what was going on and the subject fired 1 shot at them. The subject told the victim to run, and when he did so he fired 1 shot at him.

18. On 09/06/08 at 11:56 pm, Milwaukee police were dispatched to 3040 W Atkinson for a Shooting complaint. Investigation revealed that there was an altercation between one of the employees from the Jamaican Inn and one of the customers that resulted in both subjects being shot. The bartender on duty later identified as Aszett Williams, took a handgun from inside the tavern and followed a patron outside of the tavern. Once outside, Williams fired several shots at the patron striking him in the hip. The patron returned fire at Williams, striking Williams several times resulting in Williams death. The licensee, Winston Brown, was on the scene at the time of this incident and was uncooperative with police during the investigation of the shooting.

NARRATIVE SECTION:

This report is written by Detective Sharon Hess who is assigned to the Criminal Investigation Bureau, Squad 9122. On Saturday, 09/06/08 at 11:56 P.M., Milwaukee Police Department personnel were called to the Jamaican Inn (4030 W. Atkinson Avenue) regarding a shooting. Investigation revealed that there was an altercation between one of the employees from the Jamaican Inn and one of the customers that resulted in both subjects being shot. The bartender on duty, later identified as Aszett E. Williams (B/M 08/31/76), took a handgun from inside of the tavern and followed the customer, identified as Paul F. Gayle (B/M 01/01/69) outside. Once outside, it is believed that Williams fired several shots at Gayle resulting a gunshot wound to Gayle's hip. Gayle returned fire at Williams, striking Williams several times resulting in Williams' death.

During the investigation, Detective Delores Applegate interviewed the owner of the Jamaican Inn, Winston (NMN) Brown (B/M 08/10/43) of 7524 W. Medford Avenue, 464-7310. This interview took place at the Jamaican Inn immediately after this incident occurred. Winston informed Detective Applegate that he has owned this tavern since 1982 (3040 W. Atkinson Avenue, 442-2197). He identified the victim, Williams, as being a bartender at the tavern and stated that he has known Williams for three years and that Williams has bartended for him at the Jamaican Inn for the last two years.

Brown informed Detective Applegate that on the night of this incident, he opened the tavern for business at around 8:00 P.M. He stated that Williams was bartending on this evening and that at one point in the evening, Williams left the tavern for approximately 30 minutes. He stated that Williams returned to the tavern, standing near the end of the bar closest to the basement for approximately ten minutes, then left the tavern again. Brown stated that five to ten minutes later he heard four to five gunshots from outside the front door of the tavern.

Brown denied that there had been a handgun in the tavern prior to this incident occurring. During on-scene questioning, Brown stated that after this incident, a customer brought a cell phone in to the bar. As Detective Applegate continued to question Brown regarding the cell phone, Brown stated "He brought the gun into the bar." When confronted with this, Brown stated, "No, I meant to say the cell phone."

Other witnesses informed Milwaukee Police Detectives that the victim, who was the bartender working at the Jamaican Inn on the night of this incident, left the bar for a short time, came back in the tavern and armed himself with a gun that had been in the tavern before going back outside just before this incident occurred. Brown denied this. After being confronted with this information, Brown continually stated, "I saw nothing. I heard nothing."

Detective Thomas Casper interviewed Ripton H. McKen (B/M 04/16/55) of 8027 W. Brentwood Avenue, 791-2144. McKen had been a customer at the Jamaican Inn when this incident occurred. McKen stated that he had come out of the restroom in the tavern to see Williams walking out of the tavern in a hurry. He stated that within a few minutes after Williams left the tavern, he heard what he described as a barrage of gunshots fired just outside of the tavern. McKen stated that when the shots stopped, he went outside and observed Williams lying on his back on the sidewalk close to the front door of the tavern.

McKen stated that no one else was outside of the tavern at this time. He stated that there was a small dark revolver near the right hand of Williams. He also observed a cell phone near Williams' left hand. McKen stated that after checking Williams for a pulse, which he could not find and assumed Williams to be deceased, he picked up these items took them in the tavern.

McKen stated that once he was in the tavern, he gave the cell phone and revolver to Samuel Reid (B/M 02/05/46, 4918 W. Hampton Avenue #7, 419-9916) who was standing at the end of the bar. According to Brown, Reid has been employed by him at the Jamaican Inn for the last couple of years and specifically helped open the bar on the night this of this incident.

McKen further relayed that once he gave these items to Reid, Reid walked into a small room that he described as a kitchen. He stated he did not see exactly where Reid placed the items in this room.

Police Officer Matthew Brooks and Detective Tom Casper searched the tavern. Officer Brooks located a Taurus, 5-shot .38 caliber revolver on a shelf at the top of the basement stairs. This area is approximately six feet from the end of the bar. This revolver was covered with a white short sleeve t-shirt. In checking this revolver, it was found to contain five spent casings. These items were all placed on Milwaukee Police Department property Inventory 441635.

Detective Michael Sarenac interviewed Deandra M. Pirtle (B/F 03/16/71) of 4638-A N. 32nd Street. Pirtle was a customer at the Jamaican Inn at the time of this incident. Pirtle stated that while in the tavern, she had a short conversation with Paul Gayle. She stated that at one point, Gayle looked at Williams and stated, "I don't like that nigga." She stated that Gayle and two other customers then left the tavern.

Pirtle stated she then observed Williams go to the back of the bar when he stepped behind the curtain or storage area. When he came back out three to four seconds later, she saw that he was now tucking a handgun in his waistband area. Pirtle stated that five minutes later, as she got up to go to the rest room, she observed Williams as he was leaving the tavern. Pirtle stated that while she was in the rest room, she heard shots being fired. As she came out of the rest room, she heard more shots fired describing these shots as very close to the front door of the tavern. She stated she and three of her friends who were all in the tavern ran up the stairs to the upper unit apartment where they hid until the shots stopped.

It should be noted that when officers first arrived on scene, Police Officer Nicholas Federer observed Brown, the owner of the tavern, talking with Pirtle. When Officer Federer later approached Pirtle to interview her regarding this incident, Pirtle told her that while she was speaking with Brown, Brown told her to "don't say anything." Pirtle also informed Officer Federer that she knew the shooter as "Pablo" and stated that he is in the bar often. Pirtle further stated that she was scared due to the fact that Brown told her not to say anything.

The investigation of this incident was impeded due to false statements provided to Milwaukee Police Department personnel by Winston Brown, the owner of the Jamaican Inn. The action of Samuel Reid, an employee of the Jamaican Inn, hiding evidence relating to this incident, also obstructed the investigation. The homicide victim, Aszett E. Williams, who was bartending on the night of this incident, is believed to have fired the first shots at Paul F. Gayle, striking him once. Paul Gayle then returned fire, striking Williams.

NARRATIVE SECTION: This report is written by PO Jeffrey EMANUELSON, assigned to District Seven Late. On Friday 9-05-08 at 11:39pm, PO GALLOWAY and I, were dispatched to the area 4600 N 32nd St., to a shooting. Upon arrival Officers located the victim, Aszett E WILLIAMS, b/m 08/31/76, on the ground outside the Jamaican Inn, located at 3040 W Atkinson Av. WILLIAMS had no pulse and was not breathing. WILLIAMS had multiple gun shot wounds. The Homicide investigation incident number is 08-251-0020

I notified Squad 7311, Sgt QUINLAN, who was on scene and he advised CIB.

The following is Detective APPLGATE's interview of the owner of the Jamaican Inn, Winston BROWN, who was arrested for obstructing an Officer.

This report was dictated by Detective Dolores APPLGATE, assigned to the Criminal Investigation Bureau, Late Shift.

On Sunday, 09/07/08, at 12:13 a.m., while assigned to Squad 9385, I was dispatched to a shooting at N. 30th and W. Atkinson Avenue. Upon arrival, I was met by Squad 8902, Lieutenant Of Detectives Randolph OLSON, who instructed me to do witness interviews.

INTERVIEW OF WINSTON (NM) BROWN

Upon arrival I interviewed the bar owner, Winston (nm) BROWN, B/M, DOB 08/10/43, of 7524 W. Medford Avenue, phone #464-7310, owner of the Jamaican Inn located at 3040 West Atkinson Avenue, bar phone #442-2197. Mr. BROWN stated he has owned the bar since 1982, and the normal hours of operations are on weekdays, 7:00 p.m. until 1:00 a.m. and on weekends, 8:00 p.m. until 2:00 a.m.

Mr. BROWN stated he arrived at the Jamaican Inn on Saturday night, 09/06/08, at around 8:00 p.m. Mr. BROWN stated "Rogally" (phonetic), later identified as Samuel (nm) REID, B/M, DOB 02/05/46, of 4918 W. Hampton Avenue, Apartment #7, phone #419-9916, arrived to help open the bar at 8:00 p.m. Mr. BROWN stated "Rogally" (phonetic) has worked for him on and off for the last couple of years, and the victim, "Willie", later identified as Aszette E. WILLIAMS, B/M, DOB 08/31/76, of 4907 N. 60th st, phone number 414-462-3879, arrived to help open the bar at around 9:00 p.m. Mr. BROWN stated the victim, "Willie", had been a bartender for the last two years, and he has known "Willie" for the last three years.

Mr. BROWN stated at the time of the shooting, the only people in the bar were himself, "Willie", "Rogally" (phonetic), and four females. Mr. BROWN stated the victim left and walked outside of the bar for approximately 30 minutes. He stated the jukebox was playing, and the television was on, so it was hard to hear anything going on outside. Mr. BROWN stated that "Willie" came back inside the bar and stood near the end of the bar closer to the basement for approximately 10 minutes. Mr. BROWN stated "Willie" then left the bar, and about 5 to 10 minutes later, he heard four to five gunshots coming from just outside the front door.

Mr. BROWN stated he got up from behind the bar and went to the stairwell to call up to his son, Charles BROWN, B/M, DOB 05/28/69, cell phone #416-2603, who lived in the upper above the bar. Mr. BROWN stated a patron, "Ripton", went outside after the shots fired and came back into the bar and gave the owner the victim's cell phone, which was on the ground near the victim.

Officers discovered a black, Taurus, .38 caliber revolver hidden under a white T-shirt in the bar at the top of the basement steps on a ledge. When I questioned the owner of the bar, Mr. BROWN, he stated he doesn't own a gun, and he does not have a bar gun on the premises. I continued to question Mr. BROWN regarding "Ripton" bringing the cell phone into the bar, and he stated, "He brought the gun into the bar." I questioned the bar owner, Mr. BROWN, regarding that statement, and he stated, "No, I meant to say the cell phone." Mr. BROWN stated that during the incident, he was behind the bar and afterwards came out from behind the bar and called up to his son who lived in the upper of the bar.

Witnesses on the scene told other Detectives that the victim came into the bar and armed himself with a gun and went outside. Those patrons observed the victim inside of the bar arming himself with the revolver, and the owner, Mr. BROWN, denied seeing any pistol even though the witnesses stated that he was there when he armed himself. The owner of the bar stated over and over, "I saw nothing." "I heard nothing." after being confronted about other witnesses in the bar, which were relaying a different story to the other Detectives. Mr. BROWN was taken into custody at 1:39 a.m. for Resisting/Obstructing and conveyed downtown to the Police Administration Building, PPS.

While on the scene, at the Jamaican Inn, I was able to obtain a VCR, video surveillance tape, but was informed that the video recorder does not work, and tonight's incident was not captured on video. The video surveillance tape, which I retrieved from the VCR at the Jamaican Inn was transported down to the Criminal Investigation Bureau, and placed on Milwaukee Police Department Inventory #441602 as item #1. I watched the video surveillance tape and observed that the

content was old and did not capture the incident, which had occurred on Saturday, 09/06/08, at 11:35 p.m. The tape was then transported down to District #1 and turned over to the Desk Sergeant.

On Sunday, 09/07/08, at 7:56 a.m., I brought Winston (nm) BROWN, B/M, DOB 08/10/43, 7524 W. Medford Avenue, phone #464-7310, down to the Criminal Investigation Bureau from PPS Bullpen and placed him in Room 421. I started the interview at 8:03 a.m. and spoke to Mr. BROWN regarding the incident, which had occurred the evening before.

Mr. BROWN stated that he opened the Jamaican Inn between 8:00 p.m. and 8:30 p.m. with "Rogally" (phonetic). Mr. BROWN stated that "Willie" showed up at around 9:00 p.m. to bartend, and the two of them bartered together. Mr. BROWN stated that the suspect, Pablo, who was a Jamaican male, in his early 40s, 5' tall, skinny build, with dreads or braids, and was a regular customer, came into the bar with a friend, who Mr. BROWN described as an unknown, B/M, 29 to 30 years of age, 5'10 to 5'11, 215 lbs., dark complected, clean shaven, having short, black hair, and dark clothing.

Mr. BROWN stated he was serving other customers, who sat closer to the television and Willie waited on Pablo and the unknown, B/M at the other end of the bar. Mr. BROWN stated Pablo ordered a Heineken beer in a green bottle, and his friend ordered an unknown beer. Mr. BROWN stated Pablo and his friend were in the bar for approximately 15 minutes and then left. He stated that he couldn't see from where he was standing, behind the bar, where the two suspects had fled, but remembered "Willie" followed them outside. Mr. BROWN stated he didn't hear any arguing or exchange of words and that "Willie" had been gone approximately 15 to 30 minutes.

Mr. BROWN stated "Willie" returned and stood at the end of the bar watching television. Mr. BROWN stated the big, wooden door that secured his bar was opened, and the screen door was locked. Again, Mr. BROWN stated that he didn't hear or see anything, but observed "Willie" leave again for a second time, and shortly afterwards heard four to five gunshots. Mr. BROWN stated the four, female patrons in the bar got up and ran upstairs by Charles residence, but he didn't let them in. He stated he was too afraid to allow them in. Mr. BROWN stated that a patron of the bar by the name of "Ripton", who he described as a B/M, 40 to 45 years of age, 5'10, 160 lbs., skinny build, with short, black hair, dark clothing, and a button down, collar shirt, gray in color, with blue jeans, had come into the bar right after the owner had opened the bar and was a regular customer.

After the shots were fired, "Ripton" ran outside and saw "Willie" on the ground. "Ripton" ran back inside the bar and told the bar owner, "Pablo just shot "Willie"." "Ripton" then brought in the victim's cell phone, which he found on the ground and gave it to the owner, who put it on the bar. "Willie" stated he walked over to the door where he observed a man that he does not know, later identified as Paul L. MASON, B/M, DOB 03/21/82, of 4632 N. 29th Street, went out by the victim and was holding the victim, stating, "Don't die man!" "Don't die man!" The owner observed Paul MASON cradling "Willie" until the fire department arrived and was never back inside of the bar that evening.

Mr. BROWN stated that while "Willie" was bartending, three, Jamaican men had walked in and were hanging out drinking until they moved onto the next bar.

It should be noted that when I questioned Mr. BROWN about previous altercations, he stated Pablo and "Willie" had gotten into it on Friday night at around 11:00 p.m. to 12:00 a.m. He stated Pablo came inside of the bar and was trying to purchase beer, and threw his money down on the bar. He stated he knew that there was an argument between "Willie's" wife and Pablo over some kind of driving issue, but he didn't get into it, and when Pablo and "Willie" were inside of the bar arguing, he kicked him out and told him to take it elsewhere.

Mr. BROWN stated there are no bar guns. He stated he has never seen "Willie" with a gun before and swears on his mother's grave he didn't see a gun. Mr. BROWN stated Pablo has been seen with a gun in the bar before on a couple, different occasions. He stated in January 2007, Pablo had brought a gun into the bar. Mr. BROWN stated Pablo would usually leave the gun in the car, and he owned it, so he could scare people. Mr. BROWN stated he told Pablo, "I don't like what you're doing." "Don't bring it into this neighborhood." "Don't bring it into this bar." "This was a nice, neighborhood bar."

Mr. BROWN sat in front of a mug book to help identify a possible witness by the name of "Ripton." Mr. BROWN was able to identify the individual, who was in the bar the night of the shooting, and identified a Ripton H. MCKEN, B/M, DOB 04/16/55, of 3210 West Cameron Avenue, B of I #349157. I had Lieutenant Of Detectives Randy OLSON administratively release Mr. BROWN and ordered him into the District Attorney's office for Tuesday, September 23, 2008, regarding the Obstructing.

This concluded my interview with the bar owner.
