You have asked me to advise you as to our perception of the conduct of City of Milwaukee Police Officer Denise Clark on May 26, 2003.

On May 26, 2003, Police Officer Denise Clark assisted in conveying Rodric Stewart, d.o.b. 11-30-1976, to the Froedtert Hospital. At a point when Mr. Stewart was about to be scanned by a diagnostic machine at the hospital, he attempted to seize the firearm being carried in her holster by Officer Clark. In the ensuing struggle, Officer Clark discharged her firearm, injuring her own finger.

I have reviewed this matter with the medical technician who witnessed the incident, and Assistant District Attorney Thomas Potter, who is prosecuting Mr. Stewart, has reviewed the matter with Officer Clark. I am satisfied that Officer Clark committed no criminal offense, and Mr. Potter is of the opinion that she conducted herself in an heroic manner.
