
This office is in receipt of your claim in the amount of \$756.42, relating to damage sustained to your vehicle on June 11, 2003 where you allege it was struck by a City vehicle at 7424 West Appleton Avenue.

Our investigation reveals that the Fleet Division has no records relative to your vehicle damage allegedly caused by a City vehicle. Since no City driver has reported colliding with your vehicle, and you are unable to provide any information with respect to a City vehicle identification or license plate number, we are unable to verify a City vehicle was involved. As such, the City cannot accept liability. Accordingly, we are denying your claim.
