There is a possibility that your application may be denied for one or more of the following reater the recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Police spoke with the cashier Jagpreet Randhawa who had a temporary operator's license. Randhawa was asked to provide invoices regarding tobacco products and Randhawa could not. Contact was made with Mamta Singh, who could not respond to the scene because she was out of town. Agent King recovered various tobacco products inside a PF Chang bag in which Randhawa told officers that his lunch was in the bag. Agent King confiscated the products.

4. On 09/20/2014 a 17 year old, working in conjunction with Milwaukee police, was able to purchase a 3 pack of Jackpot brand cigars from the cashier at 4028 West Lisbon (Guru Foods). The applicant was cited.

Lisbon Av. The clerk was identified as F.N.U. HALIMGUL. He stated that he did check the ID but was confused by it and couldn't find her birthdate. The applicant was mailed a MARTS letter. As of 01/19/2018 the applicant had not enrolled in the program and was issued a citation for this offense.

6. On 05/19/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a Mango Swisher Sweet cigar from the clerk at Guru Foods, 4028 W. Lisbon Av. The clerk was identified as Halim Gul HALIMEY. He recalled the sale but believed the subject was 18 because he was born in the year 2000. The applicant was mailed a MARTS letter.

7. On 07/18/2018 at 8:38am officers were dispatched to an Entry at Guru Foods, 4028 W. Lisbon Av. The officers spoke with the applicant who stated that someone damaged her front door sometime overnight. The applicant stated that no one got inside because the alarm did not go off.

8. As of 01/30/2019 the applicant had enrolled in the MARTS program regarding Item #6 but failed a Mystery shopper check on 10/15/2018. The applicant was issued a citation for the 05/19/2018 violation.

- 9. On 11/08/2019 at 7:59pm officers were dispatched to a Subject with Weapon at 4028 W. Lisbon Av. The officer spoke with a security guard, who stated he had kicked out a juvenile earlier in the day. He stated he observed the juvenile coming back with several family members. The guard attempted to close the door but a subject got an arm in the door and discharged pepper spray. No citations were issued.
- 10. On 04/10/2020 at 7:38pm officers were dispatched to a Trouble with Subject complaint at 4028 W. Lisbon Av. The officers spoke with the clerk, who stated he was having problems with two subjects at the store. The subjects were advised to not return to the store.

11.10/18/20 at 8:00pm, officers were dispatched to an Armed Robbery complaint, at 4028 W. Lisbon Av. The officer spoke with the victim who he parked his car and while he was still seated in his vehicle, the suspect made verbal contact with him. The victim assumed the suspect was intoxicated, exited his vehicle and began to walk to the entrance of the store, when the suspect appeared and displayed a black firearm and demanded victim's keys and money. The suspect then fled in the victim's vehicle. The employees were cooperative and allowed officers to observe video surveillance of the incident.

- 12. On 07/27/21 at 12:58am, Milwaukee Police were dispatched to 4028 W. Lisbon Avenue for an entry complaint. Investigation revealed that a subject tried to pry open the back door but was unsuccessful at gaining entry to the business. The subject matched the description of the person who burglarized his business in June of 2021.
- 13. On 07/27/21 at 2:26am, Milwaukee Police were dispatched to 4028 W. Lisbon Avenue for an entry compliant. Investigation revealed that the same person who tried to gain entry in Item #12 was successful in entering the establishment on this 2nd attempt and took merchandise from the store. The subject did enter the building through the same rear door he tried to pry open the first time.
- 14. On 11/22/21 at 8:03pm, Milwaukee Police were dispatched to 4028 W. Lisbon Avenue for an armed robbery complaint. Investigation revealed that a subject picked up two prostitutes, drove them to the filling station at that address, and attempted to retrieve money from the ATM inside the business. While retrieving the money from the ATM, one of the prostitutes distracted the subject while the other one took his money from the ATM. Both prostitutes fled the scene and the subject called police.

15. On 05/25/22 at 11:39am, Milwaukee Police were dispatched to 4028 W. Lisbon Avenue for a
robbery compliant. The incident did not occur on the premise and the business was not
involved in the incident which turned out to a baseless complaint.

16. On 10/25/23 at 10:23p.m., Milwaukee Police were dispatched to a Threat at 4028 W. Lisbon Av. Officers were advised a subject entered the store, scaled the glass divider and stole a tobacco product. The business was cooperative with the investigation.

The following items pertain to Guru Food located at 4028 W. Lisbon Ave.

- 17. On 01/26/25, at 4:31 a.m., officers were dispatched to an Entry complaint. During hours the business was closed an unknown suspect broke the entrance glass door, entered the property, and stole various tobacco items and other merchandise estimated at \$2,000.00. Security camera footage was available of the incident.
- 18. On 05/03/25, at 6:40 p.m., Milwaukee Police received a Battery complaint. A subject attempting to steal merchandise knocked over the victim causing injuries. Medical attention was received by Milwaukee Fire Department and no other police services were taken.
- 19. On 06/22/25, at 4:44 p.m., officers were dispatched to a Theft complaint. Two subjects were confronted by an employee after they grabbed several items attempting to steal. Both subjects dropped the items and fled from the business. The employee was not able to access the camera system.
- 20. On 07/21/25, at 12:38 p.m., Officers were dispatched to a Property complaint. An unknown subject entered the business and knocked items off shelves causing damage. Security camera footage was available of the incident and the employee was cooperative.

This report is written by P.O. Joseph MACK assigned to District 3, Squad 3320, Late Shift, along with P.O. Aaron BOSTON. P.O. BOSTON and I were in full duty uniform equipped with an Axon body worn camera activated and in a marked squad vehicle.

On Sunday, January 26, 2025, at approximately 4:31 am P.O. BOSTON and I were dispatched to an entry in progress at Guru Foods 4028 W Lisbon Ave.

Upon arrival, we observed the front glass door to be broken and shattered. P.O. BOSTON and I were able to gain entry through this broken glass door and cleared the business. No subjects were located inside. Inside of the store I observed one of the cooler doors open with multiple cans of beer on the ground in front of it. The counter in front of where the cash register would be had scattered electronic accessories, such as phone chargers, and miscellaneous tobacco products. The cash register was located on the floor behind the service counter still locked and unopened. The atm inside the location was not damaged or disturbed.

The caller/owner/licensed premise agent, Mamta SINGH (A/F, 8-16-1962), was contacted and stated she received an alarm motion alert that someone was inside of her store. SINGH said she pulled her live view of the cameras and saw a subject inside behind the service counter. While watching it live, SINGH stated she only watched for a short time and the description she remembered as a male subject, approximately 6'0", medium build with a dark winter hat and light-colored jacket. SINGH could not see the subjects face or if he was wearing gloves. SINGH said she immediately called the police and started to drive to the store.

When SINGH went inside, she estimated \$2000.00 worth of various tobacco products were taken, along with some beer and lottery tickets. SINGH will have to review video inside the store to determine full loss. There are a total of 11 cameras within the store and outside of the business.

The business was cooperative with the investigation. The business does not have security officers on scene.

Suspect #3 description: Male, wearing a light-colored jacket, black pants

4:25:22- I observed suspect #1 breaking the entrance door with an object.

4:26:19- I observed suspects #1 and #2 enter the store.

4:27:13- I observed suspect #2 grab cases of beer and walked it to the front entrance. I observed suspect #1 attempting to break the glass to the cash register counter.

4:27:23- I observed suspect #1 enter through the cash register glass and began throwing merchandise over the counter, while suspect #2 grabs the merchandise and began filling it up in a bag.

4:28:26- I observed suspect #1 throw a container full of merchandise over the counter while suspect #2 picks up the container full of merchandise and places it at the front entrance.

4:28:26- I observed suspect #3 walked to the entrance door from outside, picks up merchandise and walked Northbound.

4:28:35- I observed suspects #1 and #2 exit the store.

While on scene, I observed the licenses posted and they were up to date. During my investigation for this entry in progress I did not observe any violations in the licensed premise.

This location is Guru Food LLC which is a convenience store.

Upon our arrival we observed product, chips and snacks, scattered onto the floor of the convenience store. We also observed a wet floor from the owner mopping pickle juice off the floor from the unknown subject knocking over a pickle jar.

I spoke to the caller, and licensed premise owner, Raghwinder SINGH(W/M 5-20-57) who called from 414 -208-5093. SINGH stated an unknown B/M came into the store and destroyed property. The subject was knocking over displays, which caused product to fall onto the floor with the displays. The subject also knocked product off the shelves. SINGH stated the subject alos knocked over a large pickle jar which caused pickle juice to spill onto the floor. By our arrival time, SINGH cleaned up the pickle juice and mopped the floor. We still observed some product, bags of chips, etc. on the floor.

There were no other witnesses to this incident.


