To The Elected and Appointed Representatives:

As a resident of the State of Wisconsin, born and bred in Milwaukee, and representative of the 5 Points area along with Dr. Nicole Robinson, Fatima Laster, Shear Winston, President Samuel Sims and a multitude of others write for the "push pause and halt" initiatives, zoning, etc of GrowMKE, RT5, ADU, RT4 etc. We are opposed to passage of the same in the April 15, 2025 zoning committee meeting.

First, allow me a moment to state that our goals are to ensure beautification along with salvation. The very persons who built this city and made it great are at stake for erasure across America and the State of Wisconsin. The ails of the community are woven into the fabric of the city. It appears that a failure to address the ills with current residents is fine based upon the movements and policies we see in practice. With this in mind, the 175 and more protections are designed to ensure that "honest and real" quality of life, liberty, and the pursuit of happiness abound for the least of them to the greatest.

As a result the attached presentation is scheduled for tonight. During the meeting at the CPC on Tuesday, April 8th, 2025, a widespread invite was issued for Alders, County, and Representatives and the like. In lieu of any and all passages of zoning, building, variances, etc... These protections are created for community and representative study before committee meetings. To date, we have reviewed our signed up attendance list and are identifying any and all key players on city development, zoning, financing, office of administration, and office of african american affairs. It is of utmost importance that all dollars, planning, and building take into account what appears to be the very minimal portion of residents' lives.

With this in mind, this letter is created for filing, reading, and issue to any and all parties that are touched by any portion of Repair MKE, GrowMKE, BuildMKE, Transportation MKE county, fundingMKE, festivals MKE, streetsmke, safetymke, any and all that impact residents lives.

- 1) postpone today's hearing of the CPC immediately and within a few minutes of the start.
- 2) recall former passage on April 8, 2025---Alders, community member, etc...schedule several meetings
- 3)GrowMKE submit results and attendance records
- 4) all communication files are shared with those who are in constant attendance and represent groups

- 5) Alders and other Representatives of the City, County, and State provide input on the plans, funding, etc and host community meetings in person and virtual that address these matters
- 6) City, County, and State Representatives read and implement protections
- 7) Assessor's office attendance and input
- 8) Quality and impactful dollars are allotted for tax increases, insurance rebates for homeowners, and a comprehensive state, county, and city plan is submitted
- 9) Way, means and measure along with variances are discussed and strategized
- 10) Public television, newspaper and radio presentations are held
- 11) Attendance and inclusion of the protections

This list is not exhaustive but begins to point out that passage of many of the practices and policies impact the lives of current residents and future as well as those who work to enhance the city by providing strong stable neighborhoods.

On behalf of the residents, President, and others in 5 Points equalling a total of more than 450 persons (collaborative members and those who align themselves with 5 points mission). This includes a panel of persons who research gentrification and its effects. We are in opposition of the passage of these measures today and urge this along with attendance tonight at the Protections meeting as attached.
