Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffit, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

The restaurant on 6th and Hayes, La Casa del Chivolin, has been a major problem for the area.

People are regularly overserved there and we've witnessed multiple people drive very drunk away from the restaurant. People regularly go in their cars to sleep off being drunk, often with the car running and playing loud music. This is not just a summer issue either, it happens regularly in winter.

There's an empty lot next door that the employees park in (no big deal) except that employees regularly pee in it, no idea if they follow safeserve guidelines when coming back in. It turns into an ice rink with people parking there in the winter and we've almost had people drive into our cars trying to gun it to get out of the ice.

Loud music and motorcycle clubs are regularly meeting in their tiny parking lot and disrupting late night hours for the neighborhood.

The garbage is a problem all on its own - they produce a lot (it's a restaurant, sure), but they never close it and the stench of rotting food pervades the area, as well as tons of birds picking through it and throwing it around. This is something I've addressed with the restaurant and have been waved away. The grease disposal is also similarly regularly left open and has attracted rats.

Glass has been regularly left around in the alley from bottles that then get shattered and are left to the residents to clean up. The restaurant seems to have no desire for their employees to do any kind of upkeep to make sure glass isn't everywhere.

Last night, after serving people, a huge fight broke out outside and culminated with someone ramming their car into someone else's, then the person in the car getting dragged out and beaten pretty severely. This is not the first, or even 5th or 6th time we've seen such an altercation there.




Please help any way you can - with enforcement or however it works, this situation very much needs to change.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/06/2020 officers, along with agents from Wisconsin Department of Revenue, conducted a license premise check at La Casa del Chivolin, 2423 S 6th St. regarding the location operating without licenses. The officer checked LIRA and confirmed the business had applied for licenses but they had not been issued yet. The Wisconsin Department of Revenue agent found the door locked. The agent knocked on the door and placed a to-go food order with the subject that opened the door. He also asked to include beer but was advised they did not have a license for alcohol. The agent was called by phone when the order was ready. The officer and agents entered the business and spoke with the clerk, who stated the business had been operating for about 2-3 weeks for takeout orders. The officers attempted to call the applicant but spoke with his business partner, who admitted to operating without licenses. The applicant was mailed a citation.

On March 19th, 2025 while assigned to Squad 2351 with PO Julius TORRES we were dispatched to an Entry call for service at 2423 S 6th St., La Casa Del Chivolin Restaurant. Which is located in the City and County of Milwaukee, WI.

Upon arrival we were met by the owner Luis ALVAREZ (W/M 12/20/94) who was waiting for officers outside of the dispatched location. ALVAREZ stated that someone had broken the northside window of his restaurant with a rock and gained entry. ALVAREZ stated his motion sensor cameras notified him that someone had gained entry into the restaurant at 4:31:12am. Upon arrival officers cleared the restaurant, ALVAREZ walked through and stated a cash register with \$278 was taken from the restaurant. A second register that was empty was damaged and left behind. Video footage depicts the suspect to be a W/M, Heavy set, beard, wearing gloves, gray/white hooded sweater, black jeans, and black shoes.

The hearing before the Licenses Committee will take place on 4/29/2025 at 11:05 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
