Lost Revenue: Parking Meters Removal

3 meters on the north side of Wells Street

28 meters on both sides of Market Street

4 meters on south side of Kilbourn Avenue

7 meters on east side of Water Street

Total Lost Revenue from DPW Parking Fund **\$229,320**

(42 meters x \$7/day x 5 days/wk. X 52 wks./yr. X 3 years = \$229,320)

Gained Revenue: Lane Closures and Meter Fee

Parking meter fee for removing 16 meters \$ 640

252 feet of parking lane & side walk closure-Market Street \$37,368

146 feet of parking lane & side walk closure-Kilbourn Avenue \$39,528

285 feet of parking lane & side walk closure-Water Street \$77,328

60 feet of traffic lane closure-Wells Street \$16,848

Total Gained Revenue to City's General Fund **\$171,712**
