4. On 05/16/2015 Milwaukee police responded to 1432 West Locust Street (Locust Quick Mart) to check for a shooting scene. The victim told officers he had been shot after an altercation. Officers discovered two casings in front of the location. The clerk, Pavan Surapuneti, told officers he heard a loud noise around 2:30am, but he was not sure if it was a gunshot. Milwaukee police incident report #151360032 filed.

5. On 09/02/2015 Milwaukee police responded to 1432 West Locust Street regarding a battery. Video obtained from the business depicts a female being assaulted outside the business. This incident was recently publicized on YouTube, but was never reported to the police by the business, the victim or any additional witness's.

7. On 08/04/18 a 16 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco Initiative was able to purchase a 2 pack Mango Swisher Sweet Cigars at 1432 W. Locust Av. The clerk admitted to the selling the item and the station was mailed a MARTS enrollment packet.

8. On 09/11/2019 at 4:18am officers were dispatched to a Shots Fired complaint at N. 14<sup>th</sup> St and W. Locust St. While on scene they were flagged down by the clerk of the Locust Gas and Food Mart, who stated the shooting occurred on their property. While on scene the officers were advised there were shooting victims at Mt Sinai from this location. The applicant arrived on scene and provided the officer with the video surveillance, which did capture the incident. The video showed the victims parked in the lot for about 15 minutes prior to the shooting. It showed multiple people approach the auto. It also showed the suspects approach on W. locust St and fire at the car from a distance. The clerk and applicant were cooperative.

9. On 05/09/20 at 9:25pm, Milwaukee Police were dispatched to 1432 W. Locust Avenue for a theft complaint. Upon arrival, officers interviewed the caller who stated that she put \$20 into an amusement machine, at 9:00am, to charge her phone and play video games. When she left the location, she forgot to retrieve the remaining balance from the machine. At 9:20pm, she went back into the establishment and was told there was no refund ticket. The clerk stated that that a refund ticket would usually print out, but that ticket was not in the cash drawer. The clerk told the caller she would have to come back in the morning and talk to the employee who was working at the time.

10	). On 05/12/20 at 10:04am, Milwaukee Police conducted a license premise check at 1432 W.
	Locust Street. Upon entering the store, officers observed 2 entertainment machines on the
	east wall of the filling station which were turned off and a sign saying, "out of order". The
	employee stated that the machines were "out of order" because of the safer at home order and
	he did not want customers to gather inside the establishment. The employee was told that he
	needed a Public Entertainment License to operate the machines and that they were for
	entertainment purposes only. The employee understood and would inform the applicant.

- 11. On 11/18/20 at 3:41am, Milwaukee Police were dispatched to 1432 W. Locust Avenue for a property damage complaint. Officers spoke with the store clerk who gave officers the agent information. Officers spoke with the agent who was able to provided video access regarding the incident. The business was cooperative with police during the investigation.
- 12. On 03/22/21 at 12:55 pm, Milwaukee Police conducted a license premise check at 1432 W. Locust St. Officers spoke with the owner regarding his interest for being a standing complainant for Loitering/Trespassing violations. The owner agreed and filled the complaint forms, which allow police to enforce loitering/trespassing ordinances on the premise. The agent was then provided with No Loitering No Trespassing signs to display around the business.
- 13. On 04/20/21 at 9:00am, Milwaukee Police conducted a license premise check at 1432 W. Locust St. Officers observed that the location had one amusement video gambling machine operating within the location. Officers looked over the listed city licenses and it was discovered the business did not have a Public Entertainment License for the machine. Officers spoke with the agent on scene and were shown proof of an application for the license. The agent was advised to have the machine unplugged and not operating until the city grants the license approval. The agent was cooperative, unplugged the machine and stated that he would wait for his license.

14. On 09/07/2021 at 1:18pm officers were dispatched to a Shooting at Locust Quik Mart, 1432 W. Locust St. The officers interviewed the clerk, who allowed the officers to view video of the incident. The video showed a vehicle on the street firing at a group of people on the lot. The vehicle then fled westbound on Locust.

15. On 11/19/2021 at 1:28am officers were dispatched to a Shotspotter at 1432 W. Locust St. The officers interviewed the clerk, who stated he heard several shots but did not see the suspects. The business had video but the room where it was located is locked until 7:00am. The business had security but he took cover when he heard the shots fired.

- 16. On 03/18/22 at 11:23pm, Milwaukee Police Detectives were conducting a follow up investigation for video surveillance at 1432 W Locust St. While in the gas station an unknown suspect fired one shot into the occupied gas station. No physical injuries occurred but there was damage to the building. The business was cooperative with the investigation and provided a copy.
- 17. On 04/20/22 at 12:01am, officers were dispatched to 1432 W. Locust St, for an armed robbery. Officers spoke with the victim who stated that his car was taken by suspects at gun point. The victim stated that the suspects pulled along his vehicle and ordered him out at gun point. The suspects fled the location in the victim's vehicle. Investigators reviewed video but the robbery was not captured on video. The video did provide suspect, and vehicle descriptions.
- 18. On 06/25/22 at 12:00pm, officers of District Five presented a Nuisance Designation letter to the agent of the business address of 1432 W. Locust St. (2 firearms related incidents within a year: Shots Fired and Armed Robbery)
- 19. On 01/30/23 at 10:33 pm officers were dispatched to 3154 N. 11<sup>th</sup> St., for an armed robbery complaint. The investigation revealed a carjacking occurred at 1432 W Locust St. The victim was forced out of their vehicle at gun point, and their vehicle was taken by the suspect. Investigators conducted follow up at the business which captured the incident on video surveillance, and obtained a video copy of the incident.
- 20. On 05/08/23 at 6:29pm, officers were dispatched to 1432 W. Locust St, for a child abuse complaint. Officers spoke with the employee who stated that juveniles stole from the location several times throughout the day. The employee chased the suspects out of the business armed with a plastic bat, in attempt that the suspects would not return. During the chase one of the suspects fell outside the location. The business provided video of the incident.
- 21.On 06/10/23 at 12:05am, officers were dispatched to 1432 W. Locust St, for a threat complaint. Officers spoke with the caller, who stated that the clerk did not give him an item he paid for. Officers reviewed video and the matter was resolved by both parties.
- 22. On 07/16/23 at 8:48pm, officers were dispatched to 1432 W. Locust St, for a subject with gun complaint. Officers spoke with the clerk who stated that the suspect pointed two guns at him and threatened to shoot him outside. The clerk stated that the suspect became irate over not having enough money for a soda. Officers reviewed video which showed the incident.
- 23. On 11/11/23 at 11:00am, officers while working with Wisconsin WINS Youth Prevention, conducted a compliance check at 1432 W. Locust St. The underage buyer was allowed to purchase a tobacco product from the business. The officer spoke with the clerk who stated he did not sell to a minor. The agent was advised of the incident.

This report is being submitted by PO David LETTEER, assigned to District 5 Day Shift.

I am submitting this report based on the events related to the visit of the detectives at the gas station on the day of the incident.

On Saturday, March 19, 2022, Detectives Adrian GUTIERREZ (Squad 9337) and Letitia HOLLOWAY (Squad 9339) were dispatched to a shots fired complaint at 1432 W. Locust St. (in the City and County of Milwaukee, WI).

Detectives Casey DONAHUE (Squad 9244) and Jonathan BOHN (Squad 9240) were on scene and conducting a follow up investigation for video for a different incident. and stated they were inside the gas station at 1432 W. Locust St. when they both heard one shot fired from outside the gas station. The gas station attendant Shandeep SiNGH (m/w, 05-03-99) was also present and inside the gas station during this incident.

Detective GUTIERREZ and Detective HOLLOWAY viewed video surveillance from the gas station that depicted a red 4 door older model vehicle with major damage to the rear passenger side door enter the lot of the gas station on Tuesday, 03-18-22 at 11:23PM. An unknown subject matching the following description exited the vehicle and walked towards the gas station: Black male, dark brown complexion, wearing glasses, a face mask, a dark colored jacket with an unknown light colored symbol on the left upper arm sleeve and the hood up, a white shirt, stone washed jeans, and dark shoes with white sole.

The unknown male subject stopped in front of the window of the gas station and looked inside. The unknown subject returned to the above listed vehicle and entered the passenger seat. An unknown subject is seen moving from the passenger seat to the driver seat while remaining in the vehicle. This vehicle then drove west and exited the parking lot.

An unknown male subject matching the above description returned to the location and stood at the southwest corner of the gas station as he continuously looked around this corner towards the entry door of the gas station.

Two male subjects exited the gas station and walked east in the parking lot towards their vehicle. At this time, the unknown male subject observed these subjects and then discharged a firearm towards their direction and striking the west wall of the gas station while occupied by Detectives DONAHUE, BOHN, and SINGH. This was done intentionally and without consent causing the occupants of the gas station to fear for their safety.

A copy was provided.

Detective GUTIERREZ interviewed Terry T. PHINISEE (m/b, 06-03-76) who stated he observed an unknown black male subject 20-30 yoa, wearing a black mask, black jacket, and jeans running northbound from 1432 W. Locust St. just after PHINISEE heard one gunshot. PHINISEE observed this

subject attempting conceal an unknown object in his waistband while running. PHINISEE observed this subject enter into the rear passenger of a dark color sedan, which was parked, on W. Groeling Ave at N. Teutonia Ave. facing eastbound. PHINISEE stated that upon the unknown subject's entry into the vehicle, the vehicle fled eastbound at a high rate of speed.

A casing was recovered in the parking lot. No injuries occurred.

The victim later identified as Terry HAMPTON JR (B/M 10-04-2002) walked into District #5 to report he was robbed at gunpoint at the gas station located at 1432 W Locust St between 11:20pm and 11:30pm on April 19th, 2022.

HAMPTON stated he pulled up to the gas station, a gray Hyundai Elantra pulled up next to his vehicle. Two subjects exited the vehicle and ordered him out of his vehicle at gunpoint and then took his vehicle.

S1 was described as a dark-skinned B/M, wearing all black clothing, thin build, about 6 feet tall. S2 was described as a light skinned B/M, thin build, about 6 feet tall, armed with a black AR-15 style pistol.

HAMPTON stated the only item of value in the vehicle was a white Iphone XR without case.

The vehicle is a 2005 Buick Rendezvous, no plates, Vin #3G5DB03735S530829, Navy blue upper over tan lower in color.

Acting D5 Lt, Sgt Franco was notified of this incident.

CIB Lt. Captain was notified, CIB is responding.

Det Zachary JOHNSON took over the investigation.

Squad 5330 went to the incident location to look at the surveillance video, however, the clerk stated the computer system is password protected. According to the clerk, the owner would be in around 9:00am.

Detectives returned on a later date and reviewed the footage. The footage captured the victim on the premises along with two subjects matching the description of the suspects, but the robbery is not observed on video.

Comment: CLR NOT ANSWERING TC QUESTIONS AND DISCONNECTED

SCENE DESCRIPTION- The premise is a gas station on the north east corner of N Teutonia Ave and W Locust St. The front entrance door is on the south side of the location. There are four gas pumps on in front of the entrance door of the premise and four gas pumps on the west side of the premise. As you enter the premise the cashier is to the west with bullet proof glass separating the employee from the customers. The middle of the premise is where the bulk of the merchandise is located and on the east side inside of the premise are the refrigerators.

#### INITIAL INVESTIGATION-

Upon arrival, I spoke with subject who was identified as Parveen KUMAR (M/W, DOB 04/12/1994) who stated he is the cashier at the location. KUMAR stated that a customer came to the location and attempted to purchase a soda. KUMAR stated the subject wanted to pay \$1.00 for the soda and he told the subject "no, the price of the soda is \$1.75". KUMAR stated the subject became upset and started yelling at him. KUMAR stated the subject stated that he will kill him as he retrieved two firearms from his person and pointed the guns toward him. The subject then picks up the two firearms and places them back in his pockets as he is observed talking in an aggressive manner. I observed two small children in the store at the time of this incident. The subject then walks towards the entry door of the location, turns around and points towards KUMAR. The subject walks back towards KUMAR as he is observed yelling. I then observed the two small children run out of the premise. The subject then exited the location. Shortly after the subject reentered the location saying his final words and then exiting again. I observed the subject enter the front passenger seat of an older model, gold, Chevrolet SUV and exit the parking lot W/B.

KUMAR stated he does not want to press charges. KUMAR stated he fears that the subject may try and harm him in the future.

KUMAR was cooperative in this investigation and requested the assisting of police at the time of this incident.


