1. Description of Grant Project/Program (Include Target Locations and Populations):
The federal Preventive Health and Health Services (PHHS) Block Grant provides funding to address health problems, prevent diseases and promote health in Wisconsin. The City of Milwaukee Health Department is allocated around \$57,000 each year. In 2023-2024, the MHD will use these funds to meet the following objectives:

Accreditation/Reaccreditation

The City of Milwaukee Health Department will fund time for one (1) Public Health Strategist to coordinate activities to prepare the department work toward accreditation, including but not limited to, completion of the Pathways to Recognition PHAB Readiness Assessment, creation of a Quality Improvement Committee, review and update/completion of a Quality Improvement Plan, creation of a Workforce Development Plan, and training MHD staff in the PHAB Standards and Measures, etc.

Collaborate with Partners to Address Community Needs (CHIP)

MHD staff will be engaged in periodic meetings/collaborations to keep community partners engaged over the first year of implementation of our 2023-2028 MKE Elevate CHIP. Activities may include general member meetings that include collecting and sharing data, providing issue briefs, and reporting progress toward key metrics and goals to the community. MHD also keeps stock of MKE Elevate branded materials for outreach at community events to promote the CHIP.

2. Relationship to City-Wide Strategic Goals and Departmental Objectives:
These funds align with the department's strategic plan priority of investing in the public health workforce, the department's workforce development plan, and Community Health Improvement Plan (MKE Elevate).
