You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. Hi Jim,

Evalise was told by Council (at their licensing hearing) that there license renewal would not be discussed until they had a health inspection (we still have open orders from August of 2024). The hearing was October 21st, 2025. Evalise made no attempt to contact us after the meeting. We went out to Pink Agave on Friday, October 31st because a temporary tattoo license was pulled for an event happening at Pink Agave. Jennifer, their inspector went out to do the tattoo inspection and wanted to also complete their health inspection. The Pink Agave employee onsite told Jennifer that she would need to contact Juan about conducting the food inspection. Juan denied a health inspection verbally to Jennifer over the phone. Jennifer was also told by Juan that he would send her dates and times that they would be open by Monday, November 3rd. We received nothing. Jennifer finally received a text message from Juan listing their hours of operation on November 7th after they were told that they would not be granted a provisional license. We do have plans to get out and inspect this establishment with the hours that were provided to us.

Hopefully this brings a little more clarity.

Hi Evalise and Juan,

I am reaching out as I noticed there is a hold on your year long food dealer license that would prevent us from being able to issue the provisional license that you applied for at my desk yesterday. The hold is from the Health Dept. for an inspection, and we would have to have that hold removed by them for the system to allow us to issue your provisional license.

Health does also have a few notes on your application of things that we may need to update when it comes to your renewal application that is on file:

- 1. the business has been closed the past couple of times that Health has tried to come out to complete an inspection. Have you changed the hours you're open at all from what is currently listed on your licenses?
- 2. when they did the inspection for the tattoo event on 10/31, the employee they spoke with mentioned that food wasn't being served. If food is no longer served, we'll need to update your sales percentages and then withdraw your food renewal app.
- 3. they also noted during the tattoo inspection that the floor plan seems to be different from what we have on file here. If that has changed at all, we'll need an updated floor plan drawing just to show the new layout of things.

If any of the things above have changed, I've attached the forms needed to get the changes on file with us. You'll use the amendment form for any/all of the 3 changes, specifically line 15 and then just note what is changing. I've also included a withdrawal form in case we do need to withdraw that food app for you at all.

Subject: Pink Agave Update

Good Morning,

We just wanted to update you all on Pink Agave since they met with Council a few weeks ago.

This is a timeline of where things stand with them and Health since then:

10/15/25: no entry

10/31/25:

A temporary tattoo license was pulled to operate at Pink Agave on 10/31/25.

While onsite completing the tattoo inspection, CEH Coordinator Burany asked the person working for Pink Agave if a Follow-up inspection could be completed as there are very overdue open orders that need to be followed up on. Person onsite said they would not be serving any food on 10/31 and I would have to talk to the Owner Juan. She called Juan while on site asking if a follow-up inspection could be completed, he said he was not comfortable with an inspection being completed because he was not onsite and had not been onsite since the cleaners were onsite and he was not sure of the conditions of the establishment. One of the open orders on the report is for not having paper towel available to facilitate proper handwashing, there was no paper towel onsite while doing the inspection for the tattoo temp license. I asked Juan what his current hours were and he could not provide them. I explained the importance of being able to follow-up on the open orders and be able to gain access for inspections. I asked if it would be feasible that by Monday November 3, 2025 that he would provide me with a list of the dates and times for the month of November that Pink

Agave would be open and operating. He said he would be able to do that. At of 11/5/25 no contact has been made by Juan or anyone associated with Pink Agave and hours have not been provided.

Hi Licensing,

We wanted to send a referral to your team regarding Pink Agave at 2242 S Kinnickinnic Ave.

The hours they have listed in LIRA are 7 days per week, 8am-1am. We have had an extremely difficult time getting into this establishment and it is clear that these are not actually the hours that they are operating.

For context, we did our 30 day inspection at Pink Agave on August 17, 2024. We should have conducted the reinspection between August 31-September 13, 2024. We were not able to get in there again until March 7, 2025. This was due to many, many attempts to conduct the re-inspection and were unable to find them operating. They were not responsive to our attempts to contact them.

We left notices at Pink Agave for intent to inspect on: Oct 30, 2024

Jan 9, 2025

Feb 19, 2025

Mar 7, 2025 (did not leave inspection noticed, drove past going to another late opener after 9pm)

Mar 27, 2025 (did not leave inspection noticed, drove past going to another late opener after 9pm)

April 17, 2025 (did not leave inspection noticed, drove past going to another late opener after 9pm)

April 30, 2025

June 16, 2025

We also sent 2 letters out to Pink Agave (certified mail) for intent to inspect on Feb 20, 2025 and June 26, 2025 with no response and both letters were returned to us.

In addition to the above dates, we have driven by and called multiple times with no reponse.

We have also found events that were listed on Pink Agaves webpage that listed specific events. We went out during the specific events and found the establishment closed.




