As a result of the incident, one of the subjects had brandished and fired a handgun at the employee/cashier which resulted in the death of the employee/cashier. On Friday November 29th, 2024, Squad 7288 (myself) responded to a shooting complaint at "Three Brothers Tobacco" located at 4326 W. Burleigh St. in the City and County of Milwaukee.

The incident took place inside the store where an employee (Clerk) was robbed and then shot, which resulted in a Homicide.

The witness, a store employee, stated two suspects with unknown descriptions entered the store in an attempt to rob it. The victim was behind the register, and the witness was praying in a corner. The witness did not know which suspect shot the victim. The witness did not know what direction the suspects fled in.

While on scene, the employees were cooperative with statements and allowing law enforcement to review video footage. The employees allowed officers to stay in the business the entire time without any incidents or issues during the investigation.

The caller, Qasem, stated there was an older b/f customer refusing to leave and blocking the doorway of the business.

Upon arrival P.O. Rivera and I met with the b/f who was standing in the parking lot and had taken an empty cash register that was sitting on top of a freezer in the store. The b/f stated it was hers and was not speaking incoherently. I next spoke to Qasem who stated all he wanted was the store's property.

I told the b/f I was going to give it back to Qasem to which she stated, 'no'. P.O. Rivera picked up the register and returned it to the store at which time the b/f walked away. The b/f appeared to be having mental health episode and was talking to herself as she left the area peacefully.

Qasem thanked both officers for their assistance and offered us something to drink to which we declined.

On this date and time, the store was open was for business and operating smoothly.

This report is written by Police Officer Curtis LOCKHART, assigned to District Seven, Early Shift.

On Saturday, May 10, 2025, at approximately 6:15 pm, (while in full duty uniform equipped with axon body camera worn and activated), assigned to Desk Sergeant, I spoke with **Essam M QASEM W/M 11/23/2004)** who walked into District Seven to report a **theft** which occurred on May 9th 2025, **at approximately 8:40 pm**, from the address of **4326 W Burleigh St**, (YAZEN Enterprise LLC), which is located in the City and County of Milwaukee.

While at the district, I spoke to Qasem who stated on Friday, May 9th, 2025, at approximately 8:40 pm, at the address of **4326 W Burleigh St**, which is located in the City and County of Milwaukee, **Damontre J BOOTHE (B/M 03/09/1994) intentionally and without consent, took items from store, and left beyond last point of sale without paying for items.**

Interview QASEM

Qasem stated BOOTHE is a known person who always coming into the business causing a disturbance, Qasem stated BOOTHE comes into the store three times a day at no specific times making it hard for the employees to do their job. Qasem stated BOOTHE comes inside and speaks with a black employee that cleans the store. Qasem stated he is not an employee but gives him like **\$5.00 to \$10.00 dollars** just for cleaning the store every day.

Qasem stated while BOOTHE was inside of the store, the female employee who was behind the cash registers left from behind the booth to go use the bathroom. Qasem stated the store was **unattended** for a moment due to the employee using the restroom. Qasem stated that when the black male employee pointed out to Boothe where the cigarettes are. Qasem stated only way BOOTHE could know where the items are was due to the black employee knowing where the items are.

Qasem stated the items that were stolen were a **Box of Newport 100 cigarettes value at \$1800.** Qasem stated the cigarettes were **stored in a brown box in the common area of the store but hidden on the shelves.** Qasem stated he have insurance of the business but could not remember the name.

Qasem stated on May 10th, 2025, at approximately 10:00 am, he noticed the box of cigarettes was

missing off of the shelves and replayed back the cameras and observed BOOTH stealing the cigarettes. Qasem stated he knows BOOTHE by being a regular customers and officers gave BOOTHE information to him when he tried to file for a restraining order due to past incidents.

Canvass

While at the district, Qasem allowed officers to review video of the incident.

I observed BOOTHE speaking with a black male who seems to be employed mopping the floor inside of the business. While speaking with BOOTHE, I also observed a W/F who was working behind the cash register leave the store unattended. The black male employee who was wearing a black and red hooded sweatshirt, black pants, black shoes point to a brown box that was sitting on the shelves inside the business in the front lobby.

I observed BOOTHE walks up to the brown box and intentionally leaves the store, while the w/f employee was using the bathroom according to Qasem.

FOLLOW UP

Qasem stated he would like to press charges against BOOTHE. Qasem was sent a link from evidence.com to upload all evidence of the incident.

At approximately 6:40pm, all evidence was uploaded.

Qasem was issued a PV-17 and a Citizen Community Contacts.
