We have received your recent email communications and your request to meet with our Neighborhood Improvement Development Corporation (NIDC) team to assess a possible plan of action that may rectify identified programmatic violations. This correspondence will document necessary steps that may allow a path forward towards a possible resolution.

NIDC is aware of work that has been performed on the property located at 4201-4203 W Bonny Place without executed City of Milwaukee contracts and Notices to Proceed. You are currently in violation of the terms of your Homebuyer Assistance (HBA) Program and Lead Risk Reduction Initiative (LRRI) Grant.

NIDC management would welcome the opportunity re-evaluate the possibility of bringing your rehabilitation construction project within compliance of the terms established with your PyraMax Bank private financing mortgage note and NIDC loan terms.

NIDC will require the following before such meeting may be scheduled between all parties:

- Signed and executed contracts for work that has been performed
- 2) Itemized Invoices
- Receipts confirming payments of above-mentioned itemized invoices
- Lien Waivers for all work performed
- Satisfactory closed and final inspection passed permits
- Satisfaction of Judgments against Comikia Price or the subject property
- Final documentation confirming resolution of arbitration between Comikia Price, Guardian Home Improvement and Sunlight Financing
- 8) Access to the property to re-evaluate possible eligible work under the mentioned programs

Should remaining work be deemed eligible under the program terms:

- 1) NIDC staff will create a new scope of work determining future eligible work
- NIDC staff will schedule a meeting with all parties to reach a possible resolution 2)
- NIDC staff will create a formal Bid Package 3)
- Comikia Price will secure a contractor bid on the NIDC Bid Package provided
- Selected Contractor Background Check will be performed by NIDC staff
- Proposed changes subject to Administrative Review Committee approval

Note: Recent documents provided to date have not been created, or approved, by NIDC staff.

At this time, NIDC does not know the state of the project, nor if we are able to move forward. Currently, there is no NIDC approved scope of work. The bid you provided by RC is not specific to work required by the City in order to achieve code compliance. In my last email, I had asked that you not continue to bid out your project for this reason. You may frustrate potential contractors if you have them bidding and re-bidding on different scopes of work.


