3. On 03/04/20 at 1:40 am Milwaukee Police conducted a business check at 2242 N. 12<sup>th</sup> St. Officers spoke with the store manager, who stated that one of the employee's was dealing drugs in the store. Officers spoke with the employee and it was revealed that the employee was selling individual cigarettes (loosies) Officers.
4. On 03/22/20 at 4:18am Milwaukee Police conducted a business check at 2242 N. 12<sup>th</sup> St. During the check officers observed a juvenile male at the location, the juvenile was detained for curfew violation. The juvenile was then conveyed back home to his residence.
5. On 03/31/20 at 10:43 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a shot spotter complaint. Officers did not locate any spent casing or bullet strikes. Officers spoke with gas station clerk, who was cooperative, and stated that he did not hear or see anything.
6. On 04/04/20 at 3:29pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a trouble with subject complaint. The caller stated to police that the store clerks would not let him stay and tried pushing him out of the store. The caller was not injured and requested a ride home. Officers conducted a citizen conveyance for the caller.
7. On 04/06/20 at 10:38pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a shot spotter complaint. During the course of the investigation officers determined that 7 gun shots were fired in the vicinity and one bullet struck the building. Officers spoke with the gas station clerk who stated a male subject was assaulted and possibly robbed. The clerk further stated that after the gun shots were fired two vehicles left the area. The store clerk was cooperative and gave officers access to the video. With the video footage officers observed the incident taking place in the parking lot of the location.
8. On 04/08/20 at 9:36 pm Milwaukee Police conducted a business check at 2242 N. 12<sup>th</sup> St. Officers were made aware through a citizen complaint that the gas station had 15 subjects loitering at the location. Officers spoke with clerk and made him aware of the current state stay at home order. According to the order 10 subjects should be in the store while the order is in place. The clerk was cooperative and stated that he was not aware of the order and will only allow 10 patrons in at a time.
9. On 04/16/20 at 8:12 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a shot spotter complaint. According to the shot spotter 8 gun shots were fired in the vicinity. Officers recovered spent casings in the North West corner of the parking lot of the location. Officers were allowed to view video footage and observed two subjects in a verbal argument. The suspect chased the other subject and fired approximately 8 rounds. Officers spoke to the clerk who stated that the suspect is a frequent patron, but does not know him by name. The business did not call the police regarding the incident.
10. On 04/24/20 at 12:57am Milwaukee Police conducted a subject stop at 2242 N. 12<sup>th</sup> St, on a known juvenile. The juvenile was detained for curfew violation. The juvenile stated to officers that he was with an adult, who walked away from the location. The juvenile was then conveyed back home to his residence.
11. On 04 /30/20 at 11:15am Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for an over dose complaint. Officer located the subject outside the front door of the location. The subject

displayed shallow breathing and was unconscious. The subject was administered narcan by Milwaukee Fire Department, for suspected heroin use. The subject was then conveyed to Mt. Sinai for medical treatment.

12. On 05/12/20 at 10:55 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a drug dealing complaint. Officers did not locate any one in the area regarding the complaint. Officers spoke with the gas station clerk, who was cooperative. The clerk stated that the subject was no longer at the location.
13. On 05/13/20 at 10:24pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a drug dealing complaint. The caller stated that three subjects were in the location selling drugs. Officers arrived at the location and observed no one at the location. Officers spoke with the clerk who stated that three subjects left the area.
14. On 05/14/20 at 10:37 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a subject with a gun complaint. Upon arrival officers did not observed any vehicles at the location. Officers also did not locate the described suspect in the vicinity of the location.
15. On 05/26/20 at 11:12 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a subject with a gun complaint. The caller stated that juveniles were in the store and one of the juveniles had a gun. Officers did not locate any one matching the description regarding the complaint. Officers spoke with the gas station clerk who was cooperative. The clerk allowed officers access to the video and officers did not observe any subject with a gun inside the location.
16. On 06/08/20 at 12:28 am Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a drug dealing complaint. The caller stated that three subjects were in the location selling drugs. Officers arrived at the location and observed no one at the location. Officers spoke with the caller who stated the incident is an ongoing problem at the store.
17. On 06/15/20 at 12:52 am Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a trouble with subject complaint. The caller stated that there were 13-14 subjects loitering at the location. Officers arrived at the location and observed no subjects in the vicinity. Both the inside and parking lot of the location were empty.
18. On 06/15/20 at 11:22 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a drug dealing complaint. The caller stated that three subjects were in front of the location selling drugs. Officers arrived at the location and observed no one outside the location. Officers spoke with the caller who stated the subjects left the area.
19. On 06/16/20 at 11:21 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a drug dealing complaint. The caller stated that three subjects were smoking and selling drugs with in the gas station. Officers spoke with the gas station clerk who stated that the subjects left the area. Officers reviewed video in an attempt to identify the subjects. The clerk stated to officers he would like the subjects identified so they could be issued a no trespassing notice from the gas station.
20. On 06/25/20 at 9:33 pm Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a loitering complaint. Officers arrived on scene and did not locate the subject in the vicinity of the gas station. Officers spoke with the owner who stated that the subject panhandles at the location.

The subject loitering is an ongoing problem. The owner stated that the subject only leaves when the police are called.

21. On 06/29/20 at 1:26 am Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a shot spotter complaint. Officers determined that 9 shots were fired in the vicinity. Officers located a victim who sustained a gunshot graze wound to the hip area. The victim was transported to Froedtert Hospital for medical treatment. Another victim was transported by personal auto to St. Joseph's Hospital. Officers reviewed video footage which showed numerous vehicles parked at gas pumps not getting gas. Some subjects in the vehicles were conducting possible mobile to mobile drug deals, and loitering in front of the store, for hours. Investigation revealed that suspects from the shooting were the same subjects loitering at the store. One of the gas station clerks was arrested on scene for resisting/obstructing with the investigation. The clerk's vehicle was observed dropping off one of the victims at the hospital. The clerk stated she didn't know who was in her vehicle. The other clerk did assist with the video footage. It should be noted the business did not call the police regarding the incident.
22. On 07/02/20 at 2:06 am Milwaukee Police were dispatched to 2242 N. 12<sup>th</sup> St for a battery complaint. Officers spoke with the gas station clerk who stated that an intoxicated subject had a physical altercation with other subjects armed with guns outside the location. The clerk stated that all the parties involved left the area. Officers reviewed video from inside the store. It was observed that the intoxicated subject was angry and aggressive with patrons in the store. The other subjects attempted to restrain the intoxicated subject inside the store who during the altercation knocked over food displays in the store. Officers located the intoxicated subject away from the location with no visible injuries. With the assistance of the subject's family he was conveyed home to his residence.
23. On 07/16/20 at 11:30 am Milwaukee Police conducted a meeting at District #3, with the owner of the Clark gas station. (located at 2242 N. 12<sup>th</sup> St) During the meeting the owner was made aware of ongoing issues at the gas station. Issues such as shootings, drug dealings, loitering, and high volume of police calls were discussed during the meeting. The owner was made aware that citizens from the area were not happy with issues and making complaints to the police department and alderman's office. The owner stated that he recently became the owner of the gas station and may have inherited some of the ongoing issues. The owner was cooperative and committed to changing the environment of what is occurring at the business. The owner was issued a nuisance letter and given a complaint form to sign after the meeting.
24. On 09/23/20 at 12:58 pm Milwaukee Police conducted a compliance check at 2242 N. 12<sup>th</sup> St. The check was conducted to verify listed items on an abatement plan were implemented. The following items were observed by the officers:
  1. There were "NO Loitering" signs posted.
  2. There were addition cameras installed.
  3. Bushes and trees blocking the view of business from street was removed.
  4. Area was clear of trash.
  5. A fence was installed on the east walls of the building which attaches to the existing rear fence.
  6. There were 2 large LED lights installed to brighten the business during night time.
  7. District 3 contact guide is posted by the register.
25. On 12/31/20 at 10:52 am Milwaukee Police conducted follow up regarding a fraudulent use of a credit card complaint at 2242 N. 12<sup>th</sup> St. The station clerk was cooperative with the

investigation. Officers were allowed access to the video footage by the gas station clerk. Officers did locate possible suspects but could not determine which card was used during the transaction. The clerk went the credit card transactions but could not find the purchase amount pertaining to the investigation.

This report is written by Police Officer Thomas WRIGHT, assigned to District 3, Late Shift.

On Wednesday, March 4, 2020 at approximately 1:40am, Squad 3341, myself and P.O. Janay WARD, in full duty uniform and operating a marked MPD squad, was conducting a business check at the gas station at 2242 N. 12th St when the clerk in the store, Mirza A. BAIG (m/a, 08/02/63), told us one of his employees, verbally identified as Kenneth D. LOFTON (m/b, 3/15/64) was "dealing dope". We interviewed LOFTON about the investigation, introducing ourselves. LOFTON is known to us from prior interactions at the store. LOFTON stated he was selling "loosies" (individual cigarettes), not drugs. We arranged for BAIG to hold onto LOFTON's cigarettes until the end of his shift. I issued LOFTON a PF-6 (Community Contact Card) with no further police action taken.

During the course of the investigation it was determined that the shots fired actually occurred at 2242 N 12th St and that the building was struck at least once. I spoke to the clerk that was working Mirza BAIG who stated that a male subject was assaulted and possibly robbed and was yelling at someone in the parking lot when several shots were fired. BAIG stated that he knew the subject was battered pretty bad because he face and eyes were swollen. BAIG stated that two vehicle then fled the parking lot.

The following is a short summary of what I observed on the video for a full description the video was inventoried at District 3 (AC 20011834).

- A black male ID'd by the clerk as the victim of the battery, wearing a black hooded sweatshirt with some light colored emblem on it walking in the parking lot with his hand to his ear. Subject continues to walk around and appears to be yelling.
- At approximately 10:36 PM a yellow car pulls into the gas station through the pumping area and toward the front door. Several subjects in the parking lot including the battery victim move quickly behind vehicles and duck down. Yellow vehicle at the same time accelerates and pulls out of the lot with a black sedan following. No windows toward the cameras appear to be open on either vehicle. No muzzle flashes were observed.
- Also at this time a vehicle at the stop light quickly turns right to go north and a vehicle that was behind that one goes through the red light to go west on North Ave.

After speaking with BAIG who stated that no customers were inside the location at the time of the incident, and no one in the area stayed after the incident. I again checked the parking lot and street and I was unable to locate any casings from this incident.

No phone calls were received by Dispatch from this location regarding this incident or the incident that lead to it.

This case is pending.

## Power Shift, Community Prosecution Unit.

On Thursday, July 16, 2020 at approximately 11:30AM, a meeting was conducted at District Three (2333 N 49th St) with the owner of 2242 N 12th St (Clark on 12th & North) in regards to the recent shootings and suspected drug dealing occurring at the location. Attending the meeting was Captain Norman, Sergeant Guadalupe Velasquez, Sergeant Chad Raden, myself, PO Michael Jones, ADA Kelly O'Neill. The owner, Pritpal S. GREWAL (m/w, 04/26/81), and his attorney, Samantha Huddleston (OVB Law & Consulting), were present as well.

During this meeting, the shootings were discussed in detail about the victims claiming to be at the location for drug dealing. Also discussed was the fact that the calls for service are still high and continuing to be an issue. GREWAL was advised that the citizens from the neighborhood were unhappy about the issues and making complaints to the police department and alderman's office. GREWAL was understanding.

GREWAL continued to say that he bought the property recently (May 2020) and that he was handed the issues. GREWAL stated he owns other gas stations around the City of Milwaukee, and that he does not conduct business in this manner. GREWAL stated that the previous owner had bad practices and the people committing the crimes were used to the staff allowing it. GREWAL stated he was committed to changing the environment and what was occurring on the premise.

GREWAL stated he only had one employee (Yaz) that came with the store, and was going to fire him immediately because he believes Yaz is part of the issue. GREWAL also stated that he was remodeling the interior of the building to help staff have a visual of the whole lot. GREWAL stated he also put up a fence that helps restrict access to around the rear of the building. GREWAL was open to other options to help reduce the nuisance issues, such as hiring security, cutting bushes, increasing lights, better video surveillance.

GREWAL was issued a nuisance letter during this meeting. GREWAL was advised that this nuisance letter is to keep the department and his business practices accountable. GREWAL was also given a standing complaint form to sign. GREWAL and his attorney stated they would return a signed complain form back at a later date.

On Thursday, December 31, 2020 at 10:52 a.m., my squad partner, (P.O. Andres CABRAL) and I, were dispatched to 2242 N. 16th St., located in the City and County of Milwaukee, State of Wisconsin, for a complaint of lost property.

Upon our arrival my partner and I, spoke to the caller, Shamyia B. POLLARD, (b/f, 12/21/02), who stated that she was at her child's fathers residence during the night of 12/30/2020, however she was unable to provide an actual location. P.O. CABRAL pulled Google maps up on his phone to assist locating his residence, which she described to possibly be in the 2300 block of N. 20th St., however this did not help locate his address.

While speaking to POLLARD, she stated that she spoke to Deandre A. WILLIAMS, he informed her that he packed up her wallet, and placed it into a bag before he dropped her off at home. POLLARD was unable to provide a birthday for WILLIAMS, but did speak to him over the phone while we were at the location. During there conversation WILLIAMS continued to claim that he did not look for her wallet this a.m., but he was sure he put it with the rest of her property. Please refer to case #203660047 regarding the missing property.

Prior to calling the police, POLLARD stated that she contacted her Bank company around 2:00 a.m. to report her Debit Card lost, when she was advised that there were two attempted charges on her account around 11:51 p.m., that were digitally recorded. These two attempted charges were \$18.42 for the first charge and .86 cents for the second attempt.

P.O. CABRAL and I, changed locations to this gas station, in which the address provided was 2242 N. 12th St., a Clark Gas Station located on the s/e corner of 1200 W. North Ave.

While inside the establishment, I spoke to Gurpreet SINGH, (w/m, 11/23/90), who advised my partner and I, that the store recently changed ownership and they installed many updated cameras. SINGH allowed us to check the camera system, in which P.O. CABRAL continued to take several photographs of the customers who entered the store. Though the store did have adequate security cameras that revealed very clear and high definition video playback, we were unable to check to see what the customers were trying to pay with. SINGH then pulled up the transactions from stores log, however we

POLLARD who was on the phone with her Bank confirmed the unauthorized attempts to remove monies from her account. POLLARD did not give consent for any person to use her Debit card without her permission.
