Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.





Upon arrival I observed the business to be closed but the lights were still luminated inside and then two female employees were approaching the sliding doors to leave for the day.

I met with the caller, Amy J. MARKOWSKI (W/F 9-26-68) who is one of the managers. Amy stated that at approximately 11:35PM, an unknown Hispanic Male subject entered the store and was observed taking various items mostly compromised of razor blades. Amy forced him out of the store at around 11:40PM. Total amount of products taken was \$385.27.

Subject was a H/M, approximately 30-40 yoa, 5'10, slim build, black hair, med complexion, black facial hair. Last seen wearing white/black track style jacket, camo cargo pants, black and white shoes, wearing a black backpack.

Subject was on foot unknown which direction of travel he went.

Amy, the manager, stated that this individual comes into the store often and steals but they do not know his name.

I reviewed video surveillance footage. The footage shows the subject entering the store at approximately 11:35PM on Monday 8/7/23.

While on scene, I observed the licenses posted and they were up to date.

I had advised Amy to notify her staff about this subject and to contact police if he returns.

#### LICENSED PREMISE REPORT

This report is written by PO Anthony PRESTI, assigned to Milwaukee Police District# 6, Early Power Shift. On this date, I am in full duty uniform, equipped with a functioning Axon body worn camera, and operating a marked Milwaukee Police Department squad with working emergency lights and siren.

On Friday, July 26th, 2024, at 2:43 PM, I (Sqd#6233) was dispatched to conduct follow up on two separate Retail Theft related incidents (Cad#P2407251094 & Cad#P2407251115) which both occurred on 7/25/26 at 3701 S Howell Av (Walgreens) which is located in the City & County of Milwaukee.

#### INVESTIGATION:

Upon arrival, listed location can be described as a red brick, one-story business, located on the southwest corner of S Howell Av & W Wilbur Av. There are operational security cameras affixed to the exterior of the business, as well as, operational security cameras located inside the business establishment (No security guard present).

I spoke to the (cooperative) caller/business manager, Amy J. MARKOWSKI (f/w, 9/26/68), who stated, on 7/25/24 at 4:49 PM, an unknown suspect (w/m, approx. 6'1", heavy set, black receding hair, graying beard, mid 40's, gray jacket, black pants, black shoes), intentionally & without consent, carried away merchandise held for resale by Walgreens, passing the last point of purchase, causing the business permanent loss of its properties value (totaling \$101.97).

MARKOWSKI stated, the suspect entered the Walgreens, browsed the store isles, took the listed items off of store shelves, and fled the scene with said items passing the last point of purchase.

#### **FOLLOW UP:**

I provided MARKOWSKI with a PV-17, and a Community Contact Card. I also inventoried an itemized receipt listing the stores stolen merchandise, and a USB Flash Drive containing security camera video of said theft incident (Inv#24021111). I also uploaded a copy of the security camera footage related to this theft incident to Evidence.com.

I reviewed the stores security camera footage which confirms MARKOWSKI's description of the suspect and the suspects activities inside the store.

While on scene, I observed the business licenses posted and they were up to date.

During my investigation for the Retail Theft call for service, I did not observe any violations in the licensed premise.



- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
