
Dear Council Members:


Returned herewith is a document filed by Attorney Jonathan Cermele for attorney's fees for representing Police Officer Todd Lewan. The claim is in the amount of \$2,152.00 including \$18.00 in disbursements for 19.40 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the officer on whose behalf this claim was filed.

As we have advised you under similar circumstances in the past, the Common Council has discretion to reject this claim or to pay it in whole or in part. Wis. Stat. § 895.35, *Bablitch and Bablitch v. Lincoln County*, 82 Wis. 2d 574 (1978).

DA Chisholm reviewed the matter and did not issue charges against the officer. Attached is a copy of DA Chisholm's letter and an itemization of the time and services rendered.

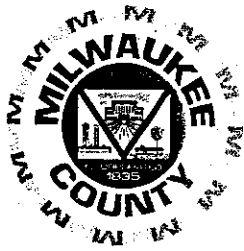

**Re: Complaint of Dontauris Ricks**


Dear Chief Hegerty:

On January 20, 2006, Milwaukee Police were dispatched to Michael's Restaurant to a report of a man with a gun. The man, Dontauris Ricks, fled the scene when police arrived. Although Ricks dropped the gun as he fled, the gun was not found until later and police pursuing him reasonably believed him to be armed.

Ricks successfully eluded police for a brief time, finding a dumpster where he hid under some garbage. His hiding place was found a short time later and police ordered him out of the dumpster. He did not comply, was pulled out and taken to the ground. He struggled and would not show his hands. Milwaukee Police officer Todd Lewan acknowledges that he delivered 3-4 "focused kicks" to Ricks's rib area, which resulted in Ricks giving up the fight and being handcuffed.

I cannot say that these kicks were an excessive use of force against a struggling, uncooperative and presumably armed man who had fled, hidden and then refused to comply with police instructions to show his hands. Having reached this conclusion, I am declining criminal charges.
