Because it will be difficult to provide reasonable advance notice to these individuals subject to a contingency appointment, actual appointments will be predicated on their availability for work and may necessarily be out of eligibility list rank order. The individuals listed above for contingency appointment will retain their position on the 911 Telecommunicator eligible list for appointment consideration to the next occurring appointments if he or she is not appointed on July 11, 2022, unless the list expires or is rescinded.
