Dear Commissioners:

These appointments are contingent upon successful completion of a pre-employment medical examination, drug screening, psychological test, background update, and the number of regularly appointed 911 Telecommunicators reporting for duty on Monday, July 11, 2022.

The recommended contingency appointment of these individuals shall become effective no earlier than Monday, July 11, 2022, and no later than July 18, 2022. Because it will be difficult to provide reasonable advance notice to these individuals subject to a contingency appointment, actual appointments will be predicated on their availability for work and may necessarily be out of eligibility list rank order. The individuals listed above for contingency appointment will retain their position on the 911 Telecommunicator eligible list for appointment consideration to the next occurring appointments if he or she is not appointed on July 11, 2022, unless the list expires or is rescinded.
