PLEASE TAKE NOTICE that the undersigned attorneys appear for and on behalf of Ryan McEldowney, residing at 514 Shepard Terrace, Apartment 4a, Madison, Wisconsin 53705, and do hereby give specific notice that this is a claim against the City of Milwaukee, a Municipal Corporation, pursuant to Wis. Stat. § 893.80(1).

PLEASE TAKE FURTHER NOTICE that on March 11, 2011, at approximately 12:30 p.m., Ryan McEldowney was proceeding to his home in Madison, Wisconsin from his place of employment at 2733 West Euclid Avenue located in Milwaukee, Wisconsin. At that time, there was a large, deep pothole in the right west-bound lane of Oklahoma Avenue. There were no cones, flags, signs, or any other markers to warn about the pothole. Ryan was travelling in the right west-bound lane of Oklahoma Avenue, below the posted speed limit. He was at the top of a hill, near the intersection of Oklahoma Avenue and 60th Street, when he noticed emergency vehicles on the right shoulder. Ryan proceeded to signal and move into the left lane, and as he did this he travelled through the pothole in the right lane. After hitting the pothole, the oil pan in Ryan's vehicle broke immediately, and his engine shut off. Ryan was able to coast to the bottom of the hill and pull over to seek assistance from Moe's Automotive Service.

PLEASE TAKE FURTHER NOTICE that Ryan's vehicle sustained significant damage, including a broken oil pan and timing belt, both of which needed to be replaced. The servicemen at Moe's determined that Ryan sustained \$737.45 worth of damage to his vehicle. Because Ryan paid cash for the repairs, Moe's gave him a \$200 discount, thereby mitigating his damage. total amount Ryan paid to repair the pothole damage was \$537.45. A copy of the repair invoice is attached. The owner of Moe's Automotive Service also informed Ryan that two other people came into his shop that same day because of damage caused by the same pothole.

PLEASE TAKE FUTHER NOTICE that the damage to Ryan McEldowney's vehicle occurred as a result of the negligence of the City of Milwaukee in that Ryan's vehicle was damaged because of the large pothole in Oklahoma Avenue, and that agents and employees of the City of Milwaukee negligently failed to repair Oklahoma Avenue (a highway which the City of Milwaukee is bound to keep in repair). Therefore, Ryan is entitled to recover damages from the City of Milwaukee in the amount of \$537.45, pursuant to Wis. Stat. §893.83(1).
