If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. 3. On 03/27/2020 at 9:44pm officers observed Famous Smoke Shop/Cigar and Liquor Bar, 1213 E. Brady St, open for business. The officers went inside and observed the bar was selling grocery items from inside the shop. The officers spoke with the manager who stated they were only open selling the grocery items, which included Mac N. Cheese, toilet paper and instant rice. The officers advised that it appeared they were staying open for reasons other than selling grocery items and a PA33 report would be filed.
4. On 03/31/2020 officers responded to Famous Cigar Bar, 1213 E. Brady St, regarding the business being open in violation of the Governor's emergency order. The officers contacted the applicant who stated he was aware of the order and is in compliance. He stated he had contact with the Mayor's officer and was told he could operate the business to sell essential items. The applicant was advised the public could enter and conduct business but could not hang out on the property.
5. On 05/15/2020 at 11:00pm officers responded to Famous Cigar Bar, 1213 E. Brady St, for a possible violation of the Emergency order, issued by the Milwaukee Health Department. When the officers entered they observed 2 patrons at the bar drinking alcohol. These subjects left immediately with their purchased alcohol. The officer was not able to verify if the carry out purchase had occurred prior to 9:00pm. The employee stated he thought he could operate with patrons inside the building. There were 3 additional patrons in the business that stated they were not leaving until the employee finished his shift. The patrons were advised they could not be inside the business by order of the health department.

On Friday, March 27th, 2020 at approximately 9:44 PM (while in full duty uniform equipped with an AXON body-worn Camera Activated and in a marked squad) I Sqd-1431 was dispatched to meet Sqd-1410 Sgt. Timothy GAUERKE PS#018001 at Famous Smoke-shop/Cigar an Liquor Bar located at 1213 E Brady St Milwaukee WI 53202 (which is in the City and County of Milwaukee and state of Wisconsin), regarding Famous Smoke-Shop/Cigar an Liquor Bar open for business and selling grocery items from inside there shop.

OBSERVATION

At approximately 9:53 PM I arrived on scene and observed that the Famous Smoke-shop/Cigar and Liquor Bar was open with its open lite ON. I was let into the business by (2) two individuals who were later identified as Jeremy L SOSEMAN (W/M 12-15-96) Employee and on duty Manager of Famous Smoke-Shop/Cigar an Liquor Bar and Arne J BAST (W/M 10-05-89) who is an Employee for Famous Smoke-Shop/Cigar an Liquor Bar.

I observed that there was a make shift shelf on the west side of the shop with grocery items such as Macaroni N Cheese, boxes of Instant Rice, Toilet paper and various 6-Pack cases of Beer. I also observed Frozen Pizzas for sale made to order on the east side of the shop.

INTERVIEW OF Jeremy L SOSEMAN/MANGER

AT approximately 9:55 PM I spoke with the Famous Smoke-shop/Cigar an Liquor Bar Manager and asked him why his bar was still open for customers and he stated that he was only open to sale the grocery items that he had on the shelf. SOSEMAN also stated that the shop was selling these I to help those in need that might need these items. I then explained to SOSEMAN that it appeared as if they were staying open for other reasons other than selling the few grocery items they had on the shelf.

Informed the Manager SOSEMAN that a tavern report regarding this incident would be filed, both individuals on scene were cooperative with the police.

This report is being submitted by Officer Carlos Felix assigned to Squad 1264 at District One, Early Shift.

On Tuesday, March 31, 2020 at 4:59PM, squad 1215 Sgt. Kevin Sadoski and I conducted follow up at Famous Smoke shop Famous Cigar Bar located at 1213 E. Brady Street, regarding an anonymous complaint sent to the aldermen's office. The complaint stated that the business was open to the public after a governor's order that all nonessential businesses close.

At the business Sgt. Sadowski and I made contact with the owner/ agent John Piette (M/W 07/20/68). Sgt. Sadowski advised John of the complaint and the governor's order, which John stated he had knowledge of and is in compliance with. John stated that he has been in contact with the mayor's office and was told that he could operate the business. He pointed out items that he believed to be essential on a newly constructed shelf. I observed a few six packs of beer, boxes of noodles, toilet paper, and a few other boxes of dry goods. I advised him that I knew the person behind the counter was an employee, but questioned the second male that had been standing at the bar since Sgt. Sadowski and I arrived. John stated that the male at the bar was a neighborhood friend. Sgt. Sadowski advised John that the public can enter and conduct business, but no one should just be hanging around in the property. This was the end of the contact with the business.

This report is written by Police Officer Jesse MATTSON, assigned to District #1 on late power shift on squad car 1430 with partner Police Officer Kristopher SARDINA. On Friday May 15th, 2020 PO SARDINA and I were on duty and wearing a full issued Milwaukee Police Department uniform with functioning body worn camera, our names and badges were affixed to our outermost garment.

At approximately 11:00 PM, Sergeant Timothy GAUERKE assigned to squad car 1410 did advise PO SARDINA and I of a possible license premises violation at Famous Cigar located at 1213 East Brady Street. SGT GAUERKE, PO SARDINA and I approached the business on foot. Famous Cigar was open for business with 5 patrons inside the business and 1 employee. After I stepped into the shop I could smell a strong odor of freshly burnt marijuana inside the cigar shop. I could not identify what person inside was responsible for possessing or burning the contraband, but it should be noted the smell was contained within the shop and was not present until I crossed the threshold of the shop's front door.

I observed a male patron and a female patron drinking alcoholic beverages near the cashiers area. Sgt. GAUERKE observed the female drinking a White Claw and the male drinking a Corona beer. The 2 persons drinking inside the business grabbed their purchases and left immediately. The purchases included alcoholic beverages. I did not check if the purchases for alcohol were made prior to 9:00 PM.

I spoke to the employee who identified himself to me by presenting an Identification card issued from the State of Wisconsin. Jeremy L. SOSEMAN (M/W 12/15/1996) of 1018 East Pearson St, Ph#309-582-4620 was the employee present. SOSEMAN stated he was operating the business thinking it was permissible to have customers remain inside the business. I observed several signs posted inside the cigar shop advising customers that purchases were carryout only.

The 3 customers still present inside the store after I interviewed SOSEMAN stated they were not leaving until SOSEMAN was finished with his shift and could leave with them. I advised the patrons and SOSEMAN they were not allowed to remain in the business and wait from him under Mayor Tom BARRETT's continuation of Milwaukee's stay-at-home order.

The hearing before the Licenses Committee will take place virtually on 9/29/2020 at 9:15 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

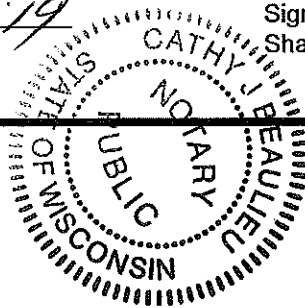

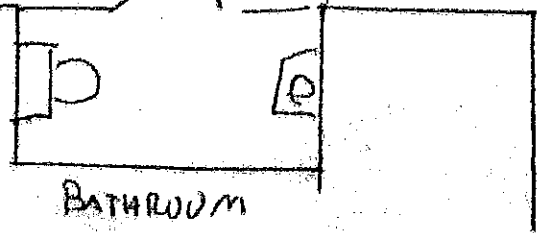

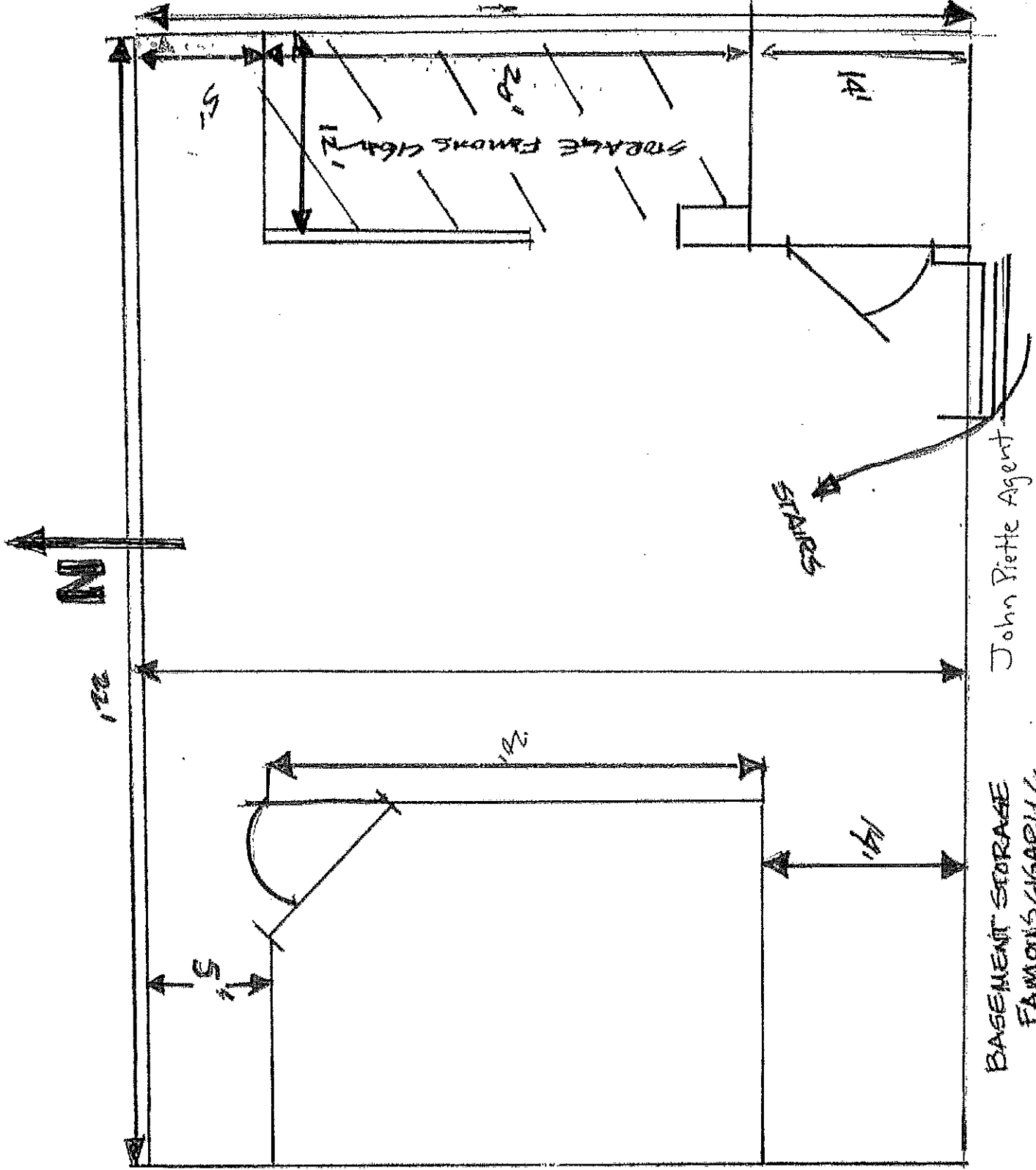
