Report on the Renewal Application of the Class "D" Bartender

License of George M. Maddente.

- 1. George M. Maddente (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2004.
- 2. An application to renew said license was untimely filed with the Office of the City Clerk on January 19, 2005.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 20, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On January 28, 2005, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 8, 2005, commencing at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the police report and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 2, 1998, George M. Maddente was stopped by the Wisconsin State Patrol and arrested in Waukesha County for operating an

- auto while intoxicated. On September 30, 1998 he was found guilty and fined \$702.75 and incurred a 9 month suspension of his driver's license.
- B. On May 19, 2002, George M. Maddente was arrested by the Wisconsin State Patrol in Washington County for operating an auto while intoxicated. On November 18, 2002 he was found guilty and fined \$1,060.00 and sentenced to 90 days in jail and had his driver's license revoked for 18 months.
- C. On April 29, 2003, George M. Maddente was arrested by the Milwaukee Police Department for operating an auto while intoxicated. On September 4, 2003 he was found guilty and fined \$2,4000.00 and sentenced to 124 days in the House of Correction and had his driver's license revoked for three years.
- D. At hearing Mr. Maddente advised that he attends meetings of Alcoholics Anonymous at St. Michael's Hospital.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee recommends that the licensee, George M. Maddente, has not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license held by the licensee without undergoing a sixty (60) day suspension. The Committee finds the police report to be true.
- The Committee recommends that the full Common Council of the City of Milwaukee exercise its discretion to grant renewal of the Class "D" Bartender license held by George M. Maddente with a sixty (60) day suspension based upon the danger that his conduct represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender License be renewed with a sixty (60) day suspension based on the police report.

Said suspension is to be in effect upon action of the Common Council on February 22, 2005 through midnight, April 23, 2005.

- 1. Stephanie A. Shay (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2004.
- 2. An application to renew said license was untimely filed with the Office of the City Clerk on January 11, 2005.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 12, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On January 28, 2005, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 8, 2005, commencing at 9:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the police report and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On February 12, 2002, the applicant was charged in the Circuit Court of Milwaukee County for violating a harassment/restraining order on

February 20, 2002. She was found guilty on August 29, 2002 to an amended charge of disorderly conduct (county ordinance) and fined \$200.00.

B. On June 5, 2003, the applicant was stopped and arrested for operating an auto while intoxicated. She was found to be in possession of a controlled substance, tetrahycrocannabinol (THC). She was charged with operating an auto while intoxicated and possession of a controlled substance tetrahydrocannabinol (THC). On September 22, 2003 she was found guilty and fined in Ozaukee County Circuit Court and fined \$1,268.96 and incurred an 8 month revocation of her driver's license.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee recommends that the licensee, Stephanie A. Shay, has not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license held by the licensee without undergoing a ten (10) day suspension. The Committee finds the police report to be true.
- 3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its discretion to grant renewal of the Class "D" Bartender license held by Stephanie A. Shay with a ten (10) day suspension based upon the danger that her conduct represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender License be renewed with a ten (10) day suspension based on the police report.

Said suspension is to be in effect upon action of the Common Council on February 22, 2005 through midnight, March 4, 2005.

("Metke's On Milwaukee").

- 1. Jason R. Metke (hereinafter the "Licensee") is the holder of a Class "B" Tavern License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, February 9, 2005.
- 2. An application to renew said license was untimely filed with the Office of the City Clerk on January 10, 2005.
- Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 11, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On January 28, 2005, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 8, 2005, commencing at 10:30 a.m. in Room 301B of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the police report and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. On December 15, 1994 Jason Metke was arrested in Winnebago County for issue of worthless checks. On September 13, 1995 he was found guilty in Winnebago County Circuit Court.
- B. On March 4, 1995 Jason Metke was arrested in Winnebago County for possession of a controlled substance (2 counts). On November 27, 1995 he was found guilty as to both counts and fined.
- C. On May 18, 1997 Jason Metke was arrested in Winnebago County for disorderly conduct. On July 9, 1997 he was found guilty and fined.
- D. On July 28, 1997 Jason Metke was arrested in Oshkosh for theft. On August 20, 1997 he was found guilty of petty theft and fined.
- E. On January 15, 1998 Jason Metke was arrested in Fond du Lac County for possession of a controlled substance. On February 2, 1998 he was found guilty and fined.
- F. On March 5, 1999 Jason Metke was stopped and arrested for operating an auto while intoxicated in the City of Waukesha. On June 4, 1999 he was found guilty and incurred a 7 month suspension of his driver's license and fined.
- G. On June 28, 2003 at 11:59 p.m., Jason Metke was observed urinating in public in the alley at 208 East Chicago Street in the City and County of Milwaukee, Wisconsin. He was cited for disorderly conduct and on August 20, 2003 was found guilty and fined \$120.00.
- H. On June 13, 2004 Jason Metke was charged in Milwaukee Count Circuit Court for felony theft, more than \$2,500 and less than \$5,000. That matter is pending.
- I. On July 15, 2004 Jason Metke was charged in Fond du Lac Circuit Court with issuance of a worthless check. On October 22, 2004 he was found guilty and fined \$1,985.00.
- J. On July 22, 2004 Jason Metke was charged in Milwaukee County Circuit Court with felony theft, business setting, misdemeanor unfair trade general orders and misdemeanor theft. That matter is pending.
- K. On October 21, 2004 at 12:49 a.m., officers of the Milwaukee Police Department investigated a complaint of underage patrons at the licensed premises at 332 North Milwaukee Street. The applicant was not on the scene, but there were six underage patrons in the bar. That matter is presently pending for February 1, 2005 at a pretrial.

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee recommends that the licensee, Jason Metke, has not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern license held by the licensee without undergoing a twenty (20) day suspension. The Committee finds items stated above to be true.
- 3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its judgment to grant renewal of the Class "B" Tavern license for the licensed premises at 332 North Milwaukee Street in the City and County of Milwaukee, Wisconsin ("Metke's on Milwaukee") held by Jason Metke with a twenty (20) day suspension based upon the danger that his conduct represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noe, recommends that the Class "B" Tavern License be renewed with a twenty (20) day suspension based on the police report.

Said suspension is to be in effect between midnight, February 22, 2005 and midnight, March 13, 2005.

Report on the Renewal Application of the Class "B" Tavern

Partnership License of Areli Martinez-Benitez and Carpo foro Benitez for the license premises at 3530 West National Avenue in the City and County

of Milwaukee, Wisconsin ("Mis Amigos Bar").

- 1. Areli Martinez-Benitez and Carpoforo Benetez (hereinafter the "Licensees") are the holders of a Class "B" Tavern Partnership License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, March 3, 2005.
- 2. An application to renew said license was timely filed with the Office of the City Clerk on January 26, 2005.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 27, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license. There were also neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, public urination, vandalism, and conduct which is detrimental to the health, safety, and welfare of the neighborhood.
- 4. On January 31, 2005, the City Clerk's Office provided timely notice to the Licensees pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report and of the neighborhood objections. The matter was scheduled for a hearing on the Police Department report on February 8, 2005, commencing at 2:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensees appeared and admitted receipt of the notice of hearing, police report and

neighborhood objections and were represented by Attorney Andres Velez, 1334 South 11th Street, Milwaukee, Wisconsin.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

As to Carpoforo Benitez:

- A. On March 16, 2003 at 2:34 a.m. at 1008 West Lincoln Avenue in the City and County of Milwaukee, Wisconsin, Carpoforo Benitez was issued citations for disorderly conduct, resisting and obstructing a police officer. He was found guilty on the disorderly conduct charge and fined \$150.00 on May 6, 2003. The charge of resisting and obstructing a police officer was dismissed on May 6, 2003 without prejudice.
- B. On October 23, 2004 at 2:03 a.m. officers of the Milwaukee police Department were dispatched to a shooting at South 36th Street and West National Avenue in the City and County of Milwaukee, Wisconsin. Upon arrival, they observed a victim lying on the ground next to the interior west wall of the licensed premises at 3530 West National Avenue in the City and County of Milwaukee, Wisconsin ("Mis Amigos Bar"). The victim had two gunshot wounds, one to the upper abdomen and one to the forearm. The officers spoke to the caller, one Ricardo Huerta, a security officer, for Mis Amigos Bar who stated that he heard two gunshots, did not see the shooter or the direction of flight. This same individual stated he did not see the victim involved in any physical or verbal argument during the evening.

The officers then spoke to the bartender, one Vicky Alcarez, who stated that she was on duty as a bartender at the time and heard two gunshots. She stated to officers that she knew the victim as a regular at the bar and that he had no trouble with any other patrons during that night while at the bar. The officers then spoke to one of the licensees, Areli Martinez, who told officers that she was managing the premises when she heard two gunshots. Ms. Martinez stated that she did not see the shooter or where the shooter fled. She stated to officers that she did not observe any altercations involving the victim during the evening while inside the bar.

It was later learned that the victim, Jose A. Flores, made a dying declaration that he was indeed in a fight with a shooter inside the Mis Amigos Bar on Friday. October 22, 2004 at approximately 11:00 p.m. Jose A. Flores was engaged in a physical fight with that unknown person who was escorted out of the premises by security and the owner/manager, Areli Martinez. Mr. Flores told officers he then saw the same male return to Mis Amigos Bar later that night and shoot him through the glass windows of the bar. The victim told officers that he did not know the

name of the suspect, but that Areli Martinez should because he knows everyone that comes into the tavern. An incident report was filed and two arrests were made for first degree homicide. At the hearing, the licensees maintained that this was a drive-by shooting.

Adjoining neighbors who have lived in the area since as long as 1989 testified to continual problems with loitering and littering outside of the premises and cars speeding up and down streets. They observed these individuals go in and out of the bar while engaging in this conduct.

B. Adjoining neighbors also observed public urination on a very regular basis.

CONCLUSIONS OF LAW

- The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee recommends that the licensees, Areli Martinez-Benitez and Carpoforo Benitez, have not met the criteria of Chapter 125, Wis. Stats. or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern Partnership license held by the licensees for the premises located at 3520 West National Avenue in the City and County of Milwaukee, Wisconsin ("Mis Amigos Bar") without undergoing a twenty (20) day suspension. The Committee finds the police report and neighborhood objections to be true.
- 3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its discretion to grant renewal of the Class "B" Tavern Partnership license for the licensed premises at 3530 West National Avenue in the City and County of Milwaukee, Wisconsin ("Mis Amigos Bar") held by Areli Martinez-Benitez and Carpoforo Benitez with a twenty (20) day suspension based upon the danger that his conduct represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noe, and one (1) excused recommends that the Class "B" Tavern Partnership license be renewed with a twenty (20) day suspension based on the police report and neighborhood objections.

Said suspension is to be in effect between midnight, March 3, 2005 and midnight, March 23, 2005.

- 1. Michelle L. Murphy (hereinafter the "Licensee") is the holder of a Class "B" Tavern License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, March 4, 2005.
- 2. An application to renew said license was filed with the Office of the City Clerk on January 12, 2005.
- 3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 13, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
- 4. On January 28, 2005, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 8, 2005, commencing at 2:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the police report and was not represented by counsel.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. On November 12, 2004 at 12:05 a.m. officers of the Milwaukee Police Department were dispatched to a shooting at the licensed premises at 1500 West Scott Street in the City and County of Milwaukee, Wisconsin ("The Nut Hut"). The victim was shot once in the right side of the chest. The victim stated that she was inside the tavern earlier and having a conversation with persons who were relatives of a person with whom the victim had a fight some time ago. One of the persons became aggressive and profane and was told to leave the bar. When the victim left the bar, fearing that the suspect would be waiting for her, she concealed a beer bottle in her waistband. The suspect confronted the victim outside. The victim swung at him with the bottle and struck him but the bottle did not break. The suspect pulled out a semi-automatic handgun from his waistband and shot her one time in the chest.
