This report is submitted by P.O. Mark KUBICEK, Squad 1226, assigned to District One, Early shift. While on routine bicycle patrol, my partner, P.O. Nathan JURVELIN and I conducted a traffic stop on American United Taxicab #117 because it had pulled into Eastbound traffic on W. Wisconsin Av at N. 4th St completely past the painted lines of the crosswalk to make a right turn from Northbound direction on 4th Street to Wisconsin Av. and confirmed the driver's aforementioned identity. The driver was transporting a family of four, and his attitude was flippant at best. As part of the traffic stop, we inspected the vehicle as a licensed premise of the city and discovered numerous other violations. These violations included not having the daily safety inspection checklist filled out as required at the start of his shift, not having complaint forms within reach of the passenger compartment, and having an open 12-ounce bottle of Miller Lite remaining in the passenger compartment from a previous customer. This bottle was within reach of two children that were approximately 2 and 6 years of age. As these violations were being pointed out to the operator, he begged for us to disregard the multitude of violations and told JURVELIN words to the effect of, "Please, I am like your younger brother." He was repeatedly hesitant to produce required documentation such as his city taxi operation permit, proof of insurance, and state driver license. We released the passengers to flag down another cab because of the unsafe operation of this stopped cab. While we were generating the tickets, after JURVELIN had given the operator repeated commands to wait in the driver seat of the cab for the duration of the stop, the operator quickly exited the vehicle without notice and refused to get back in because he said he wanted to smoke a cigarette instantly. He was secured in handcuffs and placed in the wagon to keep the scene secure. The officers, cab company, and operator upon the calming of his outbursts and erratic behavior, mutually decided to take that cab out of service the remainder of the day for the safety of the community given the operator's immature and volatile emotional state.
