There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/27/2014 at the Days Inn at 1840 N. 6th St, four unknown actors, all armed with firearms, forced their way into the victim's hotel room by pushing past the victim after knocking. The suspects obtained property and fled the scene. The applicant was informed of this incident and was very cooperative with officer.
2. On 01/04/2015 at 12:21am officers responded to the Days Inn at 1840 N. 6th St for a Shooting. The investigation revealed the victim had rented a room for a party. There was alcohol and gambling at the party. During the party, unknown black male subjects, armed with guns arrived and attempted to rob the party patrons. The victim was shot through the door of the room. The officers on scene were unable to access or copy the security footage due to the applicant being out of the country and the employees not having access to the system.

4. On 11/02/17 at 6:15pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Strong Armed Robbery complaint. Investigation revealed that the victim was in the parking lot of the Hotel where she was battered and robbed of money and a cellular phone. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (173060004).
 5. On 11/14/17 at 1:45pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a shots fired complaint. Employees were cooperative during the investigation and assisted officers with video surveillance footage. Officers located 13 spent casings near the vehicle. A police report was filed (173180105).
 6. On 01/02/18 at 8:14pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Strong Armed Robbery complaint that occurred on 12/29/17. Investigation revealed that the victim and suspect were staying in a room at the hotel, when the suspect stuck the victim in the head with a liquor bottle and took \$1,800.00 from the victim. Employees of the Hotel were cooperative with the investigation and assisted officers with video surveillance footage of the incident. A police report was filed (180020035).
 7. On 03/27/18 at 8:53am, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a Fraud Complaint. Investigation revealed that an unknown actor paid a bill at the hotel with counterfeit money. The fraud occurred between the dates of 03/17/18 and 03/19/18 and hotel staff cooperated with the investigation.
 8. On 04/03/18 at 12:35pm, Milwaukee Police Officers were dispatched to 1840 N. 6th Street (Days Inn) for a theft complaint. Investigation revealed that two victims were at the tavern located inside the hotel lobby when their purses were stolen by an unknown actor. Hotel staff assisted officers with the investigation. A police report was filed (180930068).
 9. On 06/13/18, members of the Milwaukee Joint Human Trafficking Task Force, conducted surveillance at the address of 1840 N. 6th Street (Days Inn) because of various tips regarding criminal activity (drug dealing, soliciting, and trafficking). Officers were stationed for an hour and observed the following; A gentleman exit the front lobby and conduct a hand to hand exchange, females being dropped off by vehicles and enter the hotel without belongings or small bags, males and females exiting the hotel together, multiple people loitering in front of the hotel, and staff members walking around with females in skimpy clothing.
 10. On 07/10/18 the agent of 1840 N. 6th Street (Hotel of the Arts LLC) was contacted by Milwaukee Police by telephone and told that he would be cited everyday he operated his hotel without a license. The agent was advised that officers will come to the hotel on 07/18/18 and

enforce the closing of the hotel operations. The agent understood and stated that it gave him time to get his affairs in order.

11. On 07/10/18 at 10:00am, Milwaukee Police Officers, of the License Investigation Unit, conducted a license premise check at 1840 N. 6th Street (Days Inn) because of a complaint received about the hotel operating with an expired license. Officers observed the expired license posted and was able to interview the agent about the issue. The agent stated that he submitted an application, with payment, in April and had a completed inspection by the DNS in May; therefore, he thought his license was valid. The agent was advised to gather any evidence of payment and go to the License Division to straighten things out.

12. On 07/25/18 at 1:48pm, Milwaukee Police performed a license premise check at 1840 N. 6th Street (Day's Inn) because the business was operating without a valid motel/hotel license. When officers told the front door manager about the expired license, he told them that since he paid for the license, he could operate the hotel. When informed that he was wrong and that he would be fined everyday he operated, the door manager said that he has 19 people in the hotel now and 29 checking in tonight, so he will not be closing.
13. On 09/18/18 at 2:20pm, a meeting was held at District Five with the management of the Day's Inn (1840 N. 6th Street). Present at the meeting was the General Manager of the Day's Inn, representatives from Safe and Sound, City Attorney's Office, District Attorney's Office, Sensitive Crimes, District 5 CPU, and the Captain of the Fifth District. The General Manager stated that they have taken steps to combat crime on their property. These steps include; Security patrol in parking lot, background checks on hotel employees, entrance door is locked during the overnight hours, monitor phone numbers given by patrons on "back page", patrons must be 21 years of age and above, smoking patio only accessible from the inside, and an open door policy with the police. The following recommendations were made to the manager; conduct a CPTED survey with the District Five, Human Trafficking training for all employees, and no rooms to be rented after 10pm without a reservation. The manager was advised that they would be issued one citation for each week they are determined to have operated without a license.
14. On 11/30/18 at 8:53pm, Milwaukee Police conducted a license premise check at 1840 N. 6th Street (Day's Inn). The business had a valid license.
15. On 12/07/18 at 2:15am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
16. On 12/13/18 at 11:11pm, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a subject with gun complaint. Upon arrival, officer's interviewed the caller/employee who stated the subject he called about had left and he did not see a gun. The area was checked and but the subject was never located.
17. On 12/17/18 at 9:17am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a subject with weapon complaint. Officer's interviewed the caller/patron of the hotel who stated that her ex-boyfriend sent her a video, holding a gun, and that she was afraid he was

outside. The caller was told that there was nobody outside and she was conveyed, by police, to the Greyhound Station.

18. On 01/10/19 at 9:37am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an Armed Robbery complaint. Investigation revealed that a patron of the hotel was walking to his vehicle, in the parking lot, when his vehicle was taken at gun point. There was surveillance footage of the incident and the management was cooperative with the investigation.
19. On 01/20/19 at 11:13am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for a trouble with subject complaint. Investigation revealed that a patron was in her room and refused to pay for it. The patron eventually agreed to pay for the room and no report was filed.
20. On 02/01/19 at 6:17am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) to meet Milwaukee Fire Department for a combative patient. Officers were able to escort medical personnel, with the patient who was intoxicated and injured his leg, to the hospital and the staff at the hotel was cooperative.
21. On 03/20/19 at 7:01am, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an entry to auto complaint. One of the guests of the hotel had his vehicle entered and a report was filed.
22. On 05/02/19 at 11:55pm, Milwaukee Police were dispatched to 1840 N. 6th Street (Day's Inn) for an Injured/Sick Person. Investigation revealed that security of the hotel observed a female in the lobby, unconscious, with white foam coming from her mouth. With help from other patrons, security laid the female on the ground, called 911, and the patrons started performing CPR. Milwaukee Fire Department arrived and administered 2 doses of Narcan and conveyed the female to the hospital. A check of the females' hotel room revealed a male subject sleeping on the bed, drugs, and narcotic paraphernalia inside. The male was arrested and a report was filed.

23. On 10/16/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6th Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.
24. On 10/17/19, the Milwaukee Police conducted an undercover prostitution operation at 1840 N. 6th Street. The applicant was instrumental in the success of the operation. He provided the police with two hotel rooms free of charge as he has done with past operations.
25. On 11/13/19 at 2:56pm, Milwaukee Police were dispatched to 1840 N. 6th Street for a subject with a gun complaint. Upon arrival officers interviewed the victim/caller who stated that a subject had been beating her for the past two days and was armed with a firearm. Officers went to check for the subject, found him, and a fight ensued while taking him into custody. After taking him into custody the subject was found to be in possession of a firearm and drugs. The agent was cooperative with all aspects of the investigation.
26. On 11/22/19 at 4:44am, Milwaukee Police were dispatched to 1840 N. 6th Street for check the welfare of a citizen complaint. Investigation revealed that two juveniles, who ran away from a group home, were sexually assaulted and being trafficked. The suspects were arrested and the staff of the hotel helped with the investigation.

27. On 03/05/20 at 4:04am, Milwaukee Police were dispatched to 1840 N. 6th Street for a battery complaint. Investigation revealed that a domestic violence battery occurred in one of the rooms at the hotel and the suspect was arrested.

28. On 03/26/20 at 7:35pm, Milwaukee Police were dispatched to 1840 N. 6th Street for an overdose complaint. Investigation revealed that a subject was doing prescription drugs with another subject, inside her hotel room, when she overdosed. The police and firefighters administered NARCAN, she became conscious, and she was sent to the hospital.

29. On 01/28/22 at 1:25am, Milwaukee Police were dispatched to 1840 N. 6th Street for an armed robbery complaint. Investigation revealed that two subjects knocked on the guests door and when he answered, they assaulted him and took U.S. Currency.

30. On 02/15/23 at 5:00p.m., Milwaukee Police were dispatched to an Entry to Auto at 1840 N. 6th St. Investigation revealed a guest parked their vehicle in the parking lot and unknown subject(s) had broken into it, stealing tools valued at \$3000. The employee was cooperative and allowed officers to view video surveillance, however, the incident was not captured. The officer did observe multiple cameras in the parking lot, however, they appeared to be not in working order, which would have been crucial to capturing the incident.

31. On 03/21/23 at 8:06pm, Milwaukee Police were dispatched to 1840 N. 6th St , for an overdose complaint. Officers met MFD at the location in a hotel room, where Narcan had to be delivered to the subject. The subject stated that he did not try to harm himself he just took some anxiety pills to relive pain. The subject was transferred to the hospital where he did admit to taking narcotics to the hospital staff.

32. On 03/21/23 at 9:40p.m., Milwaukee Police were dispatched to a Threat at 1840 N. 6th St. Investigation revealed a guest wanted to cancel reservation and became upset over the refund process. The guest threatened to come back with a gun, the fled the scene. The employees were cooperative with the investigation.

33. On 04/04/23 at 1:55pm, Milwaukee Police were dispatched to 1840 N. 6th St , for a fight complaint. Police arrived and spoke to the victim who was slammed by the suspect against the ATM machine. Officers issued a citation and provided a ride to the victim, away from the location.

34. On 05/01/23 at 8:33am, Milwaukee Police were dispatched to 1840 N. 6th St , for a battery complaint. Investigation determine a battery did not occur. The caller was given information regarding a restraining order, and retrieved property from the room. The caller then left the location.

35. On 05/06/23 at 8:22am, Milwaukee Police were dispatched to 1840 N. 6th St , for a theft complaint. Officers spoke with the caller who stated that an acquaintance that was in her room intentionally took her property without her consent. Officers reviewed the video and observed

the suspect running from the hotel room down the hallway and the victim giving chase. Officers on scene did not observe the business licenses.

36. On 05/10/23 at 3:40a.m., Milwaukee Police were dispatched to a Fight at 1840 N. 6th St. Investigation revealed a guest and another subject were physically fighting outside of the location. Both parties were gone on police arrival. The employee was cooperative with the investigation.
37. On 07/05/23 at 1:24pm Milwaukee Police were dispatched to 1840 N. 6th St, for a child abuse complaint. Officers spoke with the manager who stated that she believes the child in room 217 was abused by her mother. The manager stated that she heard yelling coming from the room and she checked on the room. The child answered and appeared to be cold. Officers respond to the room but the renter was not on scene. The hotel staff was cooperative with the investigation providing officers with the renter's information.

Officers did not locate the subjects involved in the complaint. No additional calls were made to police regarding the incident.

Officers spoke to the employee who stated that the subject made threats to him after he was advised no rooms were available. The threats made to shoot the employee and damage property. The subject left and banged on the doors of the business. The business provided video to officers regarding the incident.
42. On 09/27/23 at 10:44pm, officers were dispatched to 1840 N. 6th St, for a theft. The manager stated that an employee was caught on camera taking money from the business. The employee did not show up for work after the incident. The business was cooperative with police providing video and the information of the suspect.
43. On 09/29/23 at 11:17am, officers were dispatched to 1840 N. 6th St, for a battery/dv. Investigation revealed that the victim was battered by the father of her two children. The business was cooperative with the investigation.
44. On 10/10/23 at 2:10pm, officers were dispatched to 1840 N. 6th St, for shots fired. Officers spoke to the manager who stated that a subject was driving reckless in the parking lot, waving a gun. Officers located the subject who stated that the hotel's transport driver fired a shot in the air. Officers did not locate any fire arm or casings in the vicinity. The business was not able to provide video, due to malfunctioning monitors.

45. On 12/15/23 at 1:34am, officers were dispatched to 1840 N. 6th St, for a subject with gun. The caller stated that her and two female friends observed an employee of the hotel wave a gun in their direction. Officers spoke with the armed security guard who stated that three male subjects were in the lobby and acted like they were armed. The security stated that he was trying to make them leave. Officers spoke with the employee at the front counter who stated that the business allows the employees to armed. Officers reviewed video of the incident.
46. On 01/29/24, at 1:55pm, officers were dispatched to 1840 N. 6th St, for a threat complaint. Officers spoke to the manager who stated that a staff member was threaten by a guest when they attempted to clean a room. The manager wanted the guests removed due to the threat to staff. Officers made contact with the guests of the room, one of the guests physically tried to fight the manager. The aggressive guest was arrested for their actions. The business was cooperative with the investigation.
47. On 03/31/24 at 3:00am, officers were dispatched to 1840 N. 6th St, for a welfare of citizen check. Officers checked the location and no one at the premise needed police services. Officers could not get a hold of the caller for more information regarding the assignment.

48. On 05/25/24, at 12:56 a.m., officers were dispatched to a Battery complaint. An employee stated he had a disagreement with a guest who pushed him. While officers were on scene the employee and guest continued to engaged in a verbal disagreement after officers advised both parties not to continue. The employee could not access the security camera footage for officers.
49. On 09/05/24, at 5:29 a.m., an officer was dispatched to a Stolen Auto complaint. An unknown actor broke a window and caused column damage to a vehicle in the parking lot. The employee could not access the security camera footage.
50. On 10/10/24, at 11:53 a.m., officers were dispatched to a Trouble with Subject complaint. A subject jumped behind the counter and an employee reacted by spraying them with mace. The subject was gone prior to officers' arrival.

53. On 10/31/24, at 10:13 a.m., officers were dispatched to a Weapons complaint. The caller was threatened by a subject sitting in a vehicle blocking the driveway. The weapons complaint was found to be baseless, and the call was determined to be a custody issue.

The victim pulled up in the parking lot and a suspect entered the vehicle. The suspect placed a gun to the back of the victim's neck and demanded their property. The suspect drove away with the victim's vehicle and property. Security camera footage was reviewed and showed the incident take place in the parking lot.

An employee informed the guest they would refund them, but it would take a few days to show up in their account. The guest pointed a gun at the employee, demanded \$200.00 and fled.

We were wearing our Milwaukee Police Department issued uniformed with our name tags affixed on our outermost garments. We were wearing our activated Axon body worn cameras during the time of our investigation. I was the driver of our marked squad vehicle, equipped with red and blue emergency lights and audible sirens.

Upon our arrival, I observed someone working at the front counter, who identified himself as Miguel ESPINO (H/M 6/12/1994). ESPINO stated he called for police because there were customers of the Days Inn who he wanted gone. I was given paperwork, which identified one of the customers as Robin VARGUS (H/M 2/20/2022), who had checked into the Days Inn earlier on Friday 5/24/2024. ESPINO stated there was a female who was in the room with VARGUS, who was later identified as Yesinia Fabiola GARCIA (H/F 9/3/1992). ESPINO stated VARGUS pushed him from the other side of the counter while he was working on the east side of the counter, which is blocked by a tall barrier. ESPINO later stated he was outside of the front counter when he was pushed by VARGUS. ESPINO stated GARCIA and VARGUS had been drinking and was giving him a hard time, arguing with him and he wanted them to leave the Motel. When we asked ESPINO for video footage of the lobby, where he stated the incident occurred, ESPINO stated he did not have access to the cameras and his boss had left the Motel for the day. ESPINO stated he did not know VARGUS and GARCIA prior to this incident.

ESPINO escorted us up to the upper floor, where VARGUS and GARCIA was staying in.

I interviewed GARCIA who stated she was waiting in line in the lobby, standing behind a customer, ESPINO was speaking to. GARCIA stated she and VARGUS had just came back to the Motel after they went to see a comedy show. GARCIA stated she had not been drinking alcohol. GARCIA stated she became loud with ESPINO because he did not offer her a steering wheel lock, after he offered the customer in front of him a wheel lock. GARCIA stated she became upset and asked why she didn't get offered a lock. GARCIA stated she then asked ESPINO to fill out a complaint form and he would not give her one. GARCIA stated she had been drinking at the comedy show before they arrived at Days Inn. GARCIA stated she was arguing with ESPINO and stated she did not have a physical altercation with him.

P.O. LINDSEY interviewed VARGUS. VARGUS stated nothing physical occurred and informed me he had been drinking alcohol before they came back to Days Inn.

I would deem Days Inn as a nuisance due to the employee, ESPINO, arguing back and forth with GARCIA and VARGUS, who were being difficult and argumentative as well, while we were at the location. We told

Dispatch Call Type and Detail:

On Saturday, December 7th, 2024, at approximately 4:58 PM, while wearing full Milwaukee Police Department-issued uniforms with badges and nameplates affixed to our outermost garments, and with activated Milwaukee Police Department Body-Worn Cameras (BWC), Police Officer Ronald SINGLETON and I were dispatched to a call for service robbery, which resulted in an arm robbery carjacking at 803 West Vliet Street in the City and County of Milwaukee Apartment (601).

The victim, verbally identified as Dwight M. WILLIS (B/M, DOB: 02-19-2000, residing at 803 West Vliet Street, located in the City and County of Milwaukee Apartment (601)), reported to the telecommunicator he was picking up subjects for money when subjects brandished a firearm and demanded he exit his vehicle.

Initial observation/ scene description

Upon arrival on the scene at approximately 5:11 PM, I observed an apartment complex located on the south side of the street, with its main entrance facing northbound. I took the initiative to contact the reporting party, WILLIS. An unidentified female provided us entry into the unit.

Police Officer SINGLETON and I observed multiple individuals gathered in the living room area. Meanwhile, Squad 5252, comprised of Police Officers Mark MIELCAREK and Joseph MERRILL, was already on scene and taking a statement from WILLIS in the kitchen area. WILLIS appeared visibly shaken and frustrated as he began recounting the events that had transpired

Interview of Victim (Dwight WILLIS)

During the preliminary investigation, WILLIS initially reported that earlier in the day, he had posted on his Facebook notes, stating "mobile accepting rides." WILLIS mentioned that no one initially responded to the post, prompting him to delete it. However, hours later, he reportedly received a message via Facebook from an old acquaintance, "Lanine," whose profile name was "La-nine errbodyoon otw." The

message inquired if WILLIS was still conducting mobile rides.

WILLIS stated he responded, asking where the individual needed to go. The subject requested a ride to pick up a friend from the Days Inn Suites located at 1840 North 6th Street in Milwaukee, located in the City and County of Milwaukee. According to WILLIS, his girlfriend, verbally identified as Samirah S. HAYES (B/F, DOB: 03-03-2006, residing at 4218 North 16th Street, Milwaukee, phone number 262-395-8197), drove the vehicle, a 2008 blue Dodge Caliber with temporary plates (X2424N), while WILLIS rode as the passenger. WILLIS reported they first picked up "Lanine" at 3900 West Kiley Avenue, located in the City and County of Milwaukee, before heading to the Days Inn Suites. Upon arrival, HAYES parked in front of the hotel, where a black male described as approximately 5'9", stocky build, full beard, brown complexion, wearing a black bomber jacket, black t-shirt, and black skull cap, entered the rear passenger seat.

WILLIS stated HAYES then parked in the hotel lot while the subject began to "roll up." Moments later, WILLIS felt an object pressed against the right side of his neck. Initially thinking the subject was handing him something, WILLIS soon realized it was a weapon when the suspect began demanding his property. The suspect, reportedly pointing and aiming what appeared to be a 1911-style handgun with a hammer, demanded both WILLIS and HAYES exit the vehicle. The suspect then took the following items from WILLIS:

A 20k white gold Rolex watch with a blue and red face, \$280 in cash, two government-issued cell phones, iPhone 12, iPhone 6, containing his driver's license, personal identification card, and debit cards. The suspect fled the scene northbound through the alley, and "Lanine" exited the vehicle and ran in the opposite direction leaving WILLIS and HAYES behind.

On Saturday, December 7th, 2024, at approximately 5:11 PM, Squad 5273 (Officers Kaonnice WHITLEY and Domenico RIZZO) saturated the area for WILLIS' vehicle based on a phone ping, ultimately recovering the vehicle at 1540 West Fond Du Lac Avenue, located in the City and County of Milwaukee at approximately 5:47pm. Police Officer SINGLETON and I never went to the scene of the crime, Police Officers Mark MIELCAREK and J.MERRILL, relocated to the Days Inn Suites to obtain video surveillance of the incident and the suspect.

Interview of Manager (Yazmin RIVERA)

Police Officer J. MERRILL spoke with the manager of Days Inn, Yazmin RIVERA (H/F, 11-04-83). RIVERA who was cooperative and provided him access to the security system. Police Officer J. MERRILL was able to download footage of the incident to his thumb drive. The security footage and still photos of suspect, were later uploaded to evidence.com. Officer J. MERRILL shared a screenshot of a possible suspect captured from the Days Inn Suites' surveillance footage. The image depicted a black male, approximately 5'8" to 5'9", in his 40s, brown complexion, wearing a dark-colored puffer coat with a hood, dark-washed

jeans, a brown and cream hat, a black shirt with yellow lettering, a chain, and white shoes. For more details, refer to Officer J. MERRILL's supplemental report.

Police Officer J. MERRILL account of what he observed is below.

He observed the time on the security system being approximately 62 minutes faster than real time. Time references for the purpose of this report are noted by the time stamp on the security footage. On the Front Door camera, he observed the suspect walking North through the parking lot, at approximately 17:24 PM. The suspect stops outside the front door of the Days Inn, standing on the sidewalk. He does not enter the hotel. The suspect was observed as, B/M, 5'10 - 6' 01", 165 - 190 lbs., wearing a brown knit hat with light brown design, mustache, black puffy coat with hood and white logo on left arm, black shirt with the letters M A I S O visible, black pants and gray sneakers with white soles and laces. Also, on the Front Door camera, he observed the victim pick up the suspect at approximately 17:38 PM, who enters the rear passenger seat. The victim then parks the vehicle in the hotel parking lot. On the Parking Lot camera, he observed four passengers exit the victim's vehicle (Dodge Caliber), at approximately 17:43 PM. The suspect was observed entering the driver seat and driving Northbound through the alley rear of the hotel. Due to the angle of the security cameras and vehicles parked around the victim's vehicle, he was unable to observe if the suspect was holding a firearm.
