There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

Dear Ald. Perez,

I want to bring to your attention a "common" practice at Taqueria el Toro. I am not a frequent client but <u>each time</u> that I have been there, I get <u>an extra \$2-3 charge</u> on the check which is taken off when I point it out. This last Saturday I got an extra \$2 charge on the check again. This time I was told that it was the tip, that they charge it in advance and that the menu says so. I asked the lady to give me the cash register receipt (attached) and to write the word "TIP" on the item. I usually tip 20% but they decided that \$2 were good enough. I am not bothered by the dollar amount, it is the dishonest practice that I believe is common now because this time was a different lady who handled it. I wonder how many patrons get extra charges, for how much and how many really notice it.

This food truck is still an issue! There was no issue, until 7/12/23, when a parking checker moved it here. Why, after it was parked for over a year and a half a block away? I have been filing complaints all week. The parking checker told him he had to move every couple hours, so this week, that is what he has been doing. Moving forward for 3 or 4 hours and then backing up back here. Today, he has been across here since 1:00, now it is 6:11p.m. I put in the complaint #C2323588 at 3:10p.m. Watched the parking checker come by at 5:21p.m., pull up past the food truck, never come out of the truck, sit for about 5 minutes, and then leave. Then they send me an email that the issue was resolved. How can that be if now, it is an hour later (6:23 p.m.) and the fruck is still here? It doesn't pay to complain again, because the checker won't get here before 7:00, when he no longer has to move.

Why can't Marina do anything about this? And if she can't, tell me who can? Why does he have the right to bother me, but I have no rights to get him moved? The city moved it here, and I heard the city parking checker tell him how to beat the system, but now again, he is not complying with the posted parking signs.

Please tell me who to contact to get this food truck moved away from across from my house. No one wants to or should have to listen to this generator from 10 a.m. to 10 p.m. 6-7 days a week!!!!!



I had called yesterday, July 13th, 2023, regarding a Taqueria El Toro food truck that until Wednesday, July 12th, 2023 @ 1:52 p.m., was parked in the 3100 block of S. Chase Ave. for over a year, suddenly was moved by a parking checker over here across from my house @ . Don't know why the parking checker moved them here?

On Wednesday, after going over to the food truck and asking them to please move up the street and getting the "no habla ingles", I called the non emergency police number to get an officer here to speak to them @ 3:16 p.m. At 5:19 p.m., the officer called me to see if it was still there. I said yes, and at 6:38 p.m., in the rain, we watched the police drive by our house slowly and at 6:41 it came past the truck slowly and went. There even was a vehicle parked in the no parking area at the time they passed. At 6:42, Officer Gutowski called me and said "they drove by and it wasn't loud enough to have them move". They never got out of the car to speak to the food truck. I asked him to come to my house to talk to me and listen to the noise and he said no.

I called your office at 11:36 a.m. yesterday. I was told they were not supposed to be there more than 2 hours and they would have enforcement come and give them the letter stating the rules.

The food truck is parked in a 2 hour parking zone. On Wed. it was here from 1:52 p.m. until 10:08 p.m. when it finally left. Yesterday, 7/13, it was here from 10:40 a.m. until 10:08 p.m. Today he pulled up at 10:50 a.m. Cars pull up and park behind him in a signed no parking area and in the crosswalk.

This seems to be the new permanent home for this food truck. I do not want to listen to this generator all day and night. I do not want the bright lights shining in my living room when it gets dark, which gets earlier everyday. What do I have to do to get it moved away from across from my house?

There even was a vehicle parked in the no parking area at the time they passed. At 6:42, Officer Gutowski called me and said "they drove by and it wasn't loud enough to have them move". They never got out of the car to speak to the food truck. I asked him to come to my house to talk to me and listen to the noise and he said no.

I called your office at 11:36 a.m. yesterday. I was told they were not supposed to be there more than 2 hours and they would have enforcement come and give them the letter stating the rules.

The food truck is parked in a 2 hour parking zone. On Wed. it was here from 1:52 p.m. until 10:08 p.m. when it finally left. Yesterday, 7/13, it was here from 10:40 a.m. until 10:08 p.m. Today he pulled up at 10:50 a.m. Cars pull up and park behind him in a signed no parking area and in the crosswalk.

This seems to be the new permanent home for this food truck. I do not want to listen to this generator all day and night. I do not want the bright lights shining in my living room when it gets dark, which gets earlier everyday. What do I have to do to get it moved away from across from my house?
