Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/25/2004 at 2:05 AM officers responded to the licensed premises at 3250 N 2nd St regarding a shooting. Investigation revealed that a fatal shooting occurred outside the tavern at about 2:00 AM and that the victim had been a patron of the tavern. No further information. Incident Report Filed.
2. On Wednesday 08/17/2004 at 2:50 AM officers observed patrons exiting the licensed premises at 3250 N 2nd St, the Glass Slipper. Officers then made a lawful inspection of the licensed premises at found 22 patrons still in the tavern. The bartender on duty stated that the patrons were from a birthday party. The applicant was not on the scene and was cited.

3. On 02/06/10, Milwaukee police were dispatched to 3250 N 2nd Street for a Drug Dealing complaint. Officers spoke with the bartender Nicole Spillers who stated earlier in the evening a female entered the tavern and wanted her boyfriend to leave the tavern. The female was asked to leave and when she did, broke the glass on the front door. Spillers believed that the female was the one who made the call regarding the drug dealing complaint. A check of the tavern found no evidence of drug dealing. No tavern violations were observed.
4. On 03/12/10 at 12:18 am, Milwaukee police were dispatched to 2nd and Concordia for a Shots Fired complaint. Investigation found two subjects were arguing in front of the tavern when one actor pulled out a gun and started firing shots at the other subject. Officers were able to view video surveillance that was provided by the tavern owner Jimmy Jordan, which showed the incident. The tape however was in black and white and was blurry. The time on the video also didn't correspond with the actual time of the incident taking place. Casings were found in front of the tavern and were placed on police inventory. Area hospitals were checked for a shooting victim but none were found. Officers also spoke with the bartender Nicole Spillers who stated she heard shots but did not know was shooting outside. Officers also spoke with the doorman John Wright who stated he heard about 16 shots being fired and when he looked outside, did not observe who was shooting the gun.

5. On 05/26/13, Milwaukee police were dispatched to a Shooting at 3250 N 2nd Street. Investigation revealed that two victims of the shooting had been previously inside the bar. One victim was the DJ who had been performing at the bar, with the second victim being a friend of the DJ, who was a patron. Both subjects had exited the bar to have a cigarette and while outside, were approached by 2-3 males who were armed with guns. The suspects ordered the victims, as well as several other patrons who were outside smoking, to the ground and began going through their pockets. Prior to leaving and possibly before the searching of the pockets, the suspects shot each of the victims once to their right leg. The suspects fled after obtaining money and property from the victims. It is possible that the suspects may have been in the bar previous to the robbery/shooting. The bar's surveillance video depicts not only the lead up to the incident, but what the owner said was the possible two suspects.

6. On 02/15/2015 Milwaukee police conducted a licensed premise check at 3250 North 2nd Street. Officers discovered patrons inside the business who had not yet attained the legal drinking age of 21 as well as a subject who was armed with a handgun. Milwaukee police incident report #150460010 filed.

7. On 01/04/2020 officers were dispatched to a fight at Glass Slipper bar, 3250 N. 2nd St. The investigation revealed a female was at the bar with friends. A male subject observed the female taking with other men. The male became upset and struck the female several times. The male was located and arrested. The applicant called the police and reported the incident.
 8. On 01/01/2021 at 1:33am officers conducted a license premise check at Glass Slipper, 3250 N. 2nd St. The officers spoke with the applicant, who stated the night was slow. The officer asked to see the licenses and the applicant showed them to the officers. The licenses showed an expiration date of 12/20/2020. The officers checked LIRA and found the business did not

have a valid license to operate. The applicant provided an email dated 12/04/2020 that showed he had applied for a renewal.

During the investigation, an incident occurred inside the bar between two subjects. The subjects were identified as Lemetrius Q. SMITH (B/M (9/23/88) and Karon F. STEWART (B/F 9/17/84). The two subjects got into an altercation inside the bar and SMITH was arrested outside of the bar regarding the incident.

STEWART was at the Glass Slipper with friends and enjoying her night when SMITH came and witnessed STEWART talking to other men. Watching STEWART "flirt" with other men upset SMITH, who then went inside the bar and began to physically attack STEWART striking her multiple times. After striking STEWART, SMITH left the Glass Slipper and went outside, where we made contact with SMITH.

An employee at the Glass Slipper, identified as Jimmy D. JORDAN (B/M 12/24/46) reported the incident to the police.

Robert PARKS and myself) along with Squad 5468 (P.O. David LETTEER and P.O. Russell MACRAE) conducted a Tavern Check at 3250 N. 2nd St. in the city of Milwaukee, which is the "Glass Slipper".

On scene I spoke with the owner and agent Jimmy D JORDAN (b/m 12-24-46). JORDAN stated that the night had been slow. While on scene I observed 5 patrons and two other employees (1 bartender and 1 doorman). I asked JORDAN to view his licenses and JORDAN showed them to me.

We checked the website and it showed there was no current license to operate. I informed JORDAN of this and he informed us he would get it taken care of.

The bartender, identified as Nequnda M JONES (b/f 04-20-82), had her bartender license visibly posted on the wall. JONES stated she began her shift at 10:00 p.m. and would work until bar close which she thought would be about 2:30 a.m.

The hearing before the Licenses Committee will take place virtually on 2/17/2021 at 9:50 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
