Hi Tim,

I'm attaching the information requested. My first time annotated photos but think it works. Also added a hand drawn layout which may be helpful or if it adds confusion just toss it.

The exact position of cameras and small solar panels (dimensions are listing on page two of application will be determined once held in place to determine field of vision. But the red Xs should be within inches of final location.

**Dimensions: cameras - 4.98 x 2.71 x 2.95 inches. Solar panels - 7.50 x 6.00 x 1.25 inches.**

Only one camera w/panel is on the front of the building, to protect entrance and front living room windows. The others are on back of building and far rear side of north side of building to protect area behind fence which would shield intruders.

Please let me know if this is all you need. The install was scheduled for tomorrow but I've placed on hold pending approval.
